S. 50, to strengthen Federal consumer product safety programs and activities with respect to commercially marketed seafood by directing the Secretary of Commerce to coordinate with the Federal Trade Commission and other appropriate Federal agencies to strengthen and coordinate those programs and activities. S. 52, to establish uniform administrative and enforcement procedures and penalties for the enforcement of the High Seas Driftnet Fishing Moratorium Protection Act and similar statutes. (S. Rept. No. 112–132)

Report to accompany S. 363, to authorize the Secretary of Commerce to convey property of the National Oceanic and Atmospheric Administration to the City of Pascagoula, Mississippi. (S. Rept. No. 112–133)

S. 485, to expand the boundaries of the Thunder Bay National Marine Sanctuary and Underwater Preserve, with an amendment in the nature of a substitute. (S. Rept. No. 112–134)

S. 1665, to authorize appropriations for the Coast Guard for fiscal years 2012 and 2013, with an amendment in the nature of a substitute. (S. Rept. No. 112–135)

S. 97, to amend the Federal Water Pollution Control Act to establish a grant program to support the restoration of San Francisco Bay, with an amendment. (S. Rept. No. 112–136)

S. 893, to authorize the Secretary of the Interior to provide financial assistance to the State of Louisiana for a pilot program to develop measures to eradicate or control feral swine and to assess and restore wetlands damaged by feral swine. (S. Rept. No. 112–137)

S. 1296, to revise the boundaries of John H. Chafee Coastal Barrier Resources System Sachuest Point Unit RI–04P, Easton Beach Unit RI–05P,

Almy Pond Unit RI–06, and Hazards Beach Unit RI–07 in the State of Rhode Island. (S. Rept. No. 112–138)

S. 1740, to amend the Chesapeake Bay Initiative Act of 1998 to provide for the reauthorization of the Chesapeake Bay Gateways and Watertrails Network. (S. Rept. No. 112–139)

S. 1789, to improve, sustain, and transform the United States Postal Service, with an amendment in the nature of a substitute.

S. 2038, to prohibit Members of Congress and employees of Congress from using nonpublic information derived from their official positions for personal benefit. **Page S131**

#### Measures Passed:

**Honoring Special Agent Jared Francom:** Senate agreed to S. Res. 355, honoring the memory of Special Agent Jared Francom of the Ogden, Utah Police Department. **Pages S114–15**

**Airport and Airway Extension Act:** Senate passed H.R. 3800, to amend the Internal Revenue Code of 1986 to extend the funding and expenditure authority of the Airport and Airway Trust Fund, to amend title 49, United States Code, to extend authorizations for the airport improvement program. **Page S136**

**Ultralight Aircraft Smuggling Prevention Act:** Senate passed H.R. 3801, to amend the Tariff Act of 1930 to clarify the definition of aircraft and the offenses penalized under the aviation smuggling provisions under that Act. **Pages S95, S136**

**State or Local Government Levee Construction:** Senate passed S. 2039, to allow a State or local government to construct levees on certain properties otherwise designated as open space lands, after agreeing to the following amendment proposed thereto: **Pages S136–37**

#### Measures Considered:

**Debt Ceiling Increase:** Senate began consideration of motion to proceed to consideration of H.J.

Res. 98, relating to the disapproval of the President's exercise of authority to increase the debt limit, as submitted under section 3101A of title 31, United States Code, on January 12, 2012.

**Stop Trading on Congressional Knowledge (STOCK) Act—Cloture:** Senate began consideration of the motion to proceed to consideration of S. 2038, to prohibit Members of Congress and employees of Congress from using nonpublic information derived from their official positions for personal benefit.

Lee, and John J. Tharp, Jr., both to be a United States District Judge for the Northern District of Illinois, who were both introduced by Senator Durbin, and George Levi Russell, III, to be United States District Judge for the District of Maryland, who was introduced by Senators Mikulski and Cardin, after the nominees testified and answered questions in their own behalf.
