Lieutenant Colonel applicants must submit copies of ALL OPRs, Training Reports and Mandatory Letters of Evaluation - OPRs are required to ensure the member's record, if selected, would be competitive for promotion to Colonel. Colonel applicants only need to submit their last five OPRs. Lieutenant Colonel applicants must have a date of rank prior to 31 Dec 2009 to be eligible for this vacancy and a Mandatory Separation Date (MSD) which allows for 3 years TIG as Col.** Duties and Responsibilities: Position requires military rated officer experience in operational and support missions of the ANG to enable incumbent to provide qualified military judgment in current and future ANG missions. Incumbent will be responsible to be the principle advisor to the NGB/CF & ANGRC Commander with oversight of all ANG Programs. Reviews, evaluates, and drafts strategic planning documents including strategic plans, analytical assessments, roadmaps, and white papers. Responsible for taking action and advocating ANG interests to HAF and DoD on all matters related to strategic guidance and analytical assessments. Leads ANG resource integration into MAJCOM's Core Function Master Plans. Responsible for the vetting and correspondence relating to the Air National Guard's strategic planning guidance, and coordinates the development of proposal appropriate for consideration by the Director, Air National Guard. Oversees LNO and contractor team support to Director of the Air National Guard's Strategic Planning System body of 54 A-TAG's national/regional meetings. Directs across the command the formulation of working groups for strategy integration, force planning and basing analysis and recommendations. Ensures requisite research and preparation of correspondence for the Director of the Air National Guard's signature to the Chief of Staff, USAF, other staff agencies, gaining commands and subordinate Air National Guard units and commanders. Represents the ANG at HQ USAF Corporate Structure meetings as necessary. Should have a working knowledge of the functions and organization structure of the NGB, USAF, MAJCOMs, NAFs, TAGs, and ANG units.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.
