Headquarters ANG Title 10 3 years Statutory Tour at **NGB/JA (Pentagon, Washington, DC)**. Must be Air Force Specialty Code (AFSC) **51J3/4**. Duties and Responsibilities: Provide legal advice to the Chief Counsel, Senior Executive civilians, General Officers and Senior field grade officers in the National Guard Bureau and the 54 states and territories; will interact with senior officers and civilians in other DoD components, to include ANG representatives filling ANG positions on the Air Staff and NGB Joint Staff, and with senior officials in state and federal agencies outside DoD. General legal advice will include assistance to ANG directorates at the ANGRC, and the ANG Directors office, DoD, USAF and other NGB policy; assistance regarding operations, operations tempo, ANG deployments, and relationships between the ANG and other military components and DoD and other federal agencies, to include FEMA; and other areas of operations and deployment law as required. Develop policy regarding the roles and responsibilities of the National Guard consistent with current federal law. Responsible for reviewing a wide range of contracting actions from requirements definition through contract close out. Provides agency-level advice on all contract and cooperative agreement matters. Provides legal support for contract litigation, including procurement protests and claims that are litigated at the Court of Federal Claims, GAO or the Armed Services Board of Contract Appeals. Assist with the proper coordination of procurement fraud issues in close coordination with the US Army Legal Services Agency. Provides fiscal law advice on a wide range of issues affecting National Guard appropriations for NGB officials as well as the 54 United States Property and Fiscal Officers, including advice on potential and actual violations of the Antideficiency Act.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application.

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.
