# Course Development and Capacity Building For the DoDEA Virtual School

## 1.0 INTRODUCTION

- 1.1. The Department of Defense Education Activity (DoDEA) serves the educational needs of the dependents of military and civilian employees by providing PK-12 instruction to approximately 85,000 students in seven states, twelve foreign countries, Guam, and Puerto Rico. The number of students varies based on the deployment of military troops worldwide. DoDEA's curriculum, resources, and student achievement scores on standardized assessments compare favorably to high-performing US public schools.
- 1.2 DoDEA is divided into three administrative areas. DDESS (Domestic Dependent Elementary and Secondary Schools) covers seven states, Puerto Rico, and Cuba. DoDDS (Department of Defense Dependent Schools) is divided into DoDDS-Europe and DoDDS-Pacific. The former consists of England, Germany, Italy, Belgium, Netherlands, Spain, Portugal, Turkey, and Bahrain. The latter consists of Korea, Japan, and Guam.
- 1.3 Due to force structure changes, a large number of school-age children of military members will be relocating between DoDEA over the next few years. The majority of these children will attend public schools outside of military installations ("military connected public schools"). Section 574(d) of Public Law 109-364, the John Warner National Defense Authorization Act for FY 2007, directed the Secretary of Defense to ease the transition of these children, especially during deployments. Due to its long history of successfully educating military students, the Department of Defense selected DoDEA to champion this effort, in part, by establishing partnering relationships with local education agencies with military connected public schools.

#### 2.0 BACKGROUND

- 2.1 DoDEA has used commercial, off-the-shelf products as well as courses developed in-house to meet its virtual learning needs. In order to expand the virtual learning opportunities offered to DODEA students and to have the ability to provide outside educational partners (including local education agencies) with access to high-quality virtual courses and course material, DoDEA intends to establish a virtual high school consisting of courses developed specifically to meet DoDEA's requirements.
- 2.2 For this initiative DoDEA is seeking customized courses developed to its specific requirements, not commercial, off-the-shelf courses.

## 3.0 SCOPE AND DEFINITIONS

- 3.1 Purpose: Through the development of courses for DoDEA's virtual high school, DoDEA will expand access to quality curriculum, instruction and assessment by offering virtual courses customized to meet DoDEA standards. It is anticipated that these virtual classes will be comparable or superior in quality to those delivered in DoDEA grade 9-12 classrooms worldwide. To build a virtual high school that is customized to meet DoDEA's requirements, DoDEA requires course development and professional development.
- 3.2 <u>Course Development</u>: In the base period, DoDEA requires the development of 33 high school level (grades 9-12) courses (21 full-year and 12 semester courses) and related online teacher resources

tailored to DoDEA's standards. In Option Years 1-2, DoDEA requires the development of five additional courses (three full year courses and two semester courses) each year.

- 3.3 <u>Professional Development</u>: DoDEA requires the Contractor to create and conduct professional development for DoDEA personnel in the following areas:
  - Content development: ePedagogy and related content issues.
  - Instructional design: application of appropriate learning theory and technology to facilitate student-centered instructions.

## 3.4 Definitions

- Subject-Matter Expert (SME): A content expert in a given curricular area, such as US history, Algebra I, or chemistry.
- Curricular Area: The content areas of specialization for the courses to be developed (i.e. mathematics).
- Lead SME: A key contracting team member charged with overseeing the Contractor's efforts to provide content for the courses and providing professional development to DoDEA's content development team. This person will liaise with DoDEA's program manager throughout the life of the contract.
- Lead Instructional Designer: The key individual overseeing the Contractor's efforts in providing instructional design for the courses and providing professional development to DoDEA's instructional designers. This person will liaise with DoDEA's Contracting Officer's Representative (COR) throughout the life of the contract.
- Program Management Team: includes at least two people who have the responsibilities for project manager, lead SME and lead instructional designer. The team shall participate in the Post-Award Conference/ Implementation Plan Meeting and the Monthly Leadership Meetings and shall be the points of contact for the content and instructional design matters, including professional development.
- DoDEA's Content Development Team: The team consists of DoDEA content experts and classroom teachers, many of whom are expected to participate in the Summer Conference.
- Spiral Evaluation: The initiative's Course development process, in which Modules are developed by the Contractor, reviewed and commented on by DoDEA, changed by the Contractor, reviewed by DoDEA, etc. This process shall continue until a Course is fully developed and delivered.
- Lesson(s): Units of instruction broken down into stand-alone components, and comprised of a unified collection of Lesson Materials.
- Module(s): The organizational framework of the courses based upon subject-specific concepts or theories. Each Module must contain five Lessons.
- Course(s): A complete series of Modules (eight Modules for a semester course and 16
  Modules for a full-year Course) broken down into Lessons and accompanying Teacher
  Resources as defined by the curriculum, course description and course requirements.

Lesson Materials: Consist of all the parts of a created Lesson, including, but not limited to the text, videos, and interactive elements utilized in the Lesson to teach curricular content. Lesson Materials include but are not limited to all interactive add-ins such as HTML, XML, Flash, and MOV.

- Teacher Resources: Accompanying guidance and materials that will support the instructor in implementing each Course.
- Learning Outcome: Specific measurable objectives defined in terms of skills, knowledge, attitudes and application.

- 4.2 The Contractor shall develop online Courses that address the following requirements.
  - 4.2.1 Content: Courses shall:
    - 4.2.1.1 Be equivalent to one semester (18 weeks) or two semesters (36 weeks) as defined by DoDEA's course descriptions.

- 4.2.1.2 Meet the DoDEA provided course descriptions, standards, and related criteria that are aligned with DoDEA content standards, instruction and assessment in appropriate content and technology areas.
- 4.2.1.3 Follow the DoDEA-provided scope and sequence for each course.
- 4.2.1.4 Include a Course syllabus and a listing of requirements.
- 4.2.1.5 Be consistent with DoDEA provided expectations regarding academic integrity and etiquette.
- 4.2.1.6 Be free of racial, color, national origin, age, disabling conditions, sexual, religious, and ethnic bias and shall present a balanced coverage of a variety of cultures accurately and authentically, avoiding stereotypes. Materials should also promote gender equity.
- 4.2.1.7 Include a variety of audio, video and graphical media elements in the Lesson Material that are engaging and relate directly to topics covered. The media types accommodate different learning styles and stimulate active participation.
- 4.2.1.8 Contain 40 (semester) or 80 (full year) stand-alone (learning object-based) Lessons. Each Lesson shall:
  - 4.2.1.8.1 Contain no references or dependency on previous or future Lessons so that teachers can adapt/provide differentiated instruction to address student learning needs.
  - 4.2.1.8.2 Include Learning Outcomes that are (1) clearly stated, observable, measurable, achievable and (2) aligned with DoDEA learning standards and objectives.
  - 4.2. 1.8.3 Include content-related topics, readings and activities that provide students with authentic background information and applications to course content.
  - 4.2. 1.8.4 Emphasize 21st century themes such as learning and innovation skills; information, media, and technology skills; life and career skills.
  - 4.2. 1.8.5 Employ a flexible multi-media approach that includes virtual resources delivered via the Internet and Web 2.0 tools (e.g., audio-graphic collaboration, synchronous chat and asynchronous components) designed to promote student engagements and stimulate interaction between the instructor and students and among the students.
  - 4.2. 1.8.6 Include a glossary of key curricular terms.
- 4.2.1.9 Contain Teacher Resources that: provide materials that support the instructor in implementing each course, which, at a minimum, includes materials covering the following topics:
  - ePedagogy and management
  - Creation and sustainment of an online community
  - Implementation of a constructivist, student-centered learning approach to promote differentiated instruction and accommodate multiple learning styles.
  - Assessments. This material shall cover the following assessment related topics: the adequate and appropriate methodology to assess students' mastery of content; the use of formative and summative assessments to verify each student's

readiness for the next Lesson or Module; the use of formative and summative assessments to support student and teacher needs for feedback; and, the use of formative and summative assessments to provide grading rubrics and models for teachers.

4.2.1.10 Be deemed "works", as will all Lesson Materials and Teacher Resources, as that term is defined in Defense Federal Acquisition Regulation Supplement (DFARS) 252.227-7020. Further, the Contractor shall be bound by all the obligations and shall provide the Government with the all of the rights and licenses set forth in Defense Federal Acquisition Regulation Supplement (DFARS) 252.227-7020, "Rights in Special Works".

## 4.2.2 Design: Courses shall:

- 4.2.2.1 Be designed to run in DoDEA's designated Virtual Learning Environment (VLE) and scalable to any platform which supports SCORM 1.2. (See <a href="https://www.adinet.gov">www.adinet.gov</a>.)
- 4.2.2.2 Meet universal design principals and World Wide Web Consortium (W3C) guidelines. See <a href="https://www.w3.org">www.w3.org</a>.)
- 4.2.2.3 Be object-based and meet all SCORM (Shared Content Object Reference Model)1.2 requirements. The lowest Shareable Content Object (SCO) will be at the Lesson level.
- 4.2.2.4 Provide interactive and video file Lesson Materials and Teacher Resources in QuickTime v. 6.0+ and Windows Media V.9+ formats, and/or Flash6+ format, with closed captioning that is compatible with identified hardware and operating system requirements. (See 5.5.)
- 4.2.2.5 Be designed and delivered in HTML to facilitate multiple format use (including, but not limited to, CD distribution and mobile platforms) and include all digital assets (HTML web pages, Flash interactives, video components, and all related stock images).
- 4.2.2.6 Contain two sets of Course files; a master set and a low bandwidth set. The master set shall contain Lesson Materials and Teacher Resources with rich media elements; the low-bandwidth set shall contain duplicate Lesson Materials and Teachers Resources in plain text.
- 4.2.2.7 Be subscription-free and require no additional hardware or software for operation except for those identified in Section 5.0.
- 4.2.2.8 Have Lessons that include Lesson Materials containing virtual resources delivered via the Internet such as simulations, games, scenarios, case studies, role playing and opportunities. Interactive Lesson Materials, such as large Flash objects and videos, shall be inserted, not embedded, into the Lesson as user user-initiated links. All Lesson Materials consisting of Flash and video assets shall be differentiated from text objects in the web folder structure with no streaming video service required for proper video delivery.

## 4.3 Project Management Team

4.3.1 The Contractor shall designate a Project Management Team consisting of a project manager, a lead subject matter expert (SME), and a lead instructional designer (the Contractor shall designate at least two people to the Project Management Team). The Project Management Team shall participate in the Post-Award Conference/Implementation Plan Meeting and the Monthly Leadership Meetings described below, and shall be the points of contact for the content

and instructional design matters, including professional development. Further, the Project Management Team will also be responsible for providing DoDEA the four Quarterly Status Reports described below.

- 4.3.2 <u>Monthly Leadership Meetings</u>: The Monthly Leadership Meetings shall be devoted to reviewing the progress of and discussing changes in the Course Modules. The <u>Monthly Leadership Meetings</u> shall focus on such topics as content analysis, design and development protocols, internal and external content review and evaluation, encoding, distribution of content, and course implementation.
- 4.3.3 Quarterly Status Reports: The Contractor shall provide DoDEA four Quarterly Status Reports (a report each quarter), detailing the progress it has made towards completing the contract requirements and meeting deadlines. The format shall be finalized at the Implementation Plan Meeting, but shall include a discussion of the progress of each Course's development and a discussion of any outstanding issues.

## 4.4 Subject-Matter Experts (SME)

- 4.4.1 The Contractor shall provide at least one SME for each Course who is knowledgeable of the curriculum requirements and course materials.
- 4.4.2 The Contractor's SMEs shall (1) assist in content development of the Courses (including both the Lessons and the Teachers Resources) to ensure informed, quality instruction and (2) coordinate the integration of course standards and materials, correlation to online instructional strategies, and authentic assessment methodologies.
- 4.4.3 The Contractor's SMEs shall provide online and/or videoconference professional development services related to Course content, educational theory and instructional practices related to creating and implementing quality online courses. DoDEA anticipates that the Contractor will be working with 3-5 members of the DoDEA Content Development Team per course.

## 4.5 Professional Development: The Contractor shall:

- 4.5.1 Content Professional Development: Have its SME provide selected members of the DoDEA content development teams with approximately 125 hours of professional development on such topics as differentiating instruction and incorporating new technology into instruction. DoDEA anticipates that this professional development will be conducted in various venues through various types of media (face-to-face, videoconferencing, online and telephonic); however, when possible, DoDEA will require the Contractor to provide professional development telephonically or online Professional development recipients will include distance learning teachers and district, area, and headquarter staff. DoDEA anticipates that any face-to-face training will be for a group no larger than 25 people. DoDEA and the Contractor will determine the topics and schedule for professional development at the Post-Award and Implementation Plan Meeting. (See 3.3.)
- 4.5.2 Instructional Design Professional Development: Have its instructional designers provide DoDEA instructional designers with approximately 60 hours of professional development on the following topics: (1) principles and strategies based on researched learning theories that match student needs and management of virtual content developed in conjunction with this initiative and (2) how to revise/replace existing modules. Instructional design professional development shall generally be conducted telephonically or online; however, DoDEA anticipates that there will be one face-to-face meeting at DoDEA HQ (one day with approximately seven DoDEA staff).

DoDEA and the Contractor will determine the topics and schedule for professional development at the Post-Award and Implementation Plan Meeting. (See 3.3.)

- 4.6.3 <u>Summer Conference</u>: During the summer conference, DoDEA's content experts for each Course will be scheduled to be available for meeting with the Contractor's instructional designers and SMEs to provide course development support for each Course. (See 4.6.4.) The scheduling of meetings between DoDEA's content experts and the Contractor's instructional designers and SMEs will be determined during the Post-Award Implementation Meeting.
- 4.6.4 <u>Course Development Support</u>: In support of the course development process, including the development of teacher resources, DoDEA will provide the Contractor with components of its existing curriculum. For all Courses the components will be delivered at, or before the start of the Summer Conference, and will include the following:

- DoDEA content standards
- Course objectives and descriptions
- Course requirements, such as laboratory activity/scientific inquiry requirements for science classes, oral, aural, reading and writing requirements for foreign language requirements, etc.
- Written expectations and regulations pertaining to academic integrity and etiquette with respect to lesson activities, discussions, email communications, and plagiarism.

## Components provided at the Summer Conference

- Outline of overall course structure with a detailed scope & sequence for each course that includes the following for each module and lesson
- Module: Standards, Essential Understandings, and Guiding Questions
- Lesson: Objectives, Lesson Core Concepts, Key Terms, Guiding Questions
- Guidance for planning assessments such as pre/post test, formative/summative assessments, and the interrelationship with teacher-developed assessments.
- List of general resources for each course

## 5.0 TECHNICAL REQUIREMENTS

- 5.1 Section 508 Compliance: All Courses (including all Lesson Materials and Teacher Resources) shall be Section 508 compliant (<a href="www.Section508.gov">www.Section508.gov</a>) to include text equivalents for all Flash interactive elements, and display or presentation of alternate text presentation or audio description for all videos.
- 5.2. 5.3 All Lesson Materials and Teacher Resources containing windows, fly-out menus, etc. shall work from within an environment that blocks popup windows. Additionally, all Lesson Materials and Teacher Resources shall not require the use of streaming videos or downloads, such as Java Applets.

- 5.4 All Lesson Materials and Teacher Resources containing add-in software packages shall support unattended installation methods used by enterprise software packaging and deployment systems, e.g., Microsoft Systems Management Server, Computer Associates Unicenter software delivery, Symantec Altiris deployment solution.
- All Courses (including all Lesson Materials and Teacher Resources) shall be delivered via a web-based platform and provide video files in QuickTime v. 6.0+ and Windows Media V.9+ formats, and/or Flash6+ format that are compatible with DoDEA hardware and operating system requirements. The Courses (including Lesson Materials and Teacher Resources) shall run successfully in the existing DoDEA environment.
- 5.6 The Courses (including Lesson Materials and Teacher Resources) shall be robust enough to serve the needs of a large community of learners dispersed across the world. The Courses (including Lesson Materials and Teacher Resources) should present video media with selectable bandwidth usage ranging from 56K to 1MB for upload/download of video media.
- 5.7 Upon contract, all Contractor personnel associated with this project shall sign a Non-Disclosure Agreements (NDA). The NDA will prohibit the disclosure, publishing, divulgence, or release of any information to include, but not limited to Information Technology Assurance and Compliance information.
- 5.8 Course Development: DoD requires that the Courses be SCORM compliant.
  - 5.8.1 Each Lesson within a Module shall be designed as a reusable learning object (LO). A map identifying each LO shall be provided.
  - 5.8.2 The Courses (including Lesson Materials and Teacher Resources) shall be based on open industry standards for Web deployments (XML, SOAP or AQ) and support the major learning standards: SCORM 1.2, IMS, IEEE LOM, IMS Metadata vocabulary, IMS Content Packaging 1.1.2, IMS QTI 1.2, and IMS Enterprise 1.01. (See <a href="https://www.imsproject.org">www.imsproject.org</a>.)
  - 5.8.3 Documents shall be organized so they may be read without style sheets. For example, when an HTML document is rendered without associated style sheets, it shall still be possible to read the document.

- 6.0 DELIVERABLES: The Contractor(s) shall:
- 6.1 <u>Post-Award and Implementation Plan Meeting</u>: Participate in a two-day meeting at DoDEA HQ within ten days after contract award, to coordinate details associated with course development and duties of each SME. The main purpose of the meeting is to finalize an implementation plan, which shall include course development timelines and an evaluation plan. The evaluation plan shall contain review cycles for eight Modules per semester-length Course (16 Modules for a year-long Course), supported by written documentation reflecting all course modifications, revisions and approvals.
- 6.2 <u>Summer Conference</u>: The project manager, instructional designers, and SMEs as stated in the Contractor's implementation plan will meet at a facility provided by the Government for ten days to plan the development of the 33 courses that must be ready for use by June 30, 2010. The conference shall begin within 60 days of contract award, but is expected to occur in mid-July. DoDEA will be responsible for planning the Summer Conference.

- 6.3 Monthly Leadership Meetings: The contractor's Project Management Team shall meet with DoDEA staff to review and discuss the overall design process. The first meeting shall be face-to-face at DoDEA HQ and the subsequent meetings shall be by teleconference or videoconference.
- 6.4 <u>Quarterly Status Reports</u>: The Contractor shall provide DoDEA a status report each quarter, detailing the progress towards completing the contract requirements.
- 6.5 <u>Content Development Professional Development</u>: The Contractor shall provide approximately 125 hours of professional development to selected members of DoDEA's content development team at mutually agreed upon times during the base period.
- 6.6 <u>Instructional Design Professional Development</u>: The Contractor shall provide approximately 60 hours of professional development to DoDEA instructional designers at mutually agreed upon times during the base period.
- 6.7 <u>Delivery of Courses</u>: Deliver 33 completed Courses (including Lesson Materials and Teacher Resources) by June 30, 2010, per the requirements and timeline listed in this performance work statement. (See 4.1.2.) The Courses shall be delivered in HTML format. Upon delivery of each Course (including Lesson Materials and Teacher Resources), Contractor shall grant DoDEA all of the licenses and rights set forth in the "Rights in Special Works" clause at DFARS 252.227-7020, and agree to indemnify DoDEA as described therein.
- 6.8 <u>Technical Support</u>: The Contractor shall ensure the functionality of all deliverables for the period of one calendar year after delivery of all Courses at no cost to the Government.

## 6.9 Option Years 1-2

- 6.9.1 Course Delivery: The Contractor may be requested to develop three full year Courses and two semester Courses each year for the DoDEA virtual high school. DoDEA will develop the course development framework and deadlines for completion. The Courses shall include at least one more lab science course and two additional Professional Technical Studies course such as Marketing and Entrepreneurship, Business and Personal Finance, Business Law, and Digital Electronics I and two additional foreign language courses such as Spanish III and Spanish IV or French I and French II. No courses are required for Option Years 3-4. (See 3.2 and 4.1.)
- 6.9.2 <u>Technical Support</u>: The Contractor shall ensure the functionality of all deliverables for the period of one calendar year after delivery of all Courses at no cost to the Government.
- 6.9.3 Professional Development: The Contractor shall be requested to provide (1) approximately 40 hours of professional development for the content development team and (2) approximately 20 hours of professional development for DoDEA instructional designers. Professional development content will expand on topics described in 4.5.1 and 4.5.2 and will be related to implementation of courses to be designed. (See 3.3.)
- 6.10 Option Years 3-4: The Contractor may be requested to provide (1) approximately 30 hours of professional development for DoDEA Content development team and (2) approximately 20 hours of professional development for DoDEA instructional designers. (See 6.9.2.)

Duties: The Program Administrator shall have shared overall responsibility for the Contractor's subcontracting programs including. But not limited to, developing, preparing, and executing individual subcontracting plans and monitoring performance relative to this particular plan. Some of these duties include the following activities:

- 1. Developing and promoting company/division policy statements that demonstrate the company's/division's support for awarding contracts and subcontracts to small, hubzone small, small disadvantaged, women-owned small, veteran-owned small, and service-disabled veteran-owned small business concerns.
