### **President Clinton meeting with National Security Council and Foreign Policy Advisors in August of 1998**

#### **Extent**

Approximately 37 photographs in color film processed from 35mm negatives.

#### **Access**

Collection is open to all researchers. Access to Clinton Presidential Records is governed by the Freedom of Information Act (FOIA) (5 USC 552 as amended) and the Presidential Records Act (PRA) (44 USC 2201) and therefore records may be restricted in whole or in part in accordance with legal exemptions.

#### **Copyright**

The materials in FOIA 2007-0389-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA request 2007-0389-F contains photographs from the White House Photograph Office pertaining to President Clinton's meeting with his National Security and Foreign Policy advisors in the Situation Room on August 12, 1998. The President is briefed by his National Security team. The request also contains photographs from a Foreign Policy Meeting in the Oval Office on August 14, 1998. The President meets with George Tenet, William Cohen, Madeleine Albright, Sandy Berger, Leon Fuerth, Richard Clarke, Gen. Henry "Hugh" Shelton, Thomas Pickering, Gen. Donald Kerrick, Maria Echaveste, and John Podesta.

***The majority of the White House Photograph Office material related to this FOIA case is currently withheld under Presidential Records Act and Freedom of Information Act restrictions.***
