Scope and Content

The materials in FOIA 2009-1399-F are a selective, not necessarily all inclusive, body of documents responsive to the topic of the FOIA. Researchers should consult the archivist about related materials.

FOIA case 2009-1399-F contains responsive photos from the White House Photograph Office.

The photographs processed for this request pertain to Alan Greenspan meeting with President Clinton and economic policy advisors during the period of 1995, 1997, 1998, and 2000. The responsive photographs concerning this case are from meetings and briefings concerning Alan Greenspan, Federal Reserve Chairman, and the President's economic policy team. Furthermore, responsive photographs include President Clinton announcing the renomination of Alan Greenspan as Chairman of the Federal Reserve Board on January 4, 2000. The meeting and briefings take place in the Oval Office. Some of the advisors in the meetings include: Secretary Robert Rubin, Larry Summers, Mack McLarty, Pat

Griffin, Martin Baily, and others. The case includes photographs processed with Alan Greenspan, Robert Rubin, and Larry Summers photographed together.
