REPORT OF THE AUDIT DIVISION ON BENTSEN FOR VICE PRESIDENT - 88

I. Background

A. Overview

This report is based on an audit of Bentsen for Vice President - 88 ("the Committee") to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The audit was conducted pursuant to 26 U.S.C. §9007(a) which states that "after each presidential election, the Commission shall conduct a thorough examination and audit of the qualified campaign expenses of the candidates of each political party for President and Vice President."

In addition, 25 U.S.C. §§ 9009(b) and 9039(b) state, in relevant part, that the Commission may conduct other examinations and audits from time to time as it deems necessary to carry out its responsibilities under these chapters.

The Committee registered with the Federal Election Commission on July 22, 1988 and maintains its headquarters in Houston, Texas.

The audit covered the period from the Committee's inception (July 1988) through March 31, 1989. During this period, the Committee reported an opening cash balance of \$0, total receipts of \$27,257.67, total disbursements of \$27,257.67, and a closing cash balance of \$0.

The receipt and disbursement activity of the Committee only involved convention related expenses of the eventual Vice Presidential nominee and is considered separate and apart from the respective primary and general election campaigns of the Presidential nominee.

This report is based upon documents and workpapers which support each of the factual statements. They form part of the record upon which the Commission based its decisions on the matters in the report and were available to Commissioners and appropriate staff for review.


