ON THE
COMMITTEE TO RE-ELECT JACK BROOKS
AND THE
JACK BROOKS CAMPAIGN COMMITTEE

1. BACKGROUND

A. Overview

This report is based on an audit of the Committee to Re-Elect Jack Brooks and the Jack Brooks Campaign Committee undertaken by the Audit Division of the Federal Election Commission in accordance with the Commission's audit policy to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The audit was conducted pursuant to Section 438(a)(8) of Title 2. United States Code, which cdirects the Commission to make from time to time audits and field investigations with respect to reports and statements and under the provisions of the Act.

The Jack Brooks Campaign Committee registered with the Clerk of the U.S. House of Representatives on April 13, 1972 and the Committee to Re-Elect Jack Brooks on September 1972, 1972. Both Committees supported the Honorable Jack Brooks, candidate for re-election to the U.S. House of Representatives from the 9th Congressional District of Texas. On June 25, 1975, the Jack Brooks Campaign Committee was terminated and the funds were transferred to the Committee to Re-Elect Jack Brooks which was then designated by the Candidate as the principal campaign committee. The Committee maintains its headquarters in Chevy Chase, Maryland.

The audit covered the period from January 1, 1975 through June 30, 1977, the final coverage date of the latest report filed by the Committee to Re-Elect Jack Brooks at the time of the audit. The Committees reported the following activity during that period:

The principal officers of both Committees for the period covered by the audit were Clayton L. Burwell, Chairman, and Walter D. Hansen, Treasurer.

C. Scope

The audit included such tests as verification of total reported receipts and expenditures and individual ctransactions; review of required supporting documentation; analysis of Committee debts and obligations; and, such other caudit procedures as deemed necessary under the circumstances.

II. Auditor's Statement

of the reports and statements filed and the records presented, that the reports and statements of the Jack Brooks Campaign Committee and the Committee to Re-Elect Jack Brooks fairly present the financial activities of the Committee for the period covered by the audit. No material problems in complying with the Federal Election Campaign Act were discovered during the course of the audit.

An expenditure of \$11,761.09 by the Jack Brooks Campaign Committee and an equal amount of the \$78,346.39 in receipts of the Committee to Re-Elect Jack Brooks represent an inter-committee transfer.
