# REPORT OF THE AUDIT DIVISION ON THE RICHARDSON FOR CONGRESS COMMITTEE

# Background

#### A. Overview

This report is based upon an audit of the Richardson for Congress Committee ("the Committee") undertaken by the Audit Division of the Federal Election Commission in accordance with the Commission's audit policy to determine whether there has been compliance with the provisions of the Federal Election Campaign Act of 1971, as amended ("the Act"). The audit was conducted pursuant to Section 438(a)(8) of Title 2, United States Code, which directs the Commission to make from time to time audits and field investigations with respect to reports and statements filed under the provisions of the Act.

The Committee registered with the Federal Flection Commission on May 20, 1976 as the principal campaign committee of Robert Richardson, a candidate for the U.S. House of Representatives from the 5th District of South Carolina. The Committee maintains its headquarters in Sumter, South Carolina.

The audit covered the period May 1, 1976 through February 1, 1977, the final coverage date of the termination report filed by the Committee. During that period, the Committee reported beginning cash of \$-0-, total receipts of \$191,694.44, total expenditures of \$191,694.44 and ending cash of \$-0-.

This audit report is based on documents and working papers supporting each of its factual statements. They form part of the record upon which the Commission based its decisions on the matters in this report and were available to Commissioners and appropriate staff for review.

The audit included such tests as verification of reported receipts and expenditures and individual transactions; review of required supporting documentation; analysis of Committee debts and obligations; and, such other audit procedures as deemed necessary under the circumstances.

### II. Auditor's Statement

It is the opinion of the Audit staff, based upon examination of the reports and statements filed and the records presented, that the reports and statements of the Richardson for Congress Committee fairly present the financial activities of the Committee for the period covered by the audit. No material problems in complying with the Federal Election Campaign Act were discovered during the course of the audit.
