BioPreferred Proposes Voluntary Label for Biobased Products

The BioPreferred program announced this month it intends to create a consumer label that will appear on biobased products. When finalized, manufacturers will be able to participate in a voluntary labeling program to distinctively identify biobased products on store shelves. The label, published in the Federal Register, will be available for public comment until September 29, 2009. BioPreferred encourages interested groups, especially manufacturers, industry stakeholders and Federal government officials to provide feedback on the label.

Labeling Rule Highlights

- <u>Product eligibility</u>: Any biobased products that meet USDA minimum biobased content requirements are eligible for the label. These requirements are broken down into two groups:
 - 1. <u>Products in designated item categories</u>. These are biobased products that meet percent biobased content standards for product categories set up by the BioPreferred preferred procurement program. As of August 2009, there are 33 designated categories containing approximately 3,300 products.
 - Products not within designated categories. Biobased products that do not fall into one of the designated item categories must meet a 51 percent content requirement, unless USDA approves an alternative minimum biobased content.
- <u>Label design</u>: Two versions of the label are proposed for the labeling program. One
 version will be used for non-designated product and a slightly different version is
 suggested for designated products.
- <u>Mature markets</u>: Mature market products, those products that held significant market share in 1972, such as cotton clothing, are eligible on a case-by-case basis.
- <u>Eligibility of intermediate ingredients and feedstocks</u>: Intermediate ingredients and feedstocks, raw materials required to manufacture biobased products, are eligible for the BioPreferred label if the minimum biobased content is 51 percent, unless USDA approves an alternative biobased content minimum.
