Dear Mr. Stall:

On August 29, 2003, the NRC completed a physical security baseline inspection at your Turkey Point Units 3 and 4. The enclosed report addendum documents the inspection details which were discussed on August 29, 2003, with Mr. M. Pearce and other members of your staff.

The inspection examined activities conducted under your license as they relate to public health and safety, the common defense and security, and to compliance with the Commission's regulations, orders, and the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material will not be placed in the NRC Public Document Room. The enclosed report is being submitted as an addendum to NRC Inspection Reports 05000250/20030004 and 05000251/20030004, issued on October 27, 2003, and entered into the NRC document system (ADAMS) under accession number ML033020375.
