Assessments and Research

I am forming an Executive Steering Committee to provide guidance on the results from research and the assessments of 2010 Census operations, which also helps form direction for early 2020 life-cycle testing. Your participation on the committee is requested. Responsibilities of the Executive Steering Committee include:

- Participating in briefings on results from the 2010 Census Program for Evaluations and Experiments (CPEX), the 2010 Census Assessment Program, and the 2010 Census Quality Profile Program. Appended to the attached charter is the current inventory of evaluations, experiments, assessments, and quality profiles.
- Assessing program recommendations from stakeholders (such as the Advisory Committees, Office of Inspector General, the Government Accounting Office, and the National Academy of Sciences).
- Facilitating the bridging of 2010 Census results to early 2020 Census plans.

Charter 2010 Census Assessments and Research Executive Steering Committee

Statement of Purpose

The Executive Steering Committee (ESC) for the 2010 Census Assessments and Research (CAR) will provide guidance on the results from research, such as evaluations and experiments, and the assessments of 2010 Census operations. The ESC oversight of the results also will help form direction for early 2020 life-cycle testing.

Mission

This committee, consisting of Census Bureau Executive and Senior Staff members, will help define the scope and focus of early 2020 life-cycle testing, based on results from the 2010 Census Program for Evaluations and Experiments (CPEX), the 2010 Census Assessment Program, and the 2010 Census Quality Profile Program. Committee members will support the application by all program participants of the Quality Process guidelines for report development. The committee will oversee and the timely availability of research results for 2020 Census planning, and advise on priorities, as necessary.

Scope

Major activities within the scope of the committee include:

- Participating in briefings on results from the 2010 Census Program for Evaluations and Experiments (CPEX), the 2010 Census Assessment Program, and the 2010 Census Quality Profile Program.
- Formulating the scope of 2010 Census program topic reports.
- Advising on guidelines and standards for what gets pre-released.
- Advising on the program completion timeframe.
- Prioritizing analysis and results from research and assessments, as resource issues arise.
- Facilitating the bridging of 2010 Census results to early 2020 Census plans.
- Assessing program recommendations from stakeholders (such as the Advisory Committees, Office of Inspector General, the Government Accounting Office, and the National Academy of Sciences).
- Providing direction if program cuts are required.
- Directing the application of the Quality Process to all research and assessments.
- Establishing policy for providing data to external stakeholders.

Meetings and Support

The committee will begin meeting in the next month or so and will remain active as needed, possibly until September 30, 2013. Meetings will be held monthly, but as the volume of results increases, more frequent meetings will be necessary. Upon confirmation of attendance from proposed core members, a kick-off meeting will be held. Depending on the subject matter of the results being briefed, additional appropriate critical reviewers and Executive and Senior Staff will be invited.

Meeting schedules, agendas, and documentation will be managed by staff in the Decennial Management Division.
