### Capt. Daryl R. Hancock

Capt. Daryl R. Hancock is the director of Intelligence, United States Transportation Command, Scott Air Force Base, Ill. He is responsible for directing and executing all-source, multi-disciplinary intelligence operations and support to all USTRANSCOM missions.

Capt. Hancock is a native of Marion, Ill. and a graduate of the University of Illinois where he was commissioned through the Navy ROTC Program. He holds master's degrees from Purdue University and the Naval War College, and is a Senior Executive Fellow from Harvard's John F. Kennedy School of Government.

His Navy career began as a Surface Warfare Officer aboard the destroyer USS Scott, serving as a division officer and department head during deployments to the Mediterranean, North and Red Seas between 1987-91. In 1990, he served as the ship's tactical action officer for maritime interception operations during Operation Desert Shield. He subsequently served ashore as an instructor at the Purdue University NROTC Unit, and as officer-in-charge of a Navy sail training ketch along the East Coast, before a lateral transfer into naval intelligence.



His intelligence assignments ashore include duty as a watch officer and operations officer for the Atlantic Command Joint Intelligence Center, where he directed the theater intelligence watch. In 1999, as commander of the Navy Element at the Joint Analysis Center, Molesworth, England, he led the Navy team and served as Chief of Maritime Analysis directing maritime intelligence support in the European Theater and providing Balkans wartime support to Operations Allied Force and Enduring Freedom. In Washington duty, he served as director of the National Maritime Intelligence Watch at the Office of Naval Intelligence (ONI), and from 2006-08 he was the executive assistant to the Director of Naval Intelligence (CNO N2) on the Navy staff at the Pentagon. He also served as director of both CNO N2's International Engagement and the ONI Collections Office.

As an intelligence officer afloat, he served as the Assistant Intelligence Officer for the Flag Staff aboard USS Wasp, during Operation Restore Democracy off the coast of Haiti and with Cruiser Destroyer Group Two aboard USS George Washington, deploying to the Persian Gulf and Mediterranean Sea. He also participated in unique events such as Operation Sail 200, where the USS Constitution set sail unassisted for the first time in 116 years. As the intelligence officer (N2) for Commander Amphibious Group Three, he deployed afloat and ashore with CTF-51 in support of Operation Iraqi Freedom. He deployed again, as the N2 for Expeditionary Strike Group FIVE aboard USS Bonhomme Richard where he directed Strike Group intelligence afloat and ashore, during combat operations in Iraq, maritime security operations in the Persian Gulf and tsunami relief operations in Indonesia. In 2009 he became the director of Intelligence for TENTH Fleet and Fleet Cyber Command, responsible for identifying and defending against cyberspace threats to the Navy's networks, space, information operations and electronic warfare missions.
