

Attachment: Calendar Year 2013 Monthly Premium Rates for TRICARE Reserve Select and TRICARE Retired Reserve

TRICARE Reserve Select (TRS) premium rates are established annually on a calendar year (CY) basis in accordance with Title 10, United States Code (U.S.C.), Section (Sec.) 1076d and Title 32, Code of Federal Regulations (CFR), Section 199.24. The TRS monthly premiums for CY 2013 shall be the rates listed in the table below:

Type of Coverage	2012 TRS Monthly Rate	2013 TRS Monthly Rate	Change
TRS Member-only	\$ 54.35	\$ 51.62	- 5.3%
TRS Member & family	\$ 192.89	\$ 195.81	+ 1.5%

TRICARE Retired Reserve (TRR) premium rates are established annually on a CY basis in accordance with Title 10, U.S. C., Sec. 1076e and Title 32, CFR, Section 199.25. The TRR monthly premiums for CY 2013 shall be the rates listed in the table below:

Type of Coverage	2012 TRR Monthly Rate	2013 TRR Monthly Rate	Change
TRR Member-only	\$ 419.72	\$ 402.11	- 4.4%
TRR Member & family	\$ 1,024.43	\$ 969.10	- 5.7%
