These documents are responsive to one or more of the following requests made to the Federal Energy Regulatory Commission for Enron-related documents under the Freedom of Information Act (FOIA), 5 U.S.C. § 552: FY02-26 (Judicial Watch I), FY02-43 (Associated Press), FY02-61 (Los Angeles Times), FY02-64 (Judicial Watch II), FY02-65 (Wall Street Journal), FY02-74 (Bloomberg), FY02-84 (Washington Post), FY02-105 (San Diego Union Tribune) and FY02-107 (Betsy Miller). However, parts of the documents are being withheld under one or more FOIA exemptions. Each named FOIA requester has been contacted separately by letter and provided his or her appeal rights. This index does not create appeal rights for anyone unless he or she has submitted a formal FOIA request and that request has been formally denied, in whole or in part, by FERC.
