FY 2011 Targets

- Office of Management and Budget (OMB) and Indian Health Service (IHS) negotiate budgets annually
- Initial 2011 targets established in January 2010 budget documents
- All targets adjusted down in January 2011 budget documents, based on
 - 2010 performance
 - Decreased funding from initial 2011 budget proposal

2Q FY 2011 California Area GPRA

- 4 measures “on track” to meet or exceed national targets:
 - Poor glycemetic control
 - Ideal glycemetic control
 - Pneumovax immunizations
 - Dental Access
- 4 measures “within range” based on historical performance:
 - LDL Assessed
 - Retinopathy Assessed
 - Tobacco Cessation
 - CVD Comprehensive

2Q FY 2011 California Area GPRA

- 7 measures “Not yet within range” based on historical results, but with extra effort, could meet targets:
 - Controlled Blood Pressure
 - Nephropathy Assessed
 - Mammography Screening
 - Colorectal Cancer Screening
 - Alcohol Screening
 - DV/IPV Screening
 - Depression Screening*

*BH measures need to improve by 21-24 percentage points, compared to 17 points in FY 2010

2Q FY 2011 California Area GPRA

- 4 measures “not on track” to meet:
 - Influenza Immunization
 - Childhood Immunization
 - Pap Screening
 - Prenatal HIV Screening*

All four measures are underperforming compared to FY 2010 2Q results, and are well below the national targets.

*Prenatal HIV: CA Area average for this measure is consistently below national targets. NGST is forming a workgroup to brainstorm ideas and share best practices.



California Area GPRA Initiatives

Incentives for Behavioral Health Screening GPRA Measures*

- Universal Screening for BH GPRA measures
 - Depression Screening
 - DV/IVP Screening
 - FAS Screening
- FY 2011 Incentives:
 - CAO will be sending out some “seed” money in near future (\$1 per Active User)
 - Then, incentive payments to be made to each clinic that achieves either >50% improvement in all measures, or achieves 80% for each
 - Incentive amounts will be \$5000, \$7500, \$10000, depending on size of clinic

Prenatal HIV Workgroup

- Prenatal HIV rates in California have lagged behind national averages
- Issues identified:
 - No prenatal care at sites; all tests are referred out and results are either not received or not recorded
 - Provider reluctance to screen
 - Confusion over privacy issues/consent
- Workgroup- representatives from higher and lower-performing sites
- Brainstorm ideas for improvement, make recommendations
