Today, the AFL-CIO Executive Council's Health Care Committee met to review what we understand to be the basic elements of the health care reform plan that President Clinton will present to the nation tomorrow evening.

Our assessment of the President's plan is that it meets labor's goals for health care reform. It will be good for working people, good for their families, and good for the country.

Accordingly, the AFL-CIO is going to support this historic initiative and we're going to conduct a major campaign for its enactment by the Congress.

ADA Prepared to Respond to President Clinton's Health System Reform Plan

The American Dental Association (ADA), which represents 140,000 dentists, is prepared to respond to President Clinton's address to a joint session of Congress on his health system refor plan.

"The American Dental Association agrees with the President that a high priority should be placed on children," said Dr. Jack Harris, president of the Chicago-based ADA, commanting on the President's plan to offer preventive dental benefits to children to age 18. "However, we believe any health system reform plan should first focus limited federal funds earmarked for dental benefits on providing oral health cars to poor people of all ages starting with children."

With regard to how dentistry fits into the overall theme of health system reform, Dr. Harris said "dentistry has, for a majority of Americans, already achieved many of the goals which President Clinton is struggling to accomplish with health system reform--cost containment and improved access to care and an emphasis on prevention," he said.

Dr. Harris pointed out that dental insurance plans, for instance, encourage people to seek preventive care by reimbursing them at a higher percentage for regular teeth cleanings and checkups and a lower rate for more costly restorative work.

Dr. John S. Zapp, executive director of the ADA said that th delivery and financing of dental care has traditionally differed dramatically from medical care, making a merger between the two systems unworkable.

"Only four percent of dental services are paid for with publ funds," said Dr. John S. Zapp, executive director of the ADA, explaining one reason why the Clinton Administration has not scrutinized dentistry as it has medicine, pharmaceuticals and insurance.

Dr. Zapp said the ADA applauds the Clinton Administration fo recognizing that oral health is an integral part of overall healt He indicated the ADA is looking forward to working with both the Clinton Administration and Congress to ensure that Americans receive the finest oral health care possible under health system reform.

THE CLINTON HEALTH CARE PLAN

The President's plan dramatically changes the way we think about health care in this country. Instead of drawing harsh lines between medical care and long term care, the President is saying that Americans who have Alzheimer's disease and other chronic illnesses or disabilities also have a right to the care they need.

The Alzheimer's Association commends the President not only for his commitment to long term care but to the framework of his specific proposals, which embody the Association's recommendations for appropriate and cost-effective care.

The President's long term care proposals will give families the help they need to care for their loved ones at home where they want to be, without bankrupting the family or destroying the caregiver's health. His plan also takes useful steps to help with the overwhelming cost of a nursing home when that is the only option for care.

The President is offering help now to the 4 million American families who are dealing with Alzheimer's disease today, through his long term care proposals. By recommending increased funding for Alzheimer research, he is also offering hope to the 14 million Americans who will get Alzheimer's before they die if scientists do not find a way to stop the disease. Alzheimer's disease is the leading cause of dementia and the fourth-leading cause of death among adults. At least half of current residents of nursing homes have Alzheimer's disease or a related dementia.

The Alzheimer's Association is the only national voluntary health agency dedicated solely to support for persons with Alzheimer's disease and their families and to research to find the causes and effective treatments for the disease. The Association works through 220 chapters and thousands of support groups in the 50 states.

AIDS Action Council, the Washington voice of our nation's AIDS organizations, applauds President Clinton for taking this historic step to reform the nation's health care system. The AIDS epidemic, more than any other public health crisis, has exposed the woeful inadequacies of our existing health care delivery system. The proposal set forth by the President provides the first comprehensive national framework for addressing a broad range of health care issues facing people living with HIV/AIDS from the elimination of pre-existing condition exclusions to the preservation and enhancement of Ryan White CARE Act programs.

We look forward to continuing to work with the Administration to assure that issues and concerns of special interest to people living with HIV/AIDS are addressed.

Ann Elderkin represents one of the fastest growing health care professions in the United States -physician assistants (PAs).

Physician assistants are medically trained to provide health care services that traditionally have been performed by doctors, including diagnosing illnesses, developing treatment plans, assisting in surgery, and in most states prescribing medication. They practice medicine with the supervision of a physician, yet most state laws provide for supervision to occur via telephonic communications.

In addition to her volunteer duties as president of AAPA, Elderkin is the director of the Health Department in Somerville, Massachusetts. Somerville is a city of 76,000 residents next to Boston. Somerville faces some of the pressing health care issues of today – AIDS, tuberculosis, smoking, violence, substance abuse, lead paint poisoning, childhood immunizations, elderly health care, and the health problems of those who are under- and un-insured.

Elderkin received her medical training at the Yale University School of Medicine Physician Associate Program and graduated in 1980. Her clinical work has included internal medicine, cardiothoracic surgery, family medicine, and outpatient "urgent care" medicine at Harvard Community Health Plan, one of the largest HMOs in Massachusetts. Elderkin received her bachelor's degree in Human Services Administration from the University of Massachusetts in Amherst in 1976.

Just prior to her appointment as director of the Somerville Health Department in 1990, Elderkin worked as a senior research analyst for the chairman of the State Senate Health Care Committee. She was responsible for analyzing and developing legislation and budget amendments on health care policy and financing issues, including a universal health care law, medical malpractice insurance, and health care cost containment.

In her position as director of the Health Department, Elderkin has been a leader in AIDS education and services. She also has led the effort to pass comprehensive local tobacco control regulations and to implement educational programs to promote non-smoking. She serves on the board of trustees of her local hospital and on the Governor's Advisory Committee on Childhood Lead Poisoning Prevention. Elderkin is a former VISTA volunteer.

The president of the American Academy of Physician Assistants (AAPA), Ann Elderkin, PA, from Somerville, MA, today issued the following statement in response to President Bill Clinton's health care reform proposal:

"The debate over universal health care coverage has gone on long enough. Today's announcement is an important step toward making it a reality. We endorse the goals and objectives of the Clinton plan. It is the most comprehensive health care reform plan yet proposed.

"There are too many men, women, and children in the United States without adequate care. The Clinton plan addresses the need for greater access to medical services.

"There are too many conflicting interests in today's health care system. The Clinton plan outlines a team approach to health care that focuses on the needs of the patients.

"There are too many communities today lacking health carc services. The Clinton plan encourages the utilization of a mix of health carc providers in rural and urban areas.

"AAPA recognizes that changes will be made to the plan as it is debated in Congress. We will be actively working to retain those elements in the plan that promote: universal access, comprehensive primary and preventive care, fair and equitable cost . . 16:30

The Clinton health care reform plan recognizes that physician assistants (PAs) are essential to the delivery of primary care and preventive health care services to an increasing number of people. The proposal calls for doubling the number of PA graduates by increasing federal funding for PA programs. It encourages the adoption of state laws to increase utilization of PAs. It also includes tax credits for PAs who work in rural communities.

AAPA represents the more than 27,000 physician assistants in the United States and the armed forces. PAs are educated to provide health care services that traditionally have been provided only by physicians, such as conducting physical exams, diagnosing illnesses, ordering and interpreting tests, establishing treatment plans, assisting in surgery, and in most states writing prescriptions. PAs practice medicine with the supervision of physicians, though most state laws provide for supervision to occur by telephone or radio. Approximately 57% of all physician assistants provide primary care services, and approximately a third work in communities with fewer than 50,000 people.

ACEP SUPPORTS HEALTH CARE REFORM WITH SAFEGUARDS FOR ACCESS TO EMERGENCY CARE

The American College of Emergency Physicians (ACEP) today commended President Clinton for his efforts to enact comprehensive health care reform, and his commitment to ensure universal access to care for all Americans.

"As the physician group currently providing the major source of medical care to the uninsured, we applaud President Clinton for making this issue a major priority of his Administration, and for making access to health care the central theme of his plan," said ACEP President Robert Williams, MD, FACEP. "Such efforts are long overdue."

ACEP endorses a number of provisions in the President's plan, including the concept of mandating employers to provide health insurance for their employees, and supports the use of so-called "sin taxes" on tobacco and alcohol to provide additional revenue to finance coverage to the uninsured.

"It is a primary goal of our specialty to ensure the availability and access to critical emergency services for all of our patients," said Williams. "Emergency care is a critical community resource that our citizens will demand be maintained at a high level of both quality and availability."

At the same time, the American College of Emergency Physicians is calling for explicit federal standards to be added to the plan to guarantee the continued availability and economic viability of essential community emergency medical services. In particular, the College is concerned that safeguards be added to the bill so that undue obstacles will not prevent individuals from seeking emergency care. Specifically, emergency physicians would like to see provisions that would prevent health plans from dissuading patients from using the emergency department when they believe it is necessary, guarantee the provision of and payment for a medical screening examination for all patients who come to the emergency department, and establish mechanisms to ensure the continued viability of timely emergency care in every community.

STATEMENT OF THE AMERICAN COLLEGE OF PHYSICIANS ON THE PRESIDENT'S HEALTH CARE REFORM PLAN

The American College of Physicians, the nation's largest medical specialty society, today expressed overall support for the President's blueprint for health care reform at a meeting between the President and physician leaders.

The President's proposal guarantees stable and secure health coverage for all Americans, regardless of employment or health status. Patients can stay with the same doctor over time because patients, not employers, control their coverage choices. Patients, not their employers, choose their health plans and their physicians. And patients and physicians continue choosing the practice arrangements they prefer, including traditional fee-for-service.

The Clinton proposal is a moderate and uniquely American approach to reform that will be the vehicle for building consensus and moving legislation through Congress. The proposal combines market forces -- competition based on price and quality -- with society's evolving perception of health care as a fundamental right, not a mere economic commodity.

Key elements of College policy are reflected in the Administration's health plan and these must remain in legislation as it moves forward:

- universal access to comprehensive health care;
- a national health care budget;
- a mix of public and private financing;
- competition among health plans based on price and quality;
- physician and patient choice; and
- enhancement of primary care practice.

As with any complex set of reforms, the President's proposal contains elements which must be changed for full physician support. The malpractice reform component is weak and must be strengthened significantly. We will closely monitor proposed strategies to address issues in graduate medical education, the health care workforce, and the authorities of new agencies at the federal and state level.

The President and leading Republicans have said the status quo is unacceptable. The College agrees. In the debate ahead, the American College of Physicians will be a constructive force for change.



The American College of Obstetricians and Gynecologists (ACOG), an organization representing more than 33,000 obstetrician-gynecologists, would like to commend you and Mrs. Clinton on your commitment to the betterment of health care in the United States. Your proposal, the American Health Security Act of 1993, is a giant step forward toward ensuring that all citizens of our nation have access to quality health care.

ACOG is supportive of the goals put forth in your health care reform package. Most importantly, we are very pleased to be defined as primary care physicians for women in your health care reform package. This designation will ensure that all women will be able to continue to freely access the primary/preventive health care services offered by their obstetrician-gynecologist.

We also believe that improved access to reproductive and prenatal care, as proposed in the American Health Security Act, will benefit the lives of all American women and their children. Furthermore, we are heartened to see that family planning and pregnancy-related services are covered in the proposed guaranteed national benefit package. These services, coupled with the availability of clinical preventive services important to women, such as Pap smears, pelvic examinations and mammograms, will undoubtedly give the women in this country the assurance that this vital health care is available.

We are also pleased to see that perinatal health, reproductive health (including contraceptive development, STDs, adolescent pregnancy and pregnancy-related complications), women's mental health and HIV/AIDs are included under your "priority areas" for prevention research. In addition, the College is encouraged that some first, positive steps have been taken in your plan to address the malpractice problem, even though we believe that further reforms are needed to remedy this particular cause of spiraling health costs.

Although the College believes there are some deficiencies in the package as it is proposed,

we believe they are differences that can be worked out. For instance, the proposed schedule of clinical preventive services (which includes the frequency of Pap smears, pelvic examinations and mammograms) is contrary to the accepted scientific guidelines that are embraced by the major medical and cancer prevention groups. We will continue to work with you and the Congress to improve this package during the legislative process.

We have appreciated the opportunities extended by your Administration to comment on various aspects of the health care reform plan as it has evolved. Your Administration has certainly done its best to address the concerns of the various groups interested in health care reform and, judging by your proposal, you have certainly attempted to reconcile these concerns.

Again, ACOG supports you and Mrs. Clinton in your effort to provide affordable health care to all Americans. You are to be commended for your commitment to the betterment of health care in America. We look forward to working with you as this package proceeds through the legislative process.

AGPA SALUTES WHITE HOUSE LEADERSHIP ON HEALTH SYSTEM REFORM

Washington, D.C. - The American Group Practice Association salutes President Clinton, First Lady Hillary Rodham Clinton and others who have participated in the White House Task Force on Health Care Reform for their tireless efforts in developing a detailed and comprehensive plan addressing health system reform for America. "The President's plan shows Americans that the status-quo is no longer an option," says AGPA Executive Vice President and Chief Executive Officer, Donald W. Fisher, Fh.D. "The President has taken a major step toward reforming the nation's health care system by including substantial reforms in the areas of insurance, malpractice, administrative simplification, and public assistance for the indigent," stated Fisher.

Fisher indicates that the 26,000 physicians in the 250 AGPA member group practices are encouraged that the President addressed many of the issues that group practices have been raising for several years. Phil Lee, M.D., one of the President's leading health care advisors, calls group practice the "single most important innovation" in American health care delivery. As organized delivery systems, group practices demonstrate that quality and accessibility can be improved while constraining the growth of costs."

AGPA has some reservations with the plan on issues such as price controls - which could lock existing inequities of the current system in place; the implementation of global budgets among all the states where spending on health care is widely variable; and the highly regulatory potential for the proposed purchasing alliances. "Despite the overwhelming need for national health reform, we urge the President to not deter the innovative efforts of group practices," stated Fisher.

"As physician led organizations, quality patient care has always been the first priority of group practices," asserted Fisher. Dr. Fisher further assured that in the challenging months to come group practices will offer their full assistance and cooperation to the President as the nation attempts to design a health care system that provides quality care to every citizen.

Thank you for inviting our staff to participate in the informative briefing on September 18, about how veterans will be affected by the administration's Health Security Act.

The American Legion's Veterans Planning and Coordinating Committee has been discussing this issue for more than 2 years. The recommendations of the VPCC were endorsed by the Legion's National Executive Committee in May 1992, and our plan was published late last year.

From the beginning of your deliberations on a national health care plan we were concerned not so much with what veterans could get out of any change in the delivery of health care nationally, but with the prospect that veterans might be left out of the overall mix of delivery schemes. On several occasions in the past 8 months we have shared our concerns with Secretary Jesse Brown and with you. Clearly, you and the members of the health care task force took our concerns seriously, and we are most appreciative of the efforts each of you made to ensure that veterans will be treated with equity and dignity.

While we do not know the final shape of the Health Security Act, we stand ready to fight to protect the benefits that have been described to us by you and Secretary Brown, and to use the power we have to let members of Congress know how we feel.

The American Legion will not stand by and let VA suffer from the status quo. We are well aware of the importance of the inclusion of VA health care in a national health program, if the system designed for veterans is to survive.

America's hospitals commend the President and the First Lady for their historic effort to analyze the strengths and weaknesses of our health care delivery system, and offer concrete ideas on how it can be improved.

The President has, in effect, fired the starting gun. The challenge facing him now is to engender and sustain a cooperative spirit with the Congress to achieve much-needed change in one of the most fundamental aspects of our lives: care of our loved ones and ourselves when we are sick or injured. While the President has provided a strong voice and credible proposals for change, his are not the only ideas that will be debated. Republicans in the House and Senate and others in the President's own party have put forth thoughtful proposals that will become

part of the discussion.

It's clear we're at the start of a long legislative process -we're beginning a marathon, not a sprint. America's hospitals <u>have</u> made a long-term commitment to health care reform. We support a reform vision that will mean dramatic change for us, and for all others who make up and use our health care delivery system -- in other words, for everyone.

We seek the kind of change that will put patients and communities at the center of the health care system. We want hospitals, physicians, and other health care providers to have sound reasons to work together, rather than at cross purposes. We want to eliminate expensive duplication of services and technology, and to contain costs.

To a significant degree, the President's plan reflects these principles. We share his belief that health coverage for all Americans must be the bedrock of any reform proposal. We see in his plan a bold yet realistic way to change the way we provide care and pay for it -- a way that will help consumers take more responsibility for their health, and will lead to wiser use of health care resources. And we share the President's view that the least disruptive way to achieve these goals is to preserve and strengthen our present system of providing health coverage. through employers, and make coverage available through the government for those not employed.

We do, however, have serious concerns about aspects of the President's proposal. Most significantly, our concerns center on the structure of health alliances; on the proposed level of Medicare and Medicaid reductions; and on the lack of a timetable for folding Medicare recipients into the overall plan. We have a serious question about how reform would be financed. We believe that any global budget for health care spending should be based on people's actual health needs, not an abstract, mechanical formula.

Where do we end up when hospitals balance our support vs. our reservations? In the final analysis, there is far more common ground than battleground here. We pledge, to all those who have a sincere interest in making the health care system work better, that hospitals are willing to work hard to achieve reform. We will strongly support the President where we can, and engage in honest and open dialogue to reach consensus on those areas of the President's reform plan with which we disagree. And we will work in exactly the same manner with Members of Congress, Republicans and Democrats, because that is the only way to reach our goal of comprehensive health care reform.

And comprehensive reform is what the American people are asking us to do. Even those with adequate care today understand tomorrow's health care uncertainties. To do nothing, or worse, to fall back on simplistic solutions that may look like reform

WASHINGTON, DC - Calling it a bold, visionary plan that addresses the fundamental problems of the nation's health care system, the American Nurses Association (ANA) today announced its strong support of the Clinton Administration's health care reform plan. ANA believes that consumers will benefit from the security of knowing they have access to comprehensive, quality health care services. The plan represents a major victory for registered nurses, who will play a larger role in the delivery of care, particularly preventive and primary health care.

"America's nurses believe that access to appropriate, quality, affordable health care is a right, not a privilege. The reforms proposed by the Clinton Administration are revolutionary in scope and demonstrate a commitment to fix a system that is broken," said ANA President Virginia Trotter Betts, JD, MSN, RN.

ANA, which has actively promoted mursing's reform plan, Nursing's Agenda for Health Care Reform since 1990, specifically praised the provisions of universal access, a mandated comprehensive benefits package, insurance reforms and recognition of advanced practice nurses and registered professional nurses as qualified providers for a commum of health care services.

"This plan puts a greater emphasis on maintaining health and wellness, concepts that are central to mursing," said Betts. "It means that consumers will have access to a variety of cost-effective providers and will be able to choose an advanced practice murse for care if they wish. It means that advanced practice nurses will be able to diagnose, treat and prescribe medications for everyday health care needs without unnecessary, costly oversight."

Currently, 100,000 advanced practice nurses provide primary health care services. The Clinton plan is calling for a new funding system to prepare more nurses as primary care providers to meet the demands of the new health care system. This special entitlement could be a mechanism similar to that for resident physicians.

ANA also supports the plan's approach to controlling the increase in health care costs, specifically through paperwork reduction, a crackdown on fraud and abuse, quality assurance initiatives and malpractice reforms. ANA supports provisions in the plan that empower consumers to be more active participants in health care decisions based on cost, quality and outcomes data as well as including consumers on key health care boards.

Overall, ANA believes the plan will greatly benefit consumers, especially children, the underserved, and the elderly. Consumers will have greater access to services that maintain and enhance their health and wellness provided by registered professional nurses in community locations, such as schools.

"This is a bold plan that puts consumers' needs first and foremost," said Betts. "The nation's nurses believe in President Climon's plan. We support its goals and we will continue to work hard so that health security for all Americans becomes a reality as quickly as possible."

ANA has committed its national grassroots lobbying system, Nurses Strategic Action Team (NSTAT) to promote health care reform at the local and state levels. NSTAT is comprised of thousands of murse volunteers who work to generate media, political and hometown support as well as lobby their federal senators and representatives.

AMVETS: Clinton Plan On Right Track

WASHINGTON, Sept. 20--Leaders of the nation's fourth largest veterans organization are encouraged by the Clinton administration's plan for reforming the VA medical system.

RESPONSE OF THE ARC TO PRESIDENT CLINTON'S HEALTH CARE REFORM PROPOSAL

The Arc strongly supports President Clinton's initiative in making reform of health and long term services a top priority for his Administration. We are pleased that for the first time an Administration is supporting comprehensive reform and is addressing many of the problems in the nation's current system which affect people with mental retardation and their families.

People with mental retardation and their families are among the most vulnerable in the current health care system. They have often lost or been refused adequate health coverage for themselves or their family members because of pre-existing conditions. In addition, people with mental retardation often must rely on long term services and supports, including personal assistance services, to maintain their independence and productivity in their communities.

The Arc measures all proposals for health care reform against a set of five principles from a disability perspective. These are: non-discrimination, comprehensiveness, appropriateness, equity, and efficiency. In many ways, the Clinton proposal measures up to these principles; particularly in the guarantees of universal coverage and elimination of pre-existing conditions.

In addition, the Clinton proposal includes important new initiatives in long term services and supports, creating new community based support services to serve people of all ages with the most severe disabilities who need long term support.

Together, these two new initiatives are an important step toward achieving independence, integration, and productivity for people with mental retardation and toward fulfilling the promise of the Americans with Disabilities Act. The Arc believes that President Clinton is proposing a system which will greatly improve health coverage for people with mental retardation and their families. The proposal lays a foundation for a universal system in which everyone will have access to comprehensive health care regardless of age, income, or health status and people will have improved access to long term supports necessary as a result of their disabilities or age.

The Arc recognizes the complexity of the task before the Administration and the Congress. We are strongly committed to working with them to address areas of specific concern and to assure that the final act encompasses the best plan possible. We oppose efforts to maintain the status quo in the health care system or to enact only incremental or marginal reforms. We look forward to working with the President and the Congress in this historic effort to enact comprehensive, universal health care coverage for all Americans and to take a major step toward comprehensive long term services for people with mental retardation and other disabilities.

The Arc is marking its 43rd year of nationwide service to people with mental retardation. Together the more than 1,200 state and local chapters of The Arc across the country form the largest voluntary organization in the United States devoted solely to the welfare of the more than seven million people with mental retardation and their families and to the prevention of this condition for future generations.



CHILDREN'S DEFENSE FUND APPLAUDS HEALTH CARE REFORM PLAN

WASHINGTON, D.C. - The Administration's national health reform plan contains historic gains for children, according to the Children's Defense Fund (CDF), which applauded the plan's commitment to end the nightmare of insecurity that millions of parents feel when their children get sick.

According to CDF, the plan gives health coverage to nearly nine million children who are currently uninsured and dams the flood of millions of children who lose employer-based insurance at some point every year.

"Finally, we have a viable plan to reorganize the health system that would guarantee every American child a healthy start in life -- a guarantee every other industrialized nation already provides," said CDF President Marian Wright Edelman. "American children deserve no less than universal coverage, emphasis on preventive care, and a broad range of benefits."

The plan guarantees that lack of insurance, exclusion of pre-existing conditions, and soaring health care costs will no longer be barriers to children getting quality health care.

"For the first time, parents will be able to make decisions about their jobs based on their families' needs rather than on a child's pre-existing medical condition." Edelman said.

CDF said that, in the long run, the cost-control provisions and universal coverage provided in the President's plan will help families economically, as well as lower health costs making it more possible to reverse the wage erosion of recent years which particularly hurt younger workers with families.

The plan is not perfect, CDF said, and several improvements are needed including: making premiums and out-of-pocket costs more affordable for the working poor and near-poor; ensuring that low-and moderate-income children, including children on Medicaid, have access to the same plans and services as other families; and safeguarding essential services for children with disabilities.

CDF further noted that the benefits of the plan greatly outweigh the shortcomings and that the organization will work tirclessly with the Administration and Congress to improve and enact legislation that assures every American family has access to affordable, quality health care.

Citizen Action Praises President's Leadership on Health Care Reform Calls on Congress to Support Single-Payer System

Washington: Citizen Action, the nation's largest consumer organization, today praised President Bill Clinton for taking the bold step of proclaiming that health care will be a right for every American by 1997 and for basing his plan on the principles of universal access, cost containment and comprehensive benefits.

"President Clinton's plan sets a standard that the opponents of comprehensive, affordable health care for all Americans cannot meet, but which the proponents of a single payer system can certainly improve upon," said Ira Arlook, Citizen Action Executive Director.

"Now the battle must be to translate those principles into access for every American to quality, affordable care irrespective of income, status, employment or geographic location," said Arlook.

"While the President's initiative is a major step forward, Citizen Action will continue to fight for the American Health Security Act (H.R. 1200 and S. 491) – a single-payer system that the Congressional Budget Office concludes will provide the most benefits at the lowest cost," said Arlook.

"We are very pleased that the President's plan recognizes the benefits of a single-payer system and will allow states to choose single-payer as an option for their residents," said Arlook.

"While the American Health Security Act and President Clinton's plan share the principles of universality, comprehensive benefits, cost control and public accountability, we will call on our members and citizens all over the country to tell Congress that a single-payer system must be the ultimate goal of health care reform ," said Arlook. The Clinton plan falls short of the American Health Security Act in that it:

- Discriminates by income level in the quality of care provided
- Does not provide enough cost savings
- Is not fairly funded, because it relies on flat premiums and consumer excise taxes

"We recognize that in the months ahead the special interests – the insurance industry, drug companies and others – will use their political muscle to protect their turf. They will mount expensive, misleading campaigns to attack the bedrock principles upon which both the President's plan and the American Health Security Act are based. We are announcing today an all out effort to combat those special interests and their friends in Congress, so that all Americans can have a safe, secure, reliable, responsible and affordable health care system," said Arlook.

"We will tell American voters how the plan proposed by the Senate and House Republicans falls woefully short of what is needed. The Republican solution is to require every American to purchase health insurance, even if they cannot afford it. And if individuals or families fail to buy insurance, but need health care, the supposed anti-Big Government party would have the IRS swoop down to punish any offenders. Even though the failure of exclusive reliance on the market is the primary cause of our present health care disaster, the Republican Party prescribes more of the same. That's like a doctor telling a patient with cirrhosis of the liver, to increase his intake of alcohol. Republican Party snake oil may make some people feel better, but it won't cure their diseases," said Arlook.

CONSORTIUM FOR CITIZENS WITH DISABILITIES RESPONSE TO PRESIDENT CLINTON'S HEALTH CARE REFORM PROPOSAL

The Consortium for Citizens with Disabilities (CCD) strongly supports President Clinton's initiative in making health care reform a top priority for his Administration. We are pleased that for the first time an Administration is supporting comprehensive reform and has offered a proposal that finally addresses many of the problems in our current system.

The CCD is a Washington-based coalition of over 100 national organizations concerned with disability policy, which advocates on behalf of people with disabilities. CCD member groups represent people with physical, mental, cognitive, and sensory disabilities and people with chronic, disabling illnesses. These individuals and their families are the most vulnerable in the present health care system. They have often been refused health insurance because of preexisting conditions; have had to accept inadequate coverage; and have been most threatened by loss of coverage. Therefore, health care reform that will provide universal, comprehensive, and affordable health care to all Americans regardless of their health or disability status is a major priority of the Consortium.

The CCD measures all reform proposals against five principles for health care reform from the disability perspective. These are non-discrimination, comprehensiveness, appropriateness, equity, and efficiency. In many ways, the President's proposal measures up to the CCD principles. For example, the guarantee that no one will be denied health insurance for any reason and the elimination of pre-existing condition exclusions will mean than many people with disabilities will finally have access to health care services.

Further, we are pleased that the proposal includes important new initiatives in the area of long term services and supports, including personal assistance services. Taken together with the acute health care reforms, these new initiatives are a critical step toward achieving independence, integration, and productivity for millions of Americans with disabilities and fulfilling the promise of the Americans with Disabilities Act.

We strongly believe that President Clinton is proposing a system that would be a major improvement over what exists today. He is attempting to lay the groundwork for a universal system under which every American will have access to comprehensive health care regardless of their age, income or health status. As you prepare to formally announce the details of your health care reform plan, I wish to express my support for the significant initiatives you have taken on this subject. I compliment you for having the political courage to face up to the serious economic and social problems currently before us, the fortitude to pursue your goals forthrightly, and the determination to move effective plans through Congress.

As I indicated to you in our luncheon conversation on June 16, and in my previous letters of July 31 and September 10, health care issues have been a subject of serious study and deep concern within our company for the past 10 years. This is an absolutely essential feature in order to contain costs.

2. <u>Universal coverage</u>. Every American should have access to health care, and your system steadfastly provides for this. This is an excellent goal unto itself, and one that has been badly needed. But this general provision also will have a

While recognizing that there are concerns that the plan does not currently address, we believe that the sort of system that President Clinton is proposing would be a significant improvement over the status quo, and one that would improve access for those who are most in need of services, people with dicabilitics and chronic health conditions.

benefit on the cost-containment side. Your plan requires every employer who is able to pay for his or her employees' health care plan to do so. Such costs, therefore, cannot be shifted to others. The load is fairly distributed. This will prove to be a pivotal element in the ability to hold down health care costs for all. Also, your approach to the problems of small business is fair and equitable.

There are many other features of the plan that I strongly applaud, such as the reduction of red tape in claims processing, the effort to cut down on duplication and outright fraud in prescribing and billing for services, and the need to address malpractice and related litigation issues. This is a complex proposal and I'm certain there will be other provisions we will endorse as equally useful. If I fault your plan at all it would be in the area of litigation cost containment, and disciplining of the trial lawyers. They are abusing American society as much as the health industry, and this is a good time to bring this part of the abuse to rest. Please do this.

I applaud the members of the commission headed by Mrs. Clinton for their work. They have done a masterful job of putting together a package to address this most difficult problem that has grown, largely without restraint, for many years. It is my hope that the members of your administration will have frequent, ongoing contact on this subject with business leaders, who -- together with the government and its taxpayers -- are responsible for paying the bill for all health care in America.

Some have criticized this effort as bringing too much government into the free market system. The health industry has no free market. Involvement of government in the manner you propose works to establish a free market and therefore allows market forces to work -- market forces that have been absent in the past.

As I have stated previously, I am seriously interested in solutions to our nation's health care dilemma. If I can assist you in any way, please call on me. I congratulate you on the progress made thus far, and encourage your continued strong support of health care reform, cost containment, and quality health delivery.

STATEMENT BY PAMELA G. BAILEY I ILC MEDIA BRIEFING September 22, 1993, 10:00 a.m.

Good Morning. My name is Pam Bailey, and I am President of the Healthcare Leadership Council. I appreciate your coming this morning.

For those of you who may not know us, the HLC is a group of some 50 leaders in the health care industry. Hospitals, managed care insurance, pharmaceutical, technology, and physician/nurse sectors make up the Council. The Council originated nearly 5 years ago from discussions among its founding members after the 1988 Presidential election. They realized then a crisis was facing our health care system, that as a nation we weren't prepared to face up to that crisis - and that as leaders in the industry they had a responsibility to provide leadership toward reform. And so, the Council was created with the sole purpose of developing and advocating action on consensus solutions to health care.

Today, we applaud President Clinton's commitment to health care reform and his efforts to initiate a national discussion about reform. The very nature of that discussion demonstrates much progress has been achieved since the Council's creation. Unlike 5 years ago the debate this year is no longer over the need for reform, or even the goals. On both these points all Americans agree. Rather, the debate will now focus on how to achieve our shared vision without compromising the quality, choice and innovation that characterizes our nation's health care system at its best.

What has also changed in the past 5 years has been the delivery system itself – led in many cases by HCL members. Whether it's consolidation of hospitals and the creation of doctor and hospital networks, the targeting of R & D and manufacturing on new cost-effective technology, or the recognition by our insurance members that the tuture for them was <u>not</u> to merely process claims or manage risk, but to mange <u>health</u> <u>care</u> - our members have been in the forefront of the merket place revolution that is now the halimark of the best of American health care.

Let me make it clear. These industry leaders and their companies and institutions are not protectors of the status quo. They are the opposite. They are the risk takers, the ones who welcome and seek change. In fact, one of our most serious concerns about the Administration's plan, as it has been described so far, is the extent to which government would intrude in the market place revolution, using price controls and regulations to turn back the clock and stille innovation - dealing competition a crippiling blow by freezing in place the status quo.

The Healthcare Leadership Council applauds President Clinton's commitment to comprehensive reform and believes the announcement of the Clinton Pian is the start of a long national discussion on health care reform.

Much progress has been achieved since the members of the Healthcare Leadership Council first joined together to fight for reform nearly five years ago. As a result, the 1993 debate will not be over the need for reform, or even the goals. On both these points all Americans agree. Rather, the debate will now focus on how to achieve our shared vision - without compromising the quality, choice, and innovation that characterizes our nation's health care system at its best.

The President has laid down the right criteria by which to judge any reform plan - simplicity, savings, security and quality. To these we would add a fifth important measure -- whether the plan would allow the radical reforms that are taking place now in local delivery systems to continue, or whether it would stop at the status quo.

In the ensuing debate we must be honest with ourselves about what we know will work, what is just theory, and what we know won't work. Among the questions Americans must ask is how secure will the quality of their families' health care be if the federal government:

takes control of a \$900 billion sector of the economy?

belances that \$900 billion budget with price controls?

funds the new system with mandatory payroll assessments?

simultaneously outs \$238 billion from Medicare and Medicaid over the next five years?

How secure and simple, we must ask ourselves, is a system that requires virtually all employers to disband their current employee nealth plans and send their employees to a government agency to choose coverage?

The worst outcome of this debate would be to lose sight of those significant points on which there is broad agreement. We call on the President to give all Americans immediate relief from fear of job lock, pre-existing conditions and cancellation of coverage by putting these consensus clements of his plan on a bipartisan fast legislative track.

Clinton Health Reform Proposal Promises Community Rehabilitation Programs for People with Serious Mental Illnesses

The Clinton Administration's Health Care Reform proposal will, for the first time, make psychiatric rehabilitation and mental health services available to millions of people with mental illnesses. The plan takes steps to end a history of neglect and gross underfunding of essential health care services for people with serious and persistent mental illnesses such as schizophrenia, major depression and manic depressive disorder. The International Association of Psychosocial Rehabilitation Services, an organization representing over 1600 providers and practitioners of rehabilitation services for people with serious mental illnesses, supports President Clinton's health care reform proposal. Not only does the proposal introduce universal coverage, portability of benefits, and elimination of exclusions based on preexisting conditions, but it offers all Americans access to a broad range of mental health benefits.

People with severe and persistent mental illnesses experience functional impairments that diminish a person's ability to live independently and sustain interpersonal relationships with family, friends and co-workers. Cognitive deficits result in difficulties in thinking through and planning tasks, or making decisions. The goal of psychiatric rehabilitation is to restore the person's ability for independent living, socialization and effective life management through an experiential learning process in the community.

The Administration's proposal requires all regional health alliances include community based psychiatric rehabilitation services for individuals with serious mental illnesses in their standard benefits package.

Agencies that provide psychiatric rehabilitation reinforce national efforts to reduce health care costs while providing quality care. These community based services have proven results reducing costly inpatient hospitalizations, while introducing coping strategies for symptom management, and teaching people skills that promote independence.

Although the Administration has introduced a comprehensive mental health benefits package, the proposal contains significant limits for mental health services until the year 2001, which exceed those limits placed on services for physical illnesses. People with severe and persistent mental illnesses and children will be particularly affected by these arbitrary limits.

We are pleased that the Administration has promised to eliminate discriminatory portions of the benefit package by the year 2001. A promise however is not a guarantee. Congress must pass health care reform that legislates these historic changes, assuring all Americans that non discriminatory coverage and medically necessary care for mental and physical illnesses becomes a reality.

Alex, from People Encouraging People -- an agency in Baltimore, Maryland, has generously allowed IAPSRS to share his story with you and members of the press. Dimitrios Cavathas, a PEP staff person has provided us assistance.

Alex's Story

My name is Alex and I am a person afflicted with a mental illness. I am diagnosed as having paranoid schizophrenia. I would like to tell you a little bit about myself so that people can understand what people like me go through. Growing up, I had experiences of hearing voices. My teachers at school would tell me not to listen to the voices and not worry about people's thoughts. They said this would lead up to a lot of trouble in the future if I did not try to deal with this; they were right. There was no reason why these voices and thoughts started happening, they just did. Instead of going to school, I spent a lot of times in hospitals. I have had more than four hospitalizations that lasted a while. It was definitely not fun. I was even overmedicated onetime and I was like a vegetable. Even though I had all these problems, I still got my diploma in Connecticut. Finally at age 25, I am on my way to becoming more independent and being part of the community. I owe much of this progress to the psychiatric rehabilitation program that I attend, People Encouraging People. To understand what a community rehabilitation program does, let me tell you about PEP.

PEP is Maryland's largest psychiatric rehabilitation program for persons with mental illness. The participants range from 18 through senior citizenship. The consumers can access an array of services and opportunities which include: independent living skills, case management, community housing, education, job training and placement and transportation training. The program is divide into three departments. They are the Departments of Rehabilitation Services, Vocational Services, and Residential Services. Together they comprise a comprehensive program that is designed to restore or discover each individual's sense of self-value and involvement in everyday situations. By promoting self-awareness, PEP is able to assist our clients with taking control of their own health, appearance, diet and social well-being.

PEP is an outstanding example of the accomplishments that can come out of the public and private sectors working together. It is a program which works in collaboration with Baltimore Mental Health Systems, Inc. Sinai Hospital Lead Agency Consortium. This arrangement is not only more economical than the state hospitals, it is also more productive for people like me. When I was in the hospital, it was like I was dead. There was nothing to do. However when I came to PEP, I learned how to be productive and I was treated like a human being.

Involvement in a psychiatric rehabilitation program does many things for me. Case management assists me in getting my medication and keeping my appointments with the doctor. They help me with entitlements and any legal or technical problems that I have. For example, they assisted me to register to vote and help me to understand my medical bills. They help me communicate with other agencies if I need to.

The Young Adult Group that I attend helps me get back on my feet and into the community. The Young Adult Counselor helps me learn how to deal with people and talk to others better. My counselor helps me learn how to look at businesses and how to behave while working. He also teaches me how to use the public transportation system so I can get around. I also learn how to budget my money and pay bills. The Vocational Counselor helps me get a job and teaches me how to fill out an application and how to act in an interview.

PEP has also helped me get out of the hospital, out of my house, and become more independent. I learn how to live on my own. If it wasn't for programs like PEP, I would probably still be in the hospital instead of living in the community.

I am so happy now that I can act like a real person instead of a vegetable in the hospital. I now have a volunteer job at a hospital as an orderly. I am doing very well and it feels great to be working. I hope in the near future that I will get a paying job. I have been on clozaril* for a while which has really helped me out. I really feel that I am getting my life in order. The hospital never helped me become a real person, a person who is normal and lives and acts normal. PEP has helped me be like everyone else; normal. The government should give money to places like PEP so other people like me can get help and live a normal life.

* Clozaril is a psychotropic medication.

Statement by Becky Cain, President The League of Women Voters of the United States

The President's health care reform package marks a critical step forward. It will fix fundamental flaws in our nation's health care system.

This is real reform. The plan provides for universal access and for stringent cost control measures -- the two most important criteria set forth by League members after more than three years of studying the health care crisis.


Under the plan, Americans will be covered no matter where they live, where they work or how much they earn. The plan's basic benefits package will be a boon to people's health, especially for women. For the first time, all Americans will be guaranteed coverage for preventive, primary and acute care; and reproductive health services, including abortion, are in the plan. Mental health services and long-term care are also included, but are limited to keep costs down.

Among the plan's most critical features are its built-in cost control mechanisms. Millions of Americans are losing the battle to keep up with rising health care costs and millions more cannot even afford the most basic health care coverage. Health care costs have doubled since 1980 and will double again by the year 2000 unless strong action is taken. By standardizing forms, introducing new competitive structures and limiting spending, the plan has effective ways of cutting waste and reducing costs.

The President's health care plan is not perfect, but it is fair. It will need some fine-tuning in the legislative process. For example, citizen participation must be included in all aspects of the plan's implementation to ensure that government-sponsored programs are responsive to citizens' needs.

Health care reform will need bipartisan support. The League is encouraged that many of the goals for reform are now shared by key members of both political parties on Capitol Hill. Congress must not lose sight of the costs of inaction on this critical issue. There will be no perfect solution to this crisis. We need a viable plan that gives all Americans a more humane health care system. The President's plan is an effective blueprint for reform.

The new "personal assistance services" benefit will make a major difference in the ability of people of all ages with severe disabilities and chronic illness to remain in the community, take jobs, and maintain their independence.

The President's plan would provide security for the average American, because hardworking families and retiring seniors will no longer have to impoverish themselves before they can get help, as they must under the present system. Instead, the home and community-based services will be available to all based on their physical and cognitive need.

"Importantly, the President's proposal will provide America's families with choices they don't have under our current system. It will provide the option to receive care where people most want to receive it, at home and in the community," said AARP's John Rother, also a Campaign Board member. "People will no longer have to feel that going into a nursing home is the only choice they have."

"In addition, this proposal would begin to support family members, most of whom are women, who now provide the bulk of care," said the Older Women's League's Joan Kuriansky, another Campaign Board member.

The proposal also contains necessary built-in cost containment mechanisms to prevent costs from spiraling out of control.

Thirty-Eight Mental Health Organizations React To Clinton Health Reform Proposal

Millions of people suffering from mental illnesses will for the first time have access to health care under the historic reforms proposed by the Clinton Administration — including universal coverage, portability of bonofits and elimination of exclusions based on preexisting conditions. Thirty-eight (38) members of the Mental Health Llaison Group commend the Administration for focusing public attention on the needs of Americans with mental illnesses and on the destructive impact of mental illnesses as a major public health problem.

We are pleased that the Administration has promised to eliminate discriminatory limits on the mental health benefit by the year 2001, but a promise is not a guarantee. The current proposal is an important first step. Even so, the proposed initial benefit contains significant limits on needed services for individuals with mental illnesses who require more intensive paychotherapy, community sorvices or hospital care, and it fails to meet the special needs of children. The Mental Health Llaison Group and its members will continue to support nondiscriminatory coverage of all medically and psychologically necessary care until the promise of comprehensive benefits is realized.

For too long society has failed to recognize the reality of mental illnesses and the suffering they cause. Mental health care must be provided on a par with that available for other illnesses. Accordingly, we are concerned with any cost-sharing requirements that may be so excessive as to place the benefit outside the financial means of many Americans. Mental health care is a controllable and cost-effective benefit that can lead to significant national savings in overall health care costs and will reduce losses to the economy due to absenteelsm, impaired productivity and death.

We commend the Administration for initiating healthcare reform and offer our assistance to the Administration and Congress in the months to come.

The Mental Health Liaison Group is a Washington, DC-based coalition of national organizations representing consumers, family members, advocates, professionals and providers.



Statement of Larry S. Gage, President National Association of Public Hospitals on the Introduction of President Clinton's Health Plan

Washington, D.C. – President Bill Clinton has today offered Americans our best opportunity in over half a century to join the family of civilized nations that make adequate health care a basic right of citizenship. NAPH strongly supports President Clinton in this historic effort and will work with him to achieve enactment of health reform as swiftly as possible. We simply cannot afford to let this opportunity slip away, like so many others in the last 50 years.

NAPH member hospitals, together with a fragile network of health centers and other public health providers are today the providers of last resort for the uninsured and under insured in most metropolitan areas. In effect, our members have served for years as an institutional "national health plan" in the absence of universal insurance coverage. In many cases, they provide the <u>only</u> health services for low income urban residents, regardless of whether or not they have coverage. At the same time, these providers train a substantial number of our nation's doctors, nurses, and other health professionals, and often serve as the only provider of many costly, specialized services, such as trauma care, burn care, neo-natal intensive care, high risk pregnancy services, and emergency psychiatric care.

It is important to point out that the situation of these safety net providers continues to worsen. The nation's urban public hospitals continue to be burdened by multiple crises — including persistent state and local budget shortfalls — escalating federal and state curbs on Medicaid eligibility and spending — continuing increases in the number of uninsured and under- insured — and an increasing inability or unwillingness of many providers to shift uncompensated costs to privately insured patients. For all of these reasons, enacument of health reform must now be our most important domestic policy priority.

NAPH believes that President Clinton's proposal is an outstanding foundation for achieving health reform. There is much to admire in the President's plan, including its commitment to universal and mandatory coverage -- its commitment to prevention and primary care in the context of a generous uniform benefit package — its proposal to community rate premiums for all, as well as to adjust premiums to reflect such factors as health and income status — its willingness to subsidize premiums for low income individuals and small businesses — its attention to the special access and infrastructure needs of underserved areas and academic health centers — to name just a few.

Of course, NAPH (like others) will want to raise a number of specific issues and questions during the forthcoming debate. Based on our preliminary reading of the President's plan, those issues and concerns will include the suitability of "managed competition" in the near term for some undeserved urban and rural areas — the treatment of populations excluded under the plan, such as undocumented immigrants and prisoners — the proposed elimination of Medicare and Medicaid disproportionate share hospital adjustments, which finance a broad range of essential services, including many that are not proposed as part of the benefit package — and concerns regarding the scope and level of support of proposed initiatives for "essential access providers", infrastructure improvement, public health, health manpower, and academic health centers.

However, we wish to make crystal clear that we will be raising these questions and issues from a position of support and encouragement, not opposition or obstruction, and NAPH's goal, like to President's, will be the earliest possible enactment of comprehensive national health reform.

STATEMENT OF MARCIA GREENBERGER AND NANCY DUFF CAMPBELL. CO-PRESIDENTS OF THE NATIONAL WOMEN'S LAW CENTER. IN SUPPORT OF PRESIDENT CLINTON'S HEALTH REFORM PLAN

For decades, the health needs of women in the United States have been underfunded, overlooked and cut out of key health programs. Correcting these inequities is long overdue. President Clinton's health reform plan can make comprehensive health care a reality for all American women.

President Clinton's health care plan contains critical improvements in health care for women. All women, regardless of age, economic or health status, will have access to health insurance. Whether a woman is employed, where she is employed, or the size of her employer will not dictate her eligibility for insurance. And changing jobs will no longer put women at risk of losing their insurance.

The benefits package is important for women as well. It guarantees preventive health services that run the gamut from routine checkups for pregnant women to diagnostic and screening services such as mammography and pap smears. It also provides reproductive health care, including family planning, abortion and maternity services.

The Center supports the plan, and is committed to working through the legislative process to build on its important principles. Part-time workers, nearly two-thirds of whom are women, need greater protection; long-term care services should be broadened; and key diagnostic and screening services like pap smears and mammograms must be provided at more frequent intervals as recommended by lead professional groups. The waiting time for some important scrvices like comprehensive mental health coverage is too long. No one should have to wait until the year 2000 for critical care she sorely needs today. And subsidies for low-income women must be expanded to assure that no woman currently receiving government assistance for health care loses that help.

And, of critical importance to women nationwide, the Administration must make it clear that "pregnancy-related services" is defined as including both maternity care and termination of pregnancy.

Women need to fight not only to retain the sorely-needed improvements to their health care that are already in this plan, but also to expand the plan to improve upon it.

Women have too much at stake here to allow politics to invade the doctor's office. We will fight to make comprehensive health care a reality for all women by supporting President Clinton's plan and by building on its key principles.



NATIONAL SENIOR GROUP APPLAUDS CLINTON HEALTH PROPOSALS AND CALLS FOR FURTHER IMPROVEMENTS

In a policy statement to its 5,000 local club leaders, the National Council of Senior Cilizens (NCSC) said today that the Clinton health reform proposal would "establish health care as an achievable right for all citizens—that alone deserves the proise of Americans, young and old."

The statement, made by NCSC Executive Director Lawrence T. Smedley, noted that the Clinton proposal would assure comprehensive health services while creating mechanisms to control health costs. The senior leader said that the proposed Clinton program "can meet many of the benchmarks contained in the single-payer, universal health system backed by the Council."

Smedley hailed the Clinton proposal's inclusion of long-term care service and a new prescription drug benefit for Medicare beneficiaries, including younger persons with disabilities. He said that the Council also welcomes coverage of "early" retirees, age 55-65, many of whom have lost health insurance protection when their former employers terminated benefits.

Smedley told the grassroots NCSC leaders that, "Our ultimate goal is quality health services provided without regard to age or employment status at affordable costs based on the ability to pay through progressive financing. In short, we are committed to a national health system managed in the public interest without regard to profits or differing standards based on income, age, location or population group."

Smedley said that NCSC had adopted a three-point strategy on health care reform:

1. Support the Clinton measure's progressive, basic components including universal coverage, cost constraints and subsidized insurance for lower income, unemployed and refred persons;

2. Assure that any Medicare and Medicaid cost reductions will not harm older and disabled persons and the poor and assure prompt incorporation of Medicare into the new health reform system with full participation on an equal footing for Medicare beneficiaries; and

3. Continue to work for additional improvements in the design and financing of the nation's health care programs toward a single-payer system.

Smedley said that NCSC would fight against "those with a vested interest in the status guo—a health system based on waste and duplication that shortchanges seniors, punishes the poor and hard-working femilies and threatens to bankrupt the nation." Smedley said the Executive Board of the NCSC will be meeting in coming weeks to determine the game plan the Council will pursue in the ongoing struggle to improve and pass national health care.

The NCSC Director concluded his statement by saying: "The American people deserve an efficient health care system administered with a commitment to quality and compassion. The National Council believes that strong support of the Clinton program while working toward further improvements will lead the Nation to such a system. America's seniors are anxious to play a central role in the coming legislative and political debate. We are rearly." The Power To Overcome

Today, the National Easter Seal Society announced its support for the initiative that President Clinton has taken on health care reform. The national society endorses the comprehensive approach and general direction of the Administration's proposal, and is pleased that the President is making health care reform the top legislative priority on his domestic agenda.

Since 1919. Easter Seals has championed the interests of people with disabilities through advocacy and service delivery. In our experience, people with disabilities and their families have faced inordinate difficulties in obtaining needed health care at a reasonable cost. We believe that the President, in seeking universal, comprehensive, and affordable health care for all Americans, will significantly enhance the health, productivity, and independence of the nation's 43 million citizens with disabilities.

We clearly share the goals of the Administration and, in collaboration with our affiliates across the country, will offer specific recommendations that we believe will enhance the President's proposal.

Their next option is to drop health care coverage for the family entirely or to exclude their child.

President Clinton, your plan will make health care available and affordable for this family and thousands like them. The importance of health care reform cannot be overemphasized. The health of our nation's people is at stake and the health of our nation's economy is at stake.

We are especially encouraged by the clear signs that Republican and Democratic leaders in Congress are intent on achieving reform, rather than succumbing to deadlock.

The Coalition believes that the President's strategy for reform would help Americans in three ways.

First, it would guarantee comprehensive health coverage to all Americans, not just the affluent or the fortunate. We believe that it makes sense to do that by building on one of the great strengths of the current system -- that most employers already help to finance health care coverage for their employees. And we believe that it makes sense to combine an employer obligation with an individual one. The assurance of health coverage should be both a shared and an individual responsibility.

Second, it would work to keep health care costs in line with economic growth, not at odds with it. The Coalition supports tough measures to control costs and curtail cost-shifting, including budget targets, rate-setting to contain spending in the fee-forservice segment of the health care system, and increased competition among health care plans.

And third, it includes tools to improve the quality of care that Americans receive -- and to help them choose among health care plans on the basis of value, not just cost.

The National Leadership Coalition has nearly one hundred organizational members -- companies in all sorts of industries, unions, consumer groups, and associations of health care providers.

(A list of our members is attached.) We have been working together for three and a half years to achieve thorough and effective reform of the health care system. We are a non-partisan group -- our honorary co-chairmen are former Presidents Jimmy Carter and Gerald R. Ford -- and we are committed to working with President Clinton, and with members of Congress in both parties, to secure reform.

We recognize, as the President clearly does, that the Administration's proposal will evolve as it moves through the legislative process. We expect to make suggestions along the way, to the Administration and to the Congress, as the details of reform are refined. We are concerned to make sure that cost controls are effective in the short term as well as the long run, that reform does not require too rapid a transformation of the health care delivery structure, and that the financing mechanisms relied on to fund reform are adequate to the needs.

Congress has an extraordinary opportunity to make life better for Americans -- and Americans aren't in the mood for excuses. Now that the President's plan is front and center, the supporters of reform need to reach to the right and the left to build support for effective measures.

Enclosed you will find our position paper titled "Puerto Rican Health Care Agenda" which outlines the most crucial issues to the Puerto Rican community. As American citizens, we support most of the issues included in the package. Based on an analysis of the Puerto Rican health care crisis, we decided to focus on the four following issues:

• There needs to be an increase in health professionals serving the inner cities. Health service providers also need to be culturally sensitive and linguistically capable of serving our community;

• The White House must continue to include Puerto Rican health and public policy professionals as program design and implementation strategies continue;

• While we are pleased that AIDS and substance abuse are listed as priorities under the proposal, a portion of the prevention, education and treatment programs should targeted to the Puerto Rican community, who suffer from both maladies at distressing levels;

• We are pleased that the residents of the island of Puerto Rico will be included in the plan. We trust, however, that you are committed to the premise that the program funding for the island, as well the quality of the services available to that community, will eventually reach parity to those in the mainland United States.

"OWL applauds the President's emphasis on long-term care, within homes and in community settings," said OWL Executive Director Joan Kuriansky. "This is a vital concern for women who both provide the bulk of family caregiving and are most likely to require such care as they age. Long-term care services in a full range of settings -- at home, in community care facilities and, when necessary, in institutions -- must be available under a comprehensive plan."

"We must ensure that state governments have adequate funds to offer a full array of long term care services," Kuriansky said. "At the same time, we will work with the Administration and Congress to avoid possibly excessive Medicare cuts -- which could lower the quality of care and limit the number of health care providers willing to serve Medicare patients."

Additional provisions of the President's proposal which OWL praised are:

- The coverage of preventive as well as acute care services.
- The assurance that consumers may choose their own health care providers.

Significantly expanded coverage of prescription drug costs.
"UWL's founders both died of breast cancer," Glasse stated.
"It is long past the time when Pap smears, mammograms and appropriate cancer treatments are unavailable to many older women.
We support cancer research and treatment schedules which provide to women adequate and appropriate care."

I appreciated the invitation to the White House for the September 20 breakfast briefing for physician leaders interested in and hopefully committed to health care reform. To be numbered among that group was an honor in itself, but to be there as history was very exciting for someone who has been advocating for reform for over a decade.

I have dedicated all of my years as a physician and administrator to the care of the indigent and uninsured. As the chief executive officer of Parkland Memorial Hospital, the principal teaching hospital of The University of Texas Southwestern Medical Center at Dallas, I pushed to create a series of neighborhood clinics that operate on the community oriented primary care model. This model will serve us well in the type of reform you envision. Such settings can also be used to train the primary care physicians so sorely needed as well. And on the other end of the spectrum, Parkland provides tertiary services for trauma, neonatal intensive care, burn, and other "safety net" services needed by all of our community. These resources are severely strapped because of indigent care and will need special attention even with universal coverage as part of the academic health center infrastructure. I was pleased to see such services addressed in your plan.

My tenure as CEO has labored through two Republican presidents. During that time I witnessed the dissolution of the public health infrastructure. Your report indicates that you understand that universal insurance won't mean universal access without serious attention being given to the public health infrastructure. The need goes beyond the classical public health services to the community health clinic networks and public teaching hospitals which have been at the front lines. Please help us integrate these resources into a dynamic and culturally competent delivery system to deal more effectively with the issues facing our nation's poor and minority residents. I sense that your heart is with us and that you have the courage of your convictions. That is so refreshing after such a drought.



Our country is at a moral crossroads and we must boldly and yet wisely move forward on a journey that emphasizes the value of every citizen in our society as fundamental and not further reducible in the debate.

The attributes I have been looking for in a health reform package are embedded in your plan. While I have to admit that I was for a simpler system and one with even stronger cost controls, your speech and Mrs. Clinton's speech along with the sage advice of Dr. Koop have convinced me that now is the time to move ahead and give this reform effort a chance.

Since this will be an interactive process at the local and state levels, I stand ready to assist you in bringing about the dialogue you desire in Texas. I always felt that if I put the patients first, the institution in which I worked would be well-served. I believe that is true also of health reform. If we put the patients and the citizens first and understand health in its broadest context, we all would have to agree that medical costs cannot continue to erode the dollars we need for education, crime control, economic opportunity development, and fair housing and other legitimate purposes of government. We need these other infrastructural elements to have a healthy society.

Thank you and Mrs. Clinton for addressing these issues so we can restore this country to greatness and more importantly, return to its values.

The Save Our Security (SOS) Coalition, comprising over 100 labor, aging, disability and religious organizations, applauds President Clinton's health care reform initiative.



Meeting in Washington yesterday, the Health Care Reform Committee of our Executive Board reviewed the Clinton plan. We like what we see and we are mobilizing our more than 1 million members in support of the President and comprehensive healthcare reform.

Bill Clinton is the first president since Harry Truman to stand up and say, "The time is now for comprehensive national health care reform and I have a plan." There was an unsuccessful attempt to include health care under the first Social Security proposals and President Truman presented a proposal to the Congress which was defeated. It was only in the 1960s that President Johnson gained enough support for passage of the Medicare and Medicaid legislation. President Nixon introduced a broader plan in the early 1970s but it went nowhere.

We will soon have an historic opportunity to guarantee access to basic health care at an affordable cost for all Americans. While the new plan expected to be announced soon by the Clinton Administration will not include everything we want, we believe it is the best that can be achieved at this time. We cannot risk total defeat in the quest for perfection. We urge every member of the Cooperative to do all you can to ensure that the new plan becomes the law of the land.

If this plan does not pass, there may not be a second chance for a very long time. Meanwhile, many of us will grow sicker and poorer while we wait for that next opportunity. Even those who have good health insurance themselves know of someone who has lost a job (and, therefore, insurance benefits), who has become uninsurable through disability, or a young person who cannot find a full-time job which includes health insurance, or someone who may face these risks in the near future.

It is gratifying to note that the extraordinary hospitality you and the President have shown the veterans organizations is withput parallel in recent memory. In this connection, it is hoped the demonstration of hubris by a representative of one of the veterans groups at last Saturday's meeting is not mistaken for a representation of ingratitude by all of the veterans groups.

Mrs. Clinton, even without having reviewed the important details of your plan, you may feel free to assume with considerable confidence that VVA is prepared to place the full weight of its advocacy efforts on Capitol Hill behind your plan. It may also interest you to know that unlike most of the other veterans groups, the availability of choices for VA-dependent veterans in selecting health providers, as your plan makes possible for the first time, is even more important to VVA than the maintenance alone of an independent VA health system.

As you prepare to formally announce the details of your health care reform plan, I wish to express my support for the significant initiatives you have taken on this subject. I compliment you for having the political courage to face up to the serious economic and social problems currently before us, the fortitude to pursue your goals forthrightly, and the determination to move effective plans through Congress.

As I indicated to you in our luncheon conversation on June 16, and in my previous letters of July 31 and September 10, health care issues have been a subject of serious study and deep concern within our company for the past 10 years. Given your plan, the means for applying adequate reform and delivering quality health care with cost containment can be put in place for all Americans.

My knowledge of your plan, at this time, is limited to various press reports that have appeared over the past few weeks. If they are accurate, however, two aspects of your plan strike at the heart of the current problems, and that I support enthusiastically. They are:

1. Cost sharing and deductibles. Each individual definitely must share at least a portion of the cost. In my July 31 letter to you, I spoke of the need for consequences for all. Your provision for reasonable deductibles, together with co-payments, will help to establish a sense of responsibility with the user of health services, and provide some financial consequences for his or her actions. This is an absolutely essential feature in order to contain costs.

2. Universal coverage. Every American should have access to health care, and your system steadfastly provides for this. This is an excellent goal unto itself, and one that has been badly needed. But this general provision also will have a

benefit on the cost-containment side. Your plan requires every employer who is able to pay for his or her employees' health care plan to do so. Such costs, therefore, cannot be shifted to others. The load is fairly distributed. This will prove to be a pivotal element in the ability to hold down health care costs for all. Also, your approach to the problems of small business is fair and equitable.

There are many other features of the plan that I strongly applaud, such as the reduction of red tape in claims processing, the effort to cut down on duplication and outright fraud in prescribing and billing for services, and the need to address malpractice and related litigation issues. This is a complex proposal and I'm certain there will be other provisions we will endorse as equally useful. If I fault your plan at all it would be in the area of litigation cost containment, and disciplining of the trial lawyers. They are abusing American society as much as the health industry, and this is a good time to bring this part of the abuse to rest. Please do this.

I applaud the members of the commission headed by Mrs. Clinton for their work. They have done a masterful job of putting together a package to address this most difficult problem that has grown, largely without restraint, for many years. It is my hope that the members of your administration will have frequent, ongoing contact on this subject with business leaders, who -- together with the government and its taxpayers -- are responsible for paying the bill for all health care in America.

Some have criticized this effort as bringing too much government into the free market system. The health industry has no free market. Involvement of government in the manner you propose works to establish a free market and therefore allows market forces to work -- market forces that have been absent in the past.

As I have stated previously, I am seriously interested in sclutions to our nation's health care dilemma. If I can assist you in any way, please call on me. I congratulate you on the progress made thus far, and encourage your continued strong support of health care reform, cost containment, and quality health delivery.

As a small business owner, I would like to express my support for your health care reform initiative. In my fifteen years as a business owner I have experienced most of the problems your plan addresses.

I strongly believe that a comprehensive employee health plan is a key tool in attracting and retaining high quality employees, because of that belief I have made the commitment to provide this coverage despite the direct business costs. Many of my colleagnes in the small business community also hold this belief but have insufficient leverage with insurers to regotiate a plan that is financially practicable. Your plan will give the small business the same clout in dealing with HMOs and insurers as the largest corporations

The current environment also penalizes small businesses attempting to provide quality health insurance for their employees in two ways. First, through limiting the percent of medical insurance that is tax deductible and, second, by allowing your competitors to opt not to provide coverage.

I am also beenly aware of the administrative burden the current health care system places on a small busimens. The current requirements of administering a health care plan detract from the time my limited administrative staff have to do their primary job - helping me run the business.
