You will be meeting tomorrow at 5:00 to develop the Health Care University (HCU) concept with Administration officials, Rep. Gephardt and his policy director Andy King, Chris Williams (Sen. Mitchell), and Debra Silimeo. Administration representatives may include Chris Jennings, Jeff Eller, Steve Ricchetti (White House Leg. Affairs), Melanne Verveer (First Lady's Deputy Chief of Staff), Jerry Klepner/Karen Pollitz/Steve Edelstein (HHS), and Bob Boorstin (Task Force Communications & Policy Coordinator).

Following are some of issues that could be raised at the meeting:

- \* Timing of HCU: Pre- or post-launch?
- \* Bipartisan? This question is especially important if the educational effort is pre-launch.
- \* Bicameral? If so, should the House and Senate effort be conducted jointly?
- \* Purpose of HCU: Is it primarily to present a rationale for the President's policy or is it more message-oriented (or both)?
- \* Who should coordinate and conduct the sessions? Administration representatives, academics/analysts (just supporters of the plan or do we want a range of opinions?), or both?
- \* Format: How long and balance between presentations and Q & A.
- \* Supporting materials and statistics: What kind of handouts and charts will be helpful, and will Administration have cost estimates that will break down amount individuals and businesses will spend relative to current system?
- \* What issues should be raised? The White House came up with 10 subjects for discussion (see attached draft list). Is this list appropriate and complete?

- \* Should we change the name? Mrs. Clinton was concerned that Members may find the name "HCU" patronizing. Is this a concern? If so, what are other possible names?
- \* Other educational efforts? Are other educational sessions necessary, especially for a smaller group of Democrats who can be called on to say positive things about the plan immediately post-launch?

As you know, Senator Daschle and Senator Rockefeller are scheduled to come in tomorrow morning to discuss health care reform communications strategy. Senator Rockefeller has asked to meet briefly with you -- outside the company of Senator Daschle -- and will arrive 15 minutes early in order to do so. (It is my sense that Senator Rockefeller would like this to be a very small meeting, with no or very few staff; I suggest that you ask all or most of us to wait outside while you have your conversation.)

Since you are already well prepared for the Rockefeller/Daschle meeting, I don't believe you need much in terms of a background memo. The goal of the meeting should be to give them assurances that we are following or planning to incorporate much of their very sound advice.

At the risk of stating the obvious, I would thank them for their deep commitment to doing all in their power to help us make sure the health reform effort is successful. Along these lines, you might want to thank them for hosting/attending today's DPC meeting; they both were extremely constructive and supportive. Senator Rockefeller, in particular, chastised his colleagues for their habit of ganging up on the President just because the media is doing it.

I would also ask them how we can best utilize their expertise in the future. Lastly, I would ask them to keep us advised of ongoing lobbying developments on the Hill against our work. In other words, ask them to continue to be our best eyes and ears on Capitol Hill...
