I think our top priority should be the TIMSS roundtable we discussed with Rahm yesterday (Christa -- Mike can fill you in). We should do it the week of the 16th. Our 2nd priority should be a <u>speech</u> to a legislature, probably Delaware. Mike, how long are they in session? Ideally, we could speak to that legislature on the 16th, and do the roundtable a few days later.

The BRT deal is fine but not that pressing. We should insist on child care in CT.

Mike, when can we announce all the details of our Zones proposal? That would be a good urban event sometime -- launching a national competition to end social promotion. (Why wait for it to pass?)

I agree that we should do the TIMSS event the week of the 16th.


With respect to the Delaware legislature, I need to hear back from Carper's folks. According to NCSL, the legislature is in session until June (though I know they split their session into 2 parts, with a several week break in between. I don't know the timing of the break yet, but will find that out this morning.)

I almost think it would be preferable to do the chief state school officers on the 16th; it would be a natural setting to release the state-by-state figures on class size, and it would avoid the downside of potentially undercutting Carper.

With respect to the business/transcript event--I don't think we need to do it right away, but it would be enormously helpful to be able to tell ACHIEVE and the other business groups that we will do it, and set a date for that. Getting that nailed down will make it much easier to work with them on other issues we care about. If we can get Gerstner to the TIMSS discussion, we might event want to announce it at that time.

With regard to the Zones proposal, ED is starting to draft that now, and it should not take very long. My meeting with Clay's staff was postponed until next Tuesday--that's a critical meeting because we will find out if Clay will introduce and champion this.

An ideal announcement event would be to go to an urban school that has been/is being turned around, talk about how we don't need to accept failing schools, announce the Zones initiative and challenge everybody to end social promotion. We are also close to having ED's report on turning around failing schools, in response to our earlier directive. This, no doubt, would be the item that gives the event all the flair it needs.

Subject: POTUS Education Events

Following is a list of education events that have been proposed. After today's Short Term Scheduling meeting, I think we need to prioritize which ones we want to fight for first to ensure they are scheduled, and we need to strategize what to do with the events we may not ever schedule - like the Chief State School Officers.

Specifically -- everyone really liked the idea of doing a Business Roundtable. The down side is that everyone had a different idea about it. Ann Lewis, Cheri Carter, and Jen Palmieri thought that it may be better to do the Business Roundtable event in Connecticut on March 10. Craig is checking to see if Dodd would want this. If not, Child Care is in good standing. ( I pushed to keep child care, so please let me know if you're more ambivalent.) Also, the CEOs may not be able to come on that date, so it may not be a real option. What do you all think?

In addition, there was talk of trying to combine some of our education proposals -- (like inviting in some of the Chief State School Officers to the Business Roundtable so that we don't have to meet with them as a separate event, or perhaps inviting the Teacher of the Year to a roundtable or Mayor's Conference.)

In short, I could use your help on identifying the minimum objectives for each of these events and the general priorities. Mike, do you have time tomorrow to sit down and talk about this? Let me know what works for you.

Here is a quick list of possible events and executive actions, that probably could be taken within the next few weeks. The stuff in italics are the things that I think we can most easily/quickly pull off.

## **Education Opportunity Zones**

- Release of ED "Failing Schools Report" -- in draft form now; could be ready in a few weeks
- "How to End Social Promotions Report" -- ED has agreed to do this, but needs to start
  working on; we could issue a directive to do this if necessary to show some immediate
  action.
- "How to Intervene With Low Performing Teachers" -- Haven't talked to ED yet, but could work on getting something started.
- POTUS Visit to Turn-Around School

#### **Class Size**

- Roundtable Discussion with teachers and parents about benefits of small classes
- Visit to Tennessee, Indiana, or Milwaukee schools where small classes have proven to be effective

## **National Tests**

- TIMSS 12th Grade Release--Feb. 24. The results will be terrible; POTUS could argue that 12th graders would do better if they had to take an 8th grade test. Could also anounce NSF/ED funds in budget (\$50 million) to improve math teaching and curriculum, and could draw in some business and engineering groups that are ready to get inolved with schools to improve math teaching and learning.



Your list of ideas is the longest. While you finish nailing down the urban proposal, I wish you would also think about what we should be asking for on:

- \* Training/Virtual university: Can we do anything specific to make the Romer Leavitt idea take off? E-rate for training?? A national (not federal) virtual university??
- \* Teachers: Maybe you and I should go see Chase and plead with him to develop a testing or tenure proposal that pushes the envelope. That would be good for him and good for us, if he's willing to go far enough.
- \* Charter school vouchers: You can't just giggle every time I bring this up. There must be something we can do to put the power of choice and competition into parents' hands, and stave off the rush to private vouchers. I still think a \$500-1000 voucher for kids of poor parents who want to start charter schools could work. Also, what if we said that from now on, all the federal \$ will follow the kid -- so that charters were sure to get their share of Title I, IDEA, Chapters alpha-to-omega, etc.? We need to figure something out on this -- we can't all move to Maryland.

Attached is a list of possible short-term education events, prepared for the 3:30 meeting that didn't happen today. Sylvia's office is in the process of trying to inconveniently reschedule for Monday.

#### DPC/NEC Short-Term Education Announcement Possibilities

**POTUS Radio Address on Education (10/18).** Attack extremists on Republican side who are blocking all of our efforts to help young kids learn to read, including America Reads and national reading tests (possibly coupled with an endorsement of bipartisan charter schools bill passed by House committee)

**POTUS Reading Announcement (10/21 or other).** POTUS announces that nearly 800 colleges (up from 165 in April), in all 50 States, have pledged to use work-study participants for tutoring as part of America Reads. Event could take place at an elementary school that is using work-study (and possibly also AmeriCorps) tutoring help. Release report with examples of activities going on *today* in every State (including AmeriCorps projects).

POTUS Meeting with Business Leaders (hi-tech and/or broader cross-section). President meets with 8-10 CEO's on national tests; pool spray at top of meeting, CEO's do stakeout after meeting, announcing the committment they made to POTUS to tell Congress to support the test.

**Tips on Tax Cuts for Education**. POTUS or VPOTUS releases guidance from the IRS on how to take advantage of the new HOPE Scholarship, Lifetime Learning Credit, and other tax cuts for college. [We will not know until Wednesday, October 15, whether the guidance will be ready in time to be released the following week].


Comprehensive School Reform and Dropout Prevention. Announce support for a bipartisan effort to adopt promising whole-school reforms (Obey-Porter have \$150 million in the appropriations bill). Also announce an "Action Plan" on Dropouts, particularly focusing on Hispanic Americans. Event could include school reformers from the New American Schools Development Corporation and other school reform assistance projects, as well as Hispanic Caucus members and others from the Hill.

Child Care Conference (10/23). Some emphasis on after-school programs

National Board for Professional Teaching Standards (10/24). Reception in Tent on South Lawn; POTUS/FLOTUS make brief remarks; we set up regional press for teachers from around the country.

If we want to save the report, we need to decide that quickly, because ED has USA Today scheduled to come in first thing tomorrow morning to leak it, and Tamara Henry knows generally what the report is about at this point. They think we could pull this back but we would owe her one at that point.

If we do save it, it might make sense to fill the "Education Week" hole by having Riley come over Monday and do the riff on GOP's against reading and tests that we had been planning for the VP -do it at the top of the McCurry briefing when he would have discussed the report. One possible problem with that is Riley currently has a request in for a meeting with Goodling, so it might be a little odd to jump on him just at the time when he was asking for a meeting (this is also a problem with the letter idea we discussed earlier) -- Riley's legislative shop is skittish about this.

A couple other possibilities for the message event (I'm checking with ED for other reports/grant announcements coming up):

- -- save the teaching grant that we plan to release on Friday (a little odd since lead institution is U MD, plus this is a good fit with National Board event)
- -- save Obey endorsement/play up New American schools (but not clear this is a good fit with school to be visited because targeted on low-income/failing schools).
- -- perhaps release math action strategy -- play up as response to TIMSS scores and findings of coursetaking study

It's too bad about school construction, because evidently Florida Republicans have passed legislation that redefines portable buildings as permanent, not temporary -- that's their "solution" to the school construction problem.

After our meeting yesterday with Erskine, it seems unlikely that we are going to be ready to endorse any kind of school construction proposal by 10/31 -- so I guess we need another message. Everyone should be aware, however, that the school is overcrowded with many students attending classes in

trailers, so school construction is likely to be raised as an issue whether we like it or not.

DPC/NEC -- if so, do you have other suggestions?

Here are the education events that were discussed at the meeting with Rahm. He is going to call another meeting for Wednesday to review where we are on these; by then, I will have a short memo with a brief blurb on each.

- 1. Aug. 30 Radio Address: release of NAEP long-term trend report. (I will discuss this with Ann)
- 2. Sept. 8 Test event: Exec. Order/Leg
- 3. Sept. 20 Charter Schools: In Bay Area, school visit (possibly ribbon cutting at new charter school; release of charter schools grants to states.
- 4. Sept. 26 Community College: Dallas or some other Texas site tbd with scheduling; demonstrate how HOPE has made community colleges virtually free, and release state-by-state analysis of community college tuition.

In addition to these, Ann Lewis noted that the COngressional Dems are talking about pushing early childhood, standards, and school construction during September--no details were provided.

NEC pushed for events in the Fall on America Reads and Professional Development/Computers. ? They didn't get very far, partly because all of September is booked, though Oct has possibilities.

One other note: Paul and Rahm view Charter Schools as, in part, a Clinton signature initiative (along the lines of community policing) and a response to the attacks we expect on Coverdell/vouchers in the next few months. I talked about the failing schools idea; Paul in particular loved it.

## **Education Event Possibilities for September**

## Sept. 8/9 event [White House?]

Reforming schools to reach high standards

- -- Announce support for new whole school reform grants to help schools adopt effective reform models and adopt best practices in readin and math, as well as become smaller schools within schools or/ whole school reform models (Obey \$)
- -- For the most troubled schools, new grants for districts to identify/fix them [Could also add]:
- -- For parents, teachers, businesses and communities that want to start new public schools, release new charter schools grants

## Sept. 18-20 event in CA

1. Release charter schools funds and discuss principles for effective charter schools; CA will be getting a getting a continuation grant; subject to more careful vetting, there are at least three possibilities for a site. The first is the International Studies Academy, a magnet school within the San Fransisco district that has converted to a charter. There are also two schools which we believe will open their doors this fall: The Leadership Academy

and the East Bay Conservation Corps. A new school would be a great place for

the President to make the point that there was only 1 charter school when he came into

office, but now there are over 500.

2. Announce new urban partnerships program under the Higher Ed Act reauthorization -- would

support the kinds of college/university--K-12 partnerships that the University of California

is starting to increase student preparedness for higher ed in response to affirmative action policies. Would need OMB sign-off to announce authorization levels. Good tie-in with

the race initiative.

3. Release technology innovation challenge grant funds -- CA to get 4 of the highly competitive grants [though none of the recipients will be in the San Fransisco areal.

#### Sept. 24-27 in Little Rock

1. Release math strategy -- Could do at a middle school in Little Rock or nearby

community. Arkansas has been making a big push on math and science, with substantial funding and support from NSF, over the past few years that can be traced back to Clinton's efforts to raise standards there.

- 2. Something on after-school (could highlight 21st C. Schools if get approps; could also visit PARK youth center run by former Green Bay Packer Keith Jackson).
- 2. Reading/literacy event highlighting effective local program (could highlight America Reads if get approps)

## Possible Education Events/Announcements

( Frem NEC)

## 21st Century Scholars (student aid promise and early intervention program)

Suggested date: First two weeks of September

Announcement: New program that promises at least \$21,000 in Federal student aid (over five years) to students at middle and junior high schools. (Since the promise is grants or loans, it could be offered universally rather than just to poor schools/students). Perhaps provide the promise in exchange for students pledging to stay in school, to stay off drugs, and to take high-skills, college-oriented classes. Challenge universities to partner with needy schools to establish mentoring and tutoring efforts to help poor students prepare for college. Establish grant program for university partnerships with the 2100 neediest schools. (To partially fund 2100 partnerships would cost at least \$315 million; to fund 2100 over five years -- 420 per year -- would cost at least \$63 million).

Messages: Student aid is there for those who want to go to college (if they take it upon themselves to get prepared). Universities have a responsibility to work with low-income students starting in middle school or earlier to help them prepare for college.

Note: The decision memo on this proposal still needs to go through the NEC review process.

## **HOPE Scholarships and Pell Grants**

These could be done together, except that September 26 is too late for item 2.

1. Community Colleges: Vital Role and State-by-State

Tentative date: September 26

Announcement: Release report showing (1) the role of community colleges in preparing Americans for tomorrow's workplace, and (2) how HOPE and Pell Grants help people pay for community college (with state-by-state break downs).

Messages: HOPE helps millions of Americans pay for education that is critical to them and to the economy.

## 2. Some Students Will Be Left Out if Congress Doesn't Act

Suggested Date: Early September

Announcement: A report documenting the 210,000 independent students who will be left out if Congress doesn't follow through with the promised expansion of the Pell Grant program. Strongly imply that leaving these students out could bring a veto of the Labor-HHS-Education appropriations bill.

Message: Congress needs to finish the job in September by providing for the promised increase in the Pell Grant program.

## **Adult and Family Literacy**

These could be combined:

## 1. America Reads/Parents-as-First-Teachers

Suggested Date: Late August or early to mid September

Announcement: Regulatory action to waive the required local match for workstudy tutoring of parents, to promote participation in programs like HIPPY (which work with parents and children). (The waiver that the Secretary allowed last December applied only to tutoring of children, not their parents).

Message: Parents are critical to our efforts to improve children's reading skills. Congress must move forward with America Reads, including the Parents-as-First-Teachers program.

## 2. Literacy Needs in Every Community

Suggested Date: On or before September 8 (International Literacy Day)

Announcement: New study provides local estimates of adult literacy levels (at the city, county, and congressional district level). Call on States to do more to address the problem. Announce that the Education Department will develop guidelines, provide models, and will hold States to new levels of scrutiny under Goals 2000 (which calls for State plans to address the needs of people who had dropped out of school -- a provision which ED has not focused on in the past).

Message: States must do more to address the needs of those with low literacy levels and/or no high school diploma. Also could call on Congress to adopt the President's proposed increases in Adult Education funding (both committees straight-line the program).

## Action Plan on the Education of Hispanic Americans

Suggested date: Mid-September (Hispanic Heritage Week; Caucus Dinner)

Announcement: New report on Hispanic dropout problem. Administration response: 20-point Action plan. The plan could include the 21st Century Scholars and/or Adult and Family Literacy announcements above, as well as a PSA campaign, a conference, and other items.

Message: Educational needs of Hispanic Americans must be addressed in a serious and comprehensive way.

## 1. August 30th Radio Address: Release of NAEP Long-Term Trends Report

- Working to nail down delay in ED report release
- Next step: Conference call with Ann Lewis and David Frank

## 2. September 8: Testing Event

- Plans for event could be overtaken by floor votes on Labor-HHS-Appropriations (and Goodling amendment) as early as 9/2 in Senate and 9/4 in House
- Details to be determined as Congressional battle takes shape

#### 3. September 20: Charter Schools Event

- Visit to Bay Area charter school, announcement of \$40 million in new and continuing grants to states, and focus on growth in charter schools movement under Administration leadership (e.g.:from 1 when we took office to approximately 700 in the fall; from 1 state with charter school legislation to 30)
- 3 Bay Area schools identified as possible sites to date, search for additional sites will continue, and final pool determined; need further guidance from scheduling on geographic area we can work in.
- Developing plan to get a story in USA Today or NY Times before event.

## 4. September 26: Community Colleges/HOPE Scholarship Event

- Education Department working on report on how HOPE helps pay for community college, with (1) state-by-state table of community college tuition (2) information on eligibility and application process for HOPE and (3) brief discussion of role of community colleges in preparing people for new economy. Messages: Community colleges are the conveyer belt to the new economy, and HOPE makes attending community college affordable for all.
- Next step: identifying possible community colleges

#### Bruce and Elena

Here is a rough cut at what you need for today's meeting. Note that I haven't had a chance to connect the separate pieces here, so that we have a coherent package of policy announcement, events, and overall strategy.

On the other hand, we are making progress on battling the Goodling amendment on the test.

## 1. Education package for the fall

We've agreed to work with Congressional Democrats to develop a package of proposals that we can keep pushing throughout the fall. Among other things, I think we need to see this set as a way of promoting the standards/testing agenda to the public -- both with respect to demonstrating the steps we will take to help prepare kids to reach the standards, and the more general point that higher standards means better schools. Here's my preliminary list, based on our priorities as well as what we heard at our meeting last week:

- A Talented and Dedicated Teacher in Every Classroom. This would center on our new proposal to attract and prepare teachers for urban and poor rural areas. It can also incorporate our support for the National Board for Professional Teaching Standards, and any interest that might emerge on the Hill in training teachers to use proven and effective classroom practices.
- America Reads initiative. Even though its not new, I think we need to include this for several reasons. First, we still have to pass it, and the fall will be a critical time to push for it. Second, pushing the basic skills is good politics and good message.
- School Construction and Renovation. I think this one is obvious.
- Fixing Failing Schools. This initiative should challenge states and/or cities to fix failing schools by (1) requiring and helping them to implement effective practices; (2) close them down and reopen them, possibly as charter schools; (3) keeping schools open for after-school, weekends, and summer programs so kids can get the extra help they need to catch up. Obey has about \$150 million in the appropriations bill that focuses on implementing proven practices; we should be able to work with these funds to get something going.
- Early Childhood/Child Care/After-School. The House Dem's raised a range of issues here, from the quality of Head Start programs, to the benefits of helping local communities develop integrated and coherent approaches to meeting the needs of children and families, to helping suburban moms by providing a safe and supervised environment for pre-schoolers and elementary school kids while the moms are at work. We've got a fair amount to sort out on this before we proceed.
- Computers. Gene and Don Gipps both feel we need to move the technology initiative

into sharper relief; we are supposed to meet on this at some point in the near future.

• Overall Urban Education Initiative. Under development in ED, this would focus on standards, accountability (including dealing with failing schools), choice and charter schools, and improving the overall management of urban school systems.

## 2. Testing strategy

I think we will be in a better position develop a strategy for the next few months once we get past today's battle over the Goodling amendment, and once Riley gets back from NGA.

Nonetheless, it is likely that the following components will be folded into our strategy in some form: (1) awarding a contract within the next 6 weeks for the development of the tests; (2) creating an advisory/governing body in some fashion; (3) signing up more states and cities at some point; (4) having a fight with somebody over the tests--preferably in Alabama or some other state with a recalcitrant governor; possible in the Congress, and, hopefully not with our friends, such as the Black or Hispanic caucuses. In addition, we are likely to use the other K-12 issues we will focus on -- teaching, reading,

#### 3. Race Initiative

I've attached my latest set of issues we need to address in this context, mainly focused on urban education, and significantly overlapping with the list of issues above.

#### 4. Possible Events

Here's a pool of event possibilities, some of which connect with the lists above:

- Paying for Higher Education (best shot for August 15 event). This could be a victory lap on the higher education portion of the budget/tax package, which presumably will be signed about a week beforehand. We can release ED's handbook for parents on how to prepare your kid for college (including how to pay for it) and highlight the significant financial aid from the federal government. There are other pieces we could add to this as well, including possibly announcing additional pieces of the Higher Education Act that we will be transmitting in the near future.
- Charter Schools. ED will be ready to announce 14 new grantees -- 7 states and 7 individual charter schools that applied independently because their states did not, by mid-August. Probably by September we can add the states that will get continuation funding from previous grants.
- **Technology Grants**. ED will have Technology Innovation Challenge grants to announce mid-September
- PBS Town Hall Meeting on Education. To be broadcast in the last week of September/first week in October as the culmination of a 5-episode, 5-week series, this will focus on standards, urban education and charter schools.

- Reading Initiative. Sept. 8th is International Literacy Day. The President can address
  this in a Saturday radio address, highlighting the family literacy aspects of the America
  Reads proposal, and release the literacy council's report on state and local profiles of
  adult literacy.
- Interagency Math Strategy. Responding to the President's directive last Spring, we can announce a strategy for preparing kids for the math standards, including new national Board for Professional Teaching Standards certification for middle-school math teachers, a TIMSS resource kit for local educators, and a national conference focusing on strengthening middle school math.
- Urban Initiative/Urban Testing sign-up. In mid-October there will be a joint meeting of the U.S. Conference of Mayors and the Council of Great City Schools. This will be an opportunity to sign more cities up, and to announce our urban initiative


Elena--

Here are some ideas; please let me know if you are going to pass any of these along; as you will see, some of these I would rather have the POTUS do.

The Education Department and the National Institute for Literacy have both expressed interest in having the POTUS release some data on adult literacy rates (by state and congressional district) on National Literacy Day, which is Sept. 8. The Department has submitted a scheduling request for an event that would tie those data in to family literacy provisions in America Reads. Carolyn Staley at the National Institute for Literacy would like to try to use this to develop an additional component of America Reads that is explicitly focused on adult (rather than child literacy). I don't foresee that happening, but the data could still make either a decent POTUS radio address (on the Saturday just prior to Sept. 8, the last at Martha's vineyard) or for a VP event on Sept. 8. I don't really see this as "the" POTUS event for back to school week because it isn't K-12 focused enough, and the overall data on adult literacy has already been released, although not by subdivision.

In addition, at least a couple of the things I e-mailed you and Bruce about last night be appropriate if the POTUS doesn't do them, especially the grants announcements:

- 1. Announce \$40 million in **new charter schools grants** (Jon Schnur with OVP is very involved with charters so this would be easy for VP to do; however, I think it's really important for the President to do a charter event soon if we are going to get state legislatures going on this again, and for this event the news piece is easy).
- 2. Possibly announce technology literacy grants (still need to check on timing of this)
- 3. Release math strategy (addresses falloff in TIMSS scores after 4th grade) (but personally I would prefer for the POTUS to do this, in part because it has been developed in response to a POTUS directive and that has been the general expectation for the working group; moreover, this doesn't have to go out the week of Sept. 8; we have a lot of flexibility on when to release this)

4. Possibly announce technology literacy grants (need to check on timing of this)


Also, if the Millenium event softens up for August 15th, I think we could have a strong getting ready for college event (stronger than the radio address for the 16th) waiting in the wings:

Round-table discussion at WH (since schools mostly closed in summer) with middle school and high school students, parents, and teachers, perhaps also college admissions and financial aid officers, and high school guidance counselors.

August 21:Release of new school enrollment figures (Baby Boom Echo II)

Sec. Riley will release another report on the baby-boom echo indicating that the total number of young people going to school (K-12)), both public and private, has increased from 51.7 million to 52.2 million, another new national record. This report is a follow-up to last year's report which received significant national press attention and led to a host of state and local stories about over crowding in schools. This year we will give special attention to the fact that (1) the majority of students who make up the "baby boom echo" are in high school and what that means (2) and that school construction issue still remains a local crisis in many states.


August 28th: Long Term 1996 NAEP Trend Report

Mike Smith and Pat Forgione, Commissioner of the National Center of Education Statistics will release the long term 1996 NAEP Trend report in four subjects (math, science, reading and writing. The math and science trends are positive and confirm the recent TIMSS data. There is no significant change in reading scores but there is a decline in the writing scores. The report essentially states that there is no real significant change since the last long term repoet.

The report will note significant progress in science for blacks, that

many more females are taking tougher math courses, that TV watching is down and more young people are reading. There is some possibliity that we may try to move this August 25th and have the Secretary release the data but at this moment Mike and Pat get the lead.

Here are my nominations for educatione vents in July and August. A number of these were mentioned in the testing memo to POTUS (which went to him on June 17 -- I reconfirmed this with staff secretary)

- 1. State sign-up event in mid-July: As we discussed, I'm working on putting this together. If we can get enough states, we could do this at the NGA meeting.
- 2. City sign-up event in mid-late July: I'm also trying to get this together. Should know early next week if we can get enough cities on board to do something.
- 3. Principals meeting in late July: We could announce the Interagency Math Strategy the President directed ED and NSF to develop.
- 4. Transmittal of the Higher Ed Act reauthorization proposal: If we can get ED to complete its work and send the whole package up at once, we could do a transmittal event. Much of the proposed legislation will retain the basic structure of student financial aid, with some wrinkles to make it easier for students and parents to understand, and increase accountability for institutions that administer aid programs, while reducing regulatory burden on most of those who do this job without problem.


More newsworthy potential components of HEA proposal include: (1) a proposal to increase the size of Pell grants for kids with high academic performance in high school [details of this are not yet developed, though Riley briefly mentioned this in his testimony to the House committee last week]; (2) some version of the teacher incentive/teacher preparation proposal we discussed before the service summit;, or (3) some version of Chakkah-Fattah.

[late note: Terry Dozier says the plan is still to transmit separate components of HEA, and the the teacher preparation component is the most advanced, with a transmittal anticipated by late July.]

- 5. Failing School Initiatve: We could certainly have something ready by early August. As a stand-alone initiative, I assume it would either redirect existing/proposed resources (e.g., charter schools/community schools) or include a modest amount of new funds, such that we would stand a chance of getting OMB sign-off outside the normal budget process.
- 6. Gun Free Schools: Sometime this summer ED will be releasing final numbers for the gun free schools act (Gore released preliminary numbers). I'm checking on when they anticipate doing this.
- 7. NCSL: I still think it would be a good idea for POTUS to speak to the NCSL meeting. He could push testing and charter schools. I'm trying to find a good charter schools announcement, but

won't know what we can in fact do until Jon Shnur gets back. If we've got something good on charters, we should do a charter event even if we don't do NCSL.

I'll continue to think about NAACP possibilities, and Leslie Thornton has asked people in ED to send me additional ideas, which I will feed into the mix as they come.

Subject: IDEA update

Today I spoke with Tom Hehir at ED about how things are progressing on the IDEA reauthorization. As you know, Senator Lott's chief of staff, David Hoppe, has convened a bipartisan process involving key House and Senate staff and Judy Heumann, as well as advocacy groups, to work through a set of outstanding issues on the bill. The process has been proceeding very smoothly, and last week there was a members' meeting at which nearly everyone (including R's Lott, Coats, Goodling, Castle, Riggs, and Graham and D's Harkin, Miller, Scott, Martinez, and Payne) agreed to vote down all amendments. However, there was one fly in the ointment...

Senator Kennedy showed up late and said that he thought DOJ should have expanded jurisdiction over IDEA enforcement--that DOJ should have independent authority, not just when called in by ED (which has happened once during this Administration), with the implication being that the Department has not been vigorous enough. Lott's staff views this as a deal-breaker, and has contacted ED to ask them to intervene. Heumann has asked for a meeting on this with Kennedy, which was scheduled then canceled. Currently ED thinks it's best to wait for a day or two and see if things sort themselves out, but if not they will probably get either Harkin or Secretary Riley to call Kennedy. Bottom line is that ED remains very optimistic that there is going to be a good bill for the President to sign, but the situation with Sen. Kennedy will have to be worked out first.



Here is where we are:

#### 1. NAGB (Advisory Group(s) for testing initiative):

The short answer is that we are working with the Education Department to identify options for establishing an advisory group, and are consulting with key members of Congress, to determine how best to proceed. Congressional consultations will begin next week, and we continue for the next several weeks.

#### The longer version is:

1. The Education Department is producing an options paper, which Mike Smith and I will review on Friday. The paper addresses the mission(s) to be served, the number of groups we might need (e.g., a technical advisory group to advise on technical aspects of test development, a substantive group to make sure the test measures the right content, etc.) and how the groups would be formed.

The key issues to be resolved here revolve around (1) whether to establish an independent, policy/governing board that would have responsibility for overseeing the test development and use; (2) if so, whether this would be the current NAGB or something separate -- and, if separate, how it would relate to NAGB; (3) if we decide we need an independent group, when to engage the Hill on this.

2. Mike and I are meeting with Goodling's staff next Tuesday on these issues; as appropriate we will then reach out to other key Republicans (e.g., Riggs, Porter) and Democrats (Clay, Kildee) on the House side.

3. Mike Smith and Kay Casstevens think our biggest risk comes from getting Congress involved in all of this stuff when so far only a few Republicans (prodded by 2 outsiders and 1 staff member) have even raised these issues. However, I think our biggest risk comes from not creating some distance between the Administration and the test development, and by not taking steps to create an independent, credible buffer between us and the tests.

#### 2. Teacher News

1. The prime teacher event coming up is the teacher of the year event in mid April. This event generally generates good local coverage nationwide, because every state teacher of the year shows up. Because the national teacher of the year is a board-certified teacher, this event is also an opportunity to highlight and explain our initiatve in this area; we haven't done that yet, and the Defense announcement in North Carolina limited any attention to the National Board there.

In addition, I am working with ED to identify a new step for the President to announce at this event. My leading candidate is centered around a proposal (to be included in the Higher Ed Act) to support the development of standards and assessments for beginning teachers, to complement the tough standards for existing teachers. There is work underway on this we can build on. This will get nailed down with the Department by the beginning of the week.

As a package, the message from the event will be about excellence in teaching--teachers of the year, national board standards, standards for new teachers, and Riley and POTUS listen to the voices of the best teachers.

2. I'm still working on Shanker memorial, but no progress to report since yesterday.
