U.S. Monthly House Price Index Declined 1.6 Percent from January to February

WASHINGTON, DC – U.S. house prices declined 1.6 percent on a seasonally adjusted basis from January to February, according to the Federal Housing Finance Agency's monthly House Price Index. The previously reported 0.3 percent decrease in January was revised to a 1.0 percent decrease. For the 12 months ending in February, U.S. prices fell **5.7** percent. The U.S. index is **18.6** percent below its April 2007 peak and roughly the same as the February 2004 index level.

The FHFA monthly index is calculated using purchase prices of houses backing mortgages that have been sold to or guaranteed by Fannie Mae or Freddie Mac. For the nine Census Divisions, seasonally adjusted monthly price changes from January to February ranged from -3.7 percent in the Mountain Division to -0.6 percent in the East South Central Division.

Figure 1: Seasonally Adjusted and Unadjusted Monthly Appreciation Rates




Figure 2: Monthly House Price Index for USA

Purchase-Only, Seasonally Adjusted Index, January 1991 - Present




Figure 3: Cumulative Seasonally Adjusted Price Change Relative to Peak USA
