On 7 July 2012 at approximately 1415 hours, an employee, with three months experience, punctured his left hand while attempting to cut a tie wrap. The injured employee (IE) had received a portable light from another structure and was attempting to remove a tie wrap that secured the electrical cord. The IE entered the quarters and utilized a kitchen knife to remove the tie wrap. As he severed the tie wrap utilizing the kitchen knife with his right hand, the knife slipped and punctured his left hand directly below his thumb. The IE was flown in for medical treatment and received 3 stitches prior to being released to full duty. The lessee failed to provide proper training or a mentor due to the IE's lack of experience.

18. LIST THE PROBABLE CAUSE(S) OF ACCIDENT:

The IE should have utilized a better suited cutting device to remove the tie wrap; e.g., a pair of snips. The kitchen knife should not have been used to attempt to remove the tie wrap.

With only three months experience, the Lessee failed to provide proper training/mentoring.
