Subject:	Community Bank Capital Outreach Programs

From July 20, 2012, through August 1, 2002, FDIC staff hosted a community bank outreach program regarding the Basel III and Standardized Approach notices of proposed rulemaking (collectively, the "NPRs"), which were adopted by the FDIC Board of Directors on June 12, 2012. The purpose of this outreach program was to highlight those aspects of the NPRs that would most likely impact community banking organizations, and to assist such organizations in responding to the requests for comment presented in the NPRs. FDIC staff hosted six two-hour sessions, each of which followed an identical format. During the first hour of each session, FDIC staff provided an overview of the NPRs and identified proposed revisions to the existing leverage and riskbased capital rules that would likely be significant for community banking organizations. For the second hour of each session attendees were provided an opportunity to ask questions.

On August 3, 2012, FDIC staff hosted a national call to address those questions most frequently asked by attendees at the live outreach program sessions. During the national call, participants were given an opportunity to submit questions to FDIC staff via email.
