A: Amy, your institution can pay all or part of the 25% that is not covered by federal funds. Some institutions pay this for their partners. Your institution sets the percentage partners pay.

A: Also, partners can also send your institution a letter requesting to pay only 10% of the wages (90% can be paid through federal funds). See the Compact publication under "Partnering with Financial Aid," and articles I wrote on these technical topics.
