**SUBJECT: ISSUANCE OF ORDER FOR INTERIM SAFEGUARDS AND SECURITY
COMPENSATORY MEASURES FOR MILLSTONE POWER STATION**

Dear Mr. Christian:

The U.S. Nuclear Regulatory Commission (NRC or Commission) has issued the enclosed Order that modifies the general license for your proposed independent spent fuel storage installation (ISFSI) to require compliance with the specified interim safeguards and security compensatory measures. The interim compensatory measures are listed in Attachment 1 (contains Safeguards Information (SGI)) to the enclosed Order. The Commission has determined that additional security measures are required following the events of September 11, 2001, and concluded that the security measures should be embodied in an Order, consistent with the established regulatory framework. Due to the current threat environment, the requirements of the enclosed Order must be in place prior to you initiating operations of your ISFSI.

These actions are interim and the basis for the Order is the need to take prudent actions to address security requirements in the current threat environment. This Order does not obviate the need for licensees to continue to meet and maintain the effectiveness of existing security measures taken in response to the events of September 11, 2001. The requirements will remain in effect pending notification from the Commission that a significant change in the threat environment has occurred, or the NRC determines that other changes are needed.

The enclosed Order calls for responses and actions within specified time frames.
