#### **USDA FY-2013 SBIR Solicitation Deadline Extended**

Applications in response to the US Department of Agriculture (USDA) National Institute of Food and Agriculture (NIFA) FY-2013 SBIR Phase I solicitation originally had been due September 6, 2012, however, a notice has been added to the solicitation indicating that the deadline has been extended to September 13, 2012.

The modified solicitation also indicates that section 3.3.3 (R&R Other Project Information) has been modified to include the addition of the following:

Field 9. Bibliography & Cited References - (PDF Format is Required)
Provide a complete list of all references cited in the application. For each reference,
provide the complete name for each author, the year of the publication, full title of the
article, name of the journal or book published, volume, and the page numbers. The
references should be listed in alphabetical order using the last name of the first author.

#### DoD SBIR 2012.3 and STTR 2012.B Solicitations Open

The Department of Defense (DoD) began accepting proposals in response to their SBIR 2012.3 and STTR 2012.B Solicitations on August 27, 2012. Both solicitations close on September 26, 2012.

The web sites for both solicitations (available on the DoD SBIR/STTR website <a href="https://www.acq.osd.mil/osbp/sbir/index.shtml">www.acq.osd.mil/osbp/sbir/index.shtml</a>) include notices that 'Important updates have been made to the solicitation instructions. The solicitation websites also indicate that:

"For reasons of competitive fairness, direct communication between proposers and topic authors is not allowed during the Open period when DoD is accepting proposals for each solicitation. However, proposers may still submit written questions about solicitation topics through the <a href="SBIR Interactive Topic Information System">SBIR Interactive Topic Information System (SITIS)</a>. In SITIS the questioner and respondent are anonymous and all questions and answers are posted electronically for general viewing until the solicitation closes. All proposers are advised to monitor SITIS during the Open solicitation period for questions and answers and other significant information relevant to their SBIR/STTR topics of interest."

## NSF FY-2013 SBIR and STTR Program Solicitations Released

The National Science Foundation (NSF) posted their FY-2013 STTR solicitation on their SBIR/STTR website (<a href="http://www.nsf.gov/eng/iip/sbir/">http://www.nsf.gov/eng/iip/sbir/</a>) on August 6, 2012. NSF will accept proposals from November 20 to December 20, 2012, however, a letter of intent (LOI) must be submitted in order to submit a full proposal. NSF will accept LOIs between October 20, 2012 - November 20, 2012.

The STTR research topic for this solicitation is *Enhancing the Bioeconomy using emerging Biological Technologies (EBBT)*. Proposals must use a biologically-based approach, such as synthetic biology, systems biology, metabolic engineering, proteomics, bioinformatics, and computational biology, to address business opportunities in key industry sectors including biomedical, biomanufacturing, and sustainable agriculture.

A webinar will be held on September 13 to answer questions about the solicitation. There is no advance registration for this webinar. See the NSF SBIR/STTR website for instructions on how to join the webinar.

The NSF also posted their FY-2013 SBIR Phase I solicitation on August 30, 2012. NSF will accept proposals from November 3 to December 3, 2012. As indicated in the solicitation, which is available at <a href="http://www.nsf.gov/pubs/2012/nsf12605/nsf12605.htm">http://www.nsf.gov/pubs/2012/nsf12605/nsf12605.htm</a>, NSF has formulated broad solicitation topics for SBIR that conform to the high-technology investment sector's interests. The four broad topics are:

- Biological and Chemical Technologies (BC)
- Education Applications (EA)
- Electronics, Information and Communication Technologies (EI)
- Nanotechnology, Advanced Materials, and Manufacturing (NM)

## SBIR Proposal Writing Tip: Fraud, Waste and Abuse

SBIR Proposal Writing Basics: Don't Be an Easy Target for a Fraud, Waste and Abuse Witch Hunt

We have previously alerted you to the emphasis in the SBIR/STTR reauthorization on agencies detecting and eliminating "fraud, waste and abuse" (FW&A) by SBIR/STTR companies. We want to alert you to an area on which we think the agencies will be focusing during their FW&A investigations (described by some as witch hunts) so you can

take appropriate action to avoid becoming a victim.

The area of focus, we think, is your SBIR/STTR cost proposal and accounting system. Why would the agencies focus here? Simple: first, it is an area where many small SBIR/STTR companies don't put much effort when it comes to their proposal—unfortunately, they focus 99% of their attention on the technical proposal and just throw together an unjustified and ill-conceived cost proposal. Second, there are thousands of rules in Federal government procurement, so even larger, experienced firms do not know all of them (or changes therein). Third, the reauthorization require the agencies to report annually how much money they recovered through their FW&A efforts--it is easy for them to put a dollar value on errors in your budget or accounting system.

Now in the good ol' days (like last year), we wouldn't worry too much about Phase 1 project cost proposals and budgets, since they are relatively small dollar amounts and the agencies have tended to give you that "grace period" to get your accounting system and indirect/F&A rate projection up to snuff. But we are becoming concerned that Phase 1s may become a target for FW&A investigations, for several reasons. First, Phase 1 proposers/recipients tend to put less time and effort into the cost proposal and accounting than their Phase 2 counterparts, so Phase 1 companies become easy targets for this witch hunt. Second, we noted the following statement in the NIH notice of Phase 1 award received recently by a client: "the grantee may only charge actual F&A costs to the project, not to exceed the amount awarded (40% of total direct cost or less..." Therefore, even if you go with the NIH indirect/F&A rate of 40% of all direct costs that the agency allows if you don't have an approved rate, NIH wants you to only bill an indirect/F&A rate that you can justify. This means you can no longer just assume your actual costs equal or exceed the 40% rate, but must estimate and update the actual rate throughout the Phase 1 project.

So if you agree that FW&A is something you need to pay attention to, and if you agree that your cost proposal and accounting system can be a target for a FW&A investigation, then you need to take several actions.

- You need to estimate your indirect/F&A rate before you submit your Phase 1
  proposal. This is important both to prepare for the FW&A investigation and
  reduce the likelihood that you lose money in Phase 1 resulting from
  underestimating these costs.
- By the time you receive a Phase 1 award, you need to have an adequate
  accounting system. That doesn't just mean that it is out of the shoe box and on
  to your computer-it also means it is capable of tracking labor hours (i.e.,
  includes time sheets), and segregating indirect from direct costs and allowable
  from unallowable costs
- You need to track your actual costs (direct and indirect/F&A) throughout your project so you can make adjustments if your actual costs are different than the ones you estimated in your SBIR/STTR cost proposal.
- 4. You need to be charging, as part of your indirect/F&A rate, the time and cost you must incur to do all of this budgeting, estimating, and tracking of costs. If the Feds are going to raise the bar of FW&A scrutiny, then they should be prepared to pay the costs you incur.
- 5. Make sure you charge indirect/F&A in your proposal. With all the attention of FW&A, you may decide the safe thing to do is to just not charge anything but the direct costs on the project. While that is safe, it is not smart: you will incur indirect/F&A costs, and if you don't charge for them you will lose money and could jeopardize your company's viability.

An obvious question is how you gain the knowledge and expertise to do all of this. You may want to retain a professional who knows government accounting to set up your accounts, estimate your indirect/F&A rate, and otherwise give you important guidance. Be sure you find someone who knows government accounting (it is a specialization, and not

all bookkeepers and accountants have it), and preferably use someone who has experience working with the agency (ies) to which you are submitting proposals and receiving awards. You also may want to get some training related to the cost proposal and government accounting—it is certainly valuable if you want to estimate and track your own indirect/F&A rate, but it also is important if you retain a professional because you still need to understand the concepts and terminology so you can manage this important part of your SBIR/STTR project.
