FGDC Standards Working Group

Background

The FGDC Standards Working Group (SWG) has been active since 1995. It serves as the standards development administrative and coordination arm of the FGDC, for which standards development activities are established and delimited by Section 4 of Executive Order 12906 and applicable parts of OMB Circular A-16 and OMB Circular A-119. The FGDC develops standards only when there are no voluntary consensus standards that meet the needs of FGDC member agencies.

The SWG standards approval process is modeled upon standards approval processes used by ISO, the International Organization for Standardization, and ANSI, the American National Standards Institute. The FGDC Standards Reference Model defines the expectations of FGDC standards, describes different types of geospatial standards, and documents the FGDC standards process. Standards Directives provide specific guidance to the FGDC Subcommittees and Working Groups and other organizations that develop standards and document the practices of the FGDC Standards Working Group.

There are 40 standards in the FGDC standards program of work, of which 22 standards have been endorsed by the FGDC. Another 18 are in various stages of development. Objectives and Goals for FY 2007

The primary goal for FY 2007 is to improve the management of FGDC standards program of work through the following objectives:

- ? Continue the FGDC-wide review of FGDC standards program of work
 - o Identify projects that should be discontinued
 - o Identify endorsed standards that are up for 5-year maintenance review
- ? Manage the identification and sponsorship of voluntary consensus standards for FGDC endorsement
- ? Develop and get endorsement for timelines for development of working drafts and committee drafts and preparation of final review drafts.
- ? Revise FGDC Standards Reference Model to cover topics including (but not limited to) standards processes, classification or architecture of standards,

and harmonization with external standards and the Federal Enterprise Architecture.

- ? Review FGDC Standards Directive #9, Maintenance
- ? Accomplish public review of draft standards, specifically the Address Data Standard, the Shoreline Data Standard, and revision of the National Vegetation Classification Standards (already accepted in FGDC standards program of work)
- ? Submit revised draft Framework Data Standard and adjudicated comments received with the INCITS L1 ballot concluded in April 2006 to INCITS L1 for a second round of balloting to advance the standard as a draft preliminary American National Standard (dpANS).
- ? Support the conversion of selected FIPS standards to ANSI/INCITS standards

Benefits or Justification/Legal Mandate

Geospatial standards activities facilitate the development, sharing, and use of geospatial data. From the beginning of the FGDC, standards have been and remain to be the key to efficient identification and exchange of geospatial data. This is recognized in the following documents which for the legal basis for the work.

OMB Circular A-016 (Revised), *Coordination of Geographic Information and Related Spatial Data Activities*, August 19, 2002.

OMB Circular A-119 (Revised), *Federal Participation in the Development and Use of Voluntary Consensus Standards and in the Conformity Assessment Activities*, February 10, 1998.

Executive Order 12906, *Coordinating Geographic Data Acquisition and Access: The National Spatial Data Infrastructure*, published April 13, 1994, amended by EO 13286, March 5, 2003.

Scope of Work

The SWG scope of work includes the following:

- ? assisting the FGDC Coordination Group in promoting the development, maintenance, and management of NSDI related standards
- ? assisting the individual FGDC thematic subcommittees and other working groups in the preparation of geospatial standards
- ? acting on behalf of the FGDC for standards such as the Content Standard for Digital Geospatial Metadata (CSDGM), for which the FGDC serves as maintenance authority

The scope of work includes approving the standards projects proposed by FGDC members, reviewing the proposed scope of each project, coordinating standards projects between the subcommittees or work groups, reviewing proposed time lines for standards development, maintaining a register of FGDC standards activities and their status, providing guidance on FGDC standards development policy and procedures, assuring consistency of FGDC standards, facilitating coordination between subcommittees with overlapping standards activities, reviewing standards for compliance with FGDC policy and procedures, reviewing standard drafts and recommending final publication as FGDC standards, and recommending to the Coordination Group or the Steering Committee any actions necessary to accomplish the standards goals of the FGDC.

Milestones, Schedule, and Budget

Projects and actions to be undertaken during the upcoming year cannot be predicted with certainty because the SWG must respond to project proposals from the FGDC members and must adjust priorities and resource allocation as directed by the FGDC Coordination Group. The list below contains known projects that are either underway or planned for work during the year. When the responsible authority is other than FGDC/SWG, the schedule is under the control of that authority. FGDC/SWG only supports and guides the work. Likewise, budget and other resource needs are the duty of that responsible authority.
