**ORDER GRANTING PHASE I CLAIMANTS' MOTION  
FOR PARTIAL DISTRIBUTION OF 2009 CABLE ROYALTY FUNDS**

On September 6, 2011, the Copyright Royalty Judges (“Judges”) published in the **Federal Register** a Notice<sup>1</sup> soliciting comments on a Motion of Phase I Claimants for Partial Distribution of the 2009 cable royalty funds (“Motion”) under section 801(b)(3)(C) of the Copyright Act, dated August 5, 2011, seeking a partial distribution of 50 percent of those funds.<sup>2</sup> In particular, the notice solicited comments on whether there are reasonable objections to the requested distribution. The notice also solicited comments on whether there are any Phase I or Phase II controversies with respect to the remaining funds if the motion were granted.

<sup>2</sup> In support of their Motion, the Phase I Claimants assert that all of the preconditions of section 801(b)(3)(C) of the Copyright Act have been or will be satisfied prior to distribution.

That section provides that:

[T]he [J]udges, at any time after the filing of claims under section 111...may, upon motion of one or more of the claimants and after publication in the Federal Register of a request for responses to the motion from interested claimants, make a partial distribution of such fees, if, based upon all responses received during the 30-day period beginning on the date of such publication, the [Judges] conclude that no claimant entitled to receive such fees has stated a reasonable objection to the partial distribution, and all such claimants—

- (i) agree to the partial distribution;
- (ii) sign an agreement obligating them to return any excess amounts to the extent necessary to comply with the final determination on the distribution of the fees made under subparagraph (B);
- (iii) file the agreement with the Copyright Royalty Judges; and
- (iv) agree that such funds are available for distribution.


In response to the notice the Judges received a joint comment from the Phase I Claimants, and individual comments from the Canadian Claimants Group, Commercial Television Claimants, Devotional Claimants, Joint Sports Claimants, Music Claimants, National Public Radio, Program Suppliers, Public Television Claimants, and Independent Producers Group ("IPG").<sup>3</sup> No commenter stated a reasonable objection to the proposed distribution, although some noted various outstanding controversies with respect to the 2009 cable royalty funds.

Therefore, the Motion is **GRANTED**.

Wherefore, **IT IS ORDERED** that 50% of the cable royalties held in the 2009 funds shall be distributed in the manner set forth in Attachment A to the Motion, which is appended to this Order.

The Copyright Office shall make such a distribution **PROVIDED THAT** each of the parties receiving a share of these funds provides to the Copyright Office a signed agreement prepared by the Copyright Royalty Board stating that any overpayment that results from the distribution of these funds shall be repaid to the Copyright Office with interest according to the amount that would have accrued if the principal had remained in the fund. In addition, all pertinent information to effect the transfer of funds must be provided to the Licensing Division of the Copyright Office no later than October 20, 2011. The distribution shall take place on or after October 27, 2011.

**ATTACHMENT A**

**CABLE ROYALTY DISTRIBUTION  
2004-2005 BLENDED PERCENTAGES<sup>1</sup>**

A partial distribution of 50% of the 2009 Funds should be distributed in the following percentages: NPR should first receive 0.18% of the entire amount to be distributed after which the remaining amount should be distributed as follows:
