



About the Archival Research Catalog (ARC)


- The Archival Research Catalog or ARC is the online catalog of NARA's nationwide holdings in the Washington, DC area, Regional Archives and Presidential Libraries.
- ARC is a work in progress. Currently over 68% of our records are described in ARC. More descriptions are added regularly.
- ARC allows you to search for records in all NARA facilities across the country.
- ARC contains descriptions of NARA records and approximately 155,000 digitized copies of records.
- ARC is a catalog. It is not a database of records like AAD or Ancestry.com.








provides serial number, personal name, branch of service or civilian status, grade, date reported, race, state of residence, type of organization, parent unit number and type, place of capture (theater of war), source of report, status, detaining power, and prisoner of war or civilian internee camp site. Records of prisoners of the Japanese who died also document whether the prisoner was on a Japanese ship that sank or if he or she died during transport from the Philippine Islands to Japan. There are no records for some prisoners of war whose names appear in the lists or cables transmitted to the Office of the Provost Marshal General by the International Committee of the Red Cross.


