

This modification makes the following changes:

1. Definitizes Change Order number 10 by mutual agreement of the contracting parties in accordance with FAR 52.243-2, Changes - Cost Reimbursement and DEAR 970.5204-2, Laws, Regulations, and DOE Directives. The agreement results in a \$1,587,358 increase to the Contract Price which includes \$70,000 in fixed fee for settlement of incurred cost.
