The purpose of this modification is to issue an undefinitized change order for continued support during Fiscal Year (FY) 2012 to resolve corrective actions related to the Hanford Site Chronic Beryllium Disease Prevention Program (CBDPP). The contractor is hereby provided an immediate Notice-to-Proceed (NTP) with a Not-to-Exceed (NTE) authorized amount increased by \$125,000 from \$250,000 to \$375,000. This NTE amount includes all costs authorized with CAP planning and implementation since the issuance of Modifications 122, 126, and 138.

b. Computer Sciences Corporation - Hanford Occupational Health Services (CSC) is directed to continue to provide support during FY 2012 to the Hanford Site CBDPP as directed by the Richland Operations Office. This work scope includes, but is not limited to, the following:
