- 2. <u>Authority Cited</u>: 10 U.S.C. 2304(c) (1) "Only one responsible source and no other supplies or services will satisfy agency requirements." (FAR 6.302-1(b)(1)(i), FAR 6.302-1(c)). [Brand Name and Sole Source Justifications under FAR 6.302-1].
- 3. <u>Description of Supplies and Services:</u> Fifteen various replacement kits (list attached) for the Engineering is Elementary Units being ordered by Dr. Linda Hackett, DDESS Peachtree City. The original kits were ordered under contract: HEVAS6-12-P-0079. The kits include supplies that are generally capable of only one use (Popsicle sticks, Styrofoam balls, etc.), which is the reason for the present need for replacing such parts.

This product is a continuing training tool which will be used throughout the school year by all students. By purchasing these items, Macdonald continues to be a part of the DODEA-wide STEM Initiative.

- 4. <u>Description of Action:</u> Purchase of refill kits to support the DODEA-wide STEM Initiative for an estimated amount of \$5,125.00
- 5. Reason for Authority Cited: There is a reasonable basis to conclude that such unique supplies are available from only one supplier (Boston Museum of Science) with unique capabilities (per FAR 6.302-1(b)(i)). The only company which carries the EIE refill kits is the Boston Museum of Science; as the Engineering is Elementary Curriculum (the current curriculum in the schools) is exclusively provided by Boston Museum of Science.

It is also necessary to use a brand name description (per FAR 6.302-1(c)) to describe this requirement, as it is essential to the Government's requirements, thereby precluding consideration of a product manufactured by another company. The kits are intended as replacement kits for existing curriculum materials in the school, and the only source for these replacement kits is the Boston Museum of Science.

- 6. <u>Effort to Obtain Competition:</u> DDESS has and will continue to research/consider the need for the existing curriculum/ or need to modify or change the curriculum will also be examined. A notice of the Government's intent to make a sole source award to Boston Museum of Science will be posted on the DDESS Business Opportunities website, if the value for this requirement deems appropriate.
- 7. <u>Action to Increase Competition:</u> The market place will continue to be monitored to identify any new sources. The need for the existing curriculum/ or need to modify or change the

curriculum will also be examined. Furthermore, due to the constant need of replacing these materials, the possibility of an IDIQ will be considered for future acquisitions.

- 8. <u>Market Research:</u> Searched the Boston Museum of Science site. As stated previously, there is no other source for this product. Research from past contractual actions, in addition to current research, has indicated that there are no companies available to provide the kits for student instruction.
