**NOTICE TO LESSEES AND OPERATORS OF FEDERAL OIL AND GAS LEASES IN  
THE OUTER CONTINENTAL SHELF**

**Performance Measures for OCS Operators and Form MMS-131**

This Bureau of Ocean Energy Management, Regulation and Enforcement (BOEMRE) Notice to Lessees and Operators (NTL) rescinds NTL 2008 – N04 and hereby notifies you of relevant information about BOEMRE Form MMS-131, Performance Measures Data Form.

Form MMS-131 was revised and included in the final rule, *Oil and Gas and Sulphur Operations in the Outer Continental Shelf – Safety and Environmental Management Systems (1010-AD15)* and now requires mandatory annual reporting from operators. Operators should note that the Office of Management and Budget (OMB) approved form requires quarterly breakdowns of all recordable injuries/illnesses, Days Away, Restrictions and Transfers (DART) injuries/illnesses, and company/contract employee hours worked data. Our primary reasons for issuing this NTL are to reiterate that you are now required to provide data on an annual basis for the previous calendar year by March 31 of each new year, and to provide you with the URL, <http://www.gomr.boemre.gov/homepg/forms/frmindx.html>, where you may obtain the OMB approved form, the reporting element definitions, and the instructions to fill out the form. Previous versions of the form have expired and will not be accepted. You must submit the most current version of BOEMRE Form MMS-131 which is posted on the website listed.
