The U.S. Department of Housing and Urban Development and NeighborWorks® America have reopened the application process for the **Emergency Homeowners' Loan Program (EHL)** in 27 states, including Virginia and West Virginia, to give homeowners at risk of foreclosure more time to apply for the program. HUD estimates that resources will be available to reach more struggling homeowners and will accept applications submitted through **September 15, 2011**.

After a storm – if a primary source of housing is lost or severely damaged - or anytime, really, it helps to have tools available to assist with the search for housing. In April of this year, the Pennsylvania Housing Finance Agency, the Pennsylvania Emergency Management Agency and the Department of Public Welfare launched PAHousingSearch.com, a Web-based housing locator service that assists the Commonwealth's residents with more than 9,000 housing searches each week. PAHousingSearch.com joins VirginiaHousingSearch.com, DCHousingSearch.org and MDHousingSearch.org as ongoing resources to help landlords, who are encouraged to list their properties, and tenants, who are encouraged to look here first for housing.

SUSTAINABILITY PARTNERS AT WORK

HUD's Office of Policy Development and Research is hosting an "Advancing Sustainability Performance: A Research and Practice Forum" on September 28, 2011. This event will explore the latest developments in sustainability performance, and will feature the winning proposals for HUD's Sustainable Communities Research Grant competition. CONGRATULATIONS ARE IN ORDER

Region III programs were awarded nearly \$3,000,000 in HUD-VASH (Veterans' Affairs Supportive Housing) Vouchers to help end homelessness among Veterans of the Armed Services. To read the Federal Register announcement, [click here](#).

HUD Secretary Shaun Donovan announced a \$300,000 in [Rural Innovation Fund](#) award to the National Council on Agricultural Life & Labor Research (NCALL) Fund of Dover, DE to address distressed housing conditions and concentrated poverty on Virginia's Eastern Shore. Secretary Donovan said the grant will promote an "entrepreneurial approach" to affordable housing and economic development in rural Virginia.

HUD awarded more than \$11 million in Capital Advance funding, and nearly \$1 million for housing subsidies to projects in Maryland, Pennsylvania, Virginia and West Virginia to develop affordable housing for people with disabilities. See the [Federal Register Announcement](#) for details.

FHA LEADS THE WAY

Effective Monday, August 15, Federal Housing Administration's (FHA's) Single Family program area changed its primary e-mail address as well as the web page for the FHA "Frequently Asked Question" (FAQ) site. Here are the changes: FHA's primary email address will change from: info@fhaoutreach.com to: answers@hud.gov. The website for FHA FAQ will change from: www.fhaoutreach.gov/FHAFAQ to: www.hud.gov/answers. There is no change to the primary FHA Resource Center telephone number which remains 1-800-CALLFHA (225-5342).

HUD has posted a revised version of form HUD-92800.5b, Conditional Commitment Direct Endorsement Statement of Appraised Value, on HUDCLIPS. The new form reflects recent policy changes which reduced the validity period for appraisals from 6 months to 120 days. This form is for immediate use, but HUD will continue to accept the old form until November 1, 2011. Acceptance of the old form does not increase the validity period of appraisals beyond 120 days. FHA Notice H 2011-15 announces that discounts off the list price offered to governmental entities and HUD Approved Nonprofits on Single Family REO sales may be applied only during non-competitive sales periods and provides instructions for calculation of the net offer on competitive sales of individual FHA Single Family REO properties. New [Mortgagee Letters](#):

- Mortgagee Letter 2011-24 discusses maximum mortgage amounts as revised by the Consolidated Appropriations Act, 2008.

- Mortgagee Letter 2011-25 advises supervised lenders and mortgagees with consolidated assets below the audited financial reporting thresholds set by Federal regulators at 12 C.F.R. § 363.1(a), 12 C.F.R. § 562.4(b)(2), and 12 C.F.R. § 715.4(c) of changes to FHA's requirements regarding the submission of audited financial statements as a condition for FHA lender approval and renewal.
- Mortgagee Letter 2011-26 provides guidance to counseling agencies, HECM counselors and lenders regarding HUD-approved intermediaries inclusion on the list of HECM counseling agencies provided by lenders to prospective HECM borrowers.
- Mortgagee Letter 2011-27 transmits the new Amendment to AIA Document B108 (Form HUD-92408-M).
- Mortgagee Letter 2011-28 identifies circumstances under which mortgagors must successfully complete a trial payment plan prior to the mortgagee executing a loan modification or partial claim action under FHA Loss Mitigation Program, and announces the time requirements for mortgagees to complete permanent loan modification and partial claim documents in order to receive an incentive fee. These requirements are effective October 1, 2011.
- Mortgagee Letter 2011-29 provides notice of FHA's single family housing loan limits for forward mortgages and Home Equity Conversion Mortgages (HECMs) effective October 1, 2011 through December 31, 2011, provides loan limit instructions for FHA-insured to FHA-insured refinance (streamline) transactions, and provides eligibility criteria and instructions for pipeline loans which have not closed on or before September 30, 2011.
- Mortgagee Letter 2011-30 discusses FHA's adoption of the Uniform Appraisal Dataset (UAD) and two of the UAD compliant appraisal reporting forms, which further define specific data fields in these industry standard appraisal reporting forms.
- Mortgagee Letter 2011-31 provides guidance to counselors and lenders regarding: Revisions to form HUD 92902, Certificate of HECM Counseling (Certificate) found on HUDClips, Documenting the power of attorney, Clarification of signatures and dates on the Certificate, Counselor revisions to Certificates Changing lenders, transfers and issuance of new case numbers related to Certificates.

WHAT DO YOU THINK?

Officials from HUD, USDA Rural Development, and state housing finance agencies have been working to better align their programs. Pilot efforts addressing physical inspections and subsidy layering reviews will begin soon. Agencies are requesting stakeholder input on disposition of REO properties. The Federal Housing Finance Agency, Treasury Department, and HUD are exploring alternatives for selling single-family real estate owned properties held by Fannie Mae, Freddie Mac, and FHA, including approaches that support rental and affordable housing needs. The proposed Fiscal Year (FY) 2012 Fair Market Rents (FMRs) were published in the [Federal Register](#) on Friday, August 19, 2011. A 30-day comment period (until September 18) is in place.

HUD announces the addition of a [preservation web page](#) to the Multifamily website as a resource to provide information about preserving older affordable properties. Notices are listed by subject area, providing

resources for preserving FHA-insured properties with maturing mortgages, renewing Section 8 HAP contracts and much more.

The Federal Housing Finance Agency (FHFA), with the U.S. Department of the Treasury and HUD, has issued a [Request for Information \(RFI\)](#) to solicit ideas for sales, joint ventures, or other strategies to augment and enhance asset disposition (sales) programs of Fannie Mae, Freddie Mac and Federal Housing Administration (FHA) properties. The agencies are exploring alternatives to facilitate current and future sales, improve loss recovery, help stabilize neighborhoods and local home values, and where feasible and appropriate, improve the supply of rental housing. Responses are requested by September 15. Responses must be in .pdf format, and submitted to reo.rfi@fhfa.gov.

Two new studies using American Housing Survey data calculate that the national supply of rental units increased by an estimated 693,600 from 2007 to 2009. The stock affordable for residents with the lowest incomes fell by over 2 million units while significant shifts of units to higher rent categories occurred. The rate of unit loss was slightly higher in nonmetro areas than nationwide (2.1% compared to 1.6%). WHAT'S HAPPENING AROUND REGION III...

WILMINGTON, DELAWARE

HUD, EPA and USDA worked alongside volunteers and soon-to-be homeowners to build energy efficient homes at Crescent Shores Community in Lincoln on August 17. The Energy Efficient Rural Housing Project, supported in part by HUD's Self-help Home Ownership Program (SHOP) funding, is a program of the [Milford Housing Development Corporation](#) (MHDC), which supports affordable housing for low-income families in Delaware. HUD Regional Administrator Jane C. W. Vincent, the Environmental Protection Agency Regional Administrator Shawn Garvin and the U.S. Department of Agriculture's Rural Development State Director Jack Tarburton joined the construction crew to bring attention to the innovative rural housing development. Crescent Shores includes 10 new homes built to Energy Star standards, for first-time buyers.



BALTIMORE, MARYLAND

On July 18, 2011, a newly constructed, 60-unit mid-rise housing community for senior citizens in Hagerstown, MD opened its doors of opportunity. The 60 households that reside in the C. Williams Brooks Mid-Rise will enjoy one of the first affordable housing endeavors completed using ARRA funds. With the use of \$9.9 million in ARRA funds and \$4.5 million in additional funding, the building was constructed to provide high quality, sustainable, energy-efficient, affordable housing. The construction of C. Williams Brooks is estimated to have

provided 400 jobs to 40 vendors and contractors, with more than 67% of the construction and supporting services provided locally. Read more about it [here](#).
