- CSL was organized in February 2008 by the current owners

- The original name of the company was City State Logistics, LLC
- Our original mission was to provide specialty trucking, logistics, and environmental compliance services
- Due to the rapid economic decline in 2008, it became apparent the direction of the company needed to be directed toward non-asset based transportation
- In 2009 the company was renamed City-State, LLC to remove the trucking connotation and begin our new business model as a professional services provider



- In late 2009 the company submitted an application to the SBA for qualified HUBZone status and was approved in May 2010
