Jikin jermal eo am ej bōk konan ilo E-Verify, juon iaan būokraam im U.S. Ra eo an Homeland Security (DHS) im Social Security Administration (SSA) eo rej kōmmāne. E-Verify ej lale aolep mejele ko kwōj kwaḷoki ilo Form I-9, Employment Eligibility Verification eo, im peba ko an Kien eo bwe ren lukkuun jelā elaññe kwōweppān ñan jermal ilo Amedka in.

Kwōj bōk Leta in Lejok in jān jikin jermal eo am bwe E-Verify ej kwaḷok bwe mejele ko rej likūti ilo E-Verify jān Form I-9 eo eoktak jen mejele ko an SSA. Kwaar bōk juon 'SSA Kōjjelā Ñan Rijerbal eo Ikijien Bōlen Jab Weeppān' im kwōj bebe in jumaeiki. Men in ejab mejele bwe ebōd mejele ko kwaar lejoki ñan jikin jermal eo am im e jab kōnke kwōjab weeppān ñan jermal ilo Amedka in.

Juon SSA Bōlen Jab Weeppān emaroñ waḷok elaññe:

- Eoktak kadkadīn citizenship ak immigration status eo am jen kar kwaar bōk nōmba in Social Security eo am.
- Eoktak etam in kwaar jab kwaḷoke ñan SSA.
- Etam, nōmba in Social Security, ak raan in lotak eo am ebōd ilo mejele ko an SSA.
- Ewōr juon bar kain bōd ilo mejele ko am ilo SSA.
- Ejab jimwe wāween an jikin jermal eo am kar lejok mejele ko am ñan E-Verify.

1. Lale bwe etam, nōmba in Social Security eo am, im allōñ/iiō in lotak eo am me rej waḷok ilo peij eo kein kajuon an Leta in Lejok in ren jimwe. Elaññe ewōr mejele eo ebōd, kwaḷoke ñan booj eo am ilo iien eo emōkajata.
2. Kwōj aikuj loḷok SSA field opij eo mokta jān **8 raan in kien bijnij ko** ālikin raan in Leta in Loḷok in, mokta jān **__/__/__(MM/DD/YYYY)**, ñan kōmmāne keej eo am.

Wāween kalikjenḷok nae eok rej āinwōt: kōjemḷoke ak kōkōttare jermal eo am ie, jab lewōj wōneem ak kōmman training eo am, bar kōttar iien jino jermal eo am, ak kokkure am maroñ jermal ilo juon bar wāween.

3. **Bōktok Leta in Lejok eo am ippōm ilo iien eo kwōj loḷok SSA field opij eo.**
4. Bōktok peba kein **kāāl wōt** (jab copy) ñan SSA field opij eo, elaññe ewōr ippōm. SSA ej aikuj lale:
 - a. Kein kamoole **iiō ko am**; waan joñak, juon peba in lotak ak passport
 - b. Kein kamoole **kajjiūm**; waan joñak, juon driver's license jen juon U.S. state
 - c. Kein kamoole **kaoktak etam iumwin kien (legal name change)**; waan joñak, juon peba in made, elaññe emōj am kaoktak etam ālikin am bōk nōmba in Social Security eo am im
 - d. Kein kamoole **kadkadūm ekkar ñan jermal eo am (work-authorized status)**:
 - Elaññe kwe juon U.S. citizen: kein kamoole am **U.S. citizenship**, waan joñak, juon peba in Naturalization Certificate, U.S. public peba in lotak eo, ak U.S. passport eo, ak
 - Elaññe ejab kwe juon U.S. citizen: kein kamoole **kadkadūm in legal alien ekkar ñan jermal eo am (work-authorized legal alien status)**, waan joñak, juon Permanent Resident Card (Form I-551 ak "green card"), peba in Employment Authorization Document (Form I-766), ak Arrival-Departure Record (Form I-94) im ej kwaḷok kadkadūm ekkar ñan kien.
5. **Leta in Lejok in eaurōk** – kokone juon copy in leta in ippān peba ko am reaurōk.
6. Kōjjelāiki jikin jermal eo am ilo iien eo emōkajata elaññe jabdewōt iaan mejele ko kwaar letoki reoktak ālikin am loḷok SSA field opij eo, bwe jikin jermal eo am en kōkāāli mejele ko ippān .
