RULES AND RELATED MATTERS

APPLICATION OF THE ELECTRONIC SIGNATURES IN GLOBAL AND NATIONAL COMMERCE ACT TO RECORD RETENTION REQUIREMENTS PERTAINING TO ISSUERS UNDER THE SECURITIES ACT OF 1933, SECURITIES EXCHANGE ACT OF 1934 AND REGULATION S-T

On June 14, the Commission issued an interpretive release providing guidance on the application of the Electronic Signatures in Global and National Commerce Act (E-SIGN) to the recordkeeping requirements for issuers under the Securities Act of 1933, the Securities Exchange Act of 1934 and Regulation S-T. The release provides that E-SIGN is not applicable to manually-signed signature pages or other documents authenticating signatures appearing in typed form in documents filed with the Commission via EDGAR, or which are permitted to be filed in paper form. It states that issuers should continue to retain paper copies of these documents. The release also provides that certain other identified records may be retained in electronic form. ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDING INITIATED AGAINST JAMES MCCURDY, CPA

The Commission announced today that it has instituted a public administrative proceeding pursuant to Rule 102(e) of the Commission's Rules of Practice to determine whether James Thomas McCurdy, CPA, engaged in improper professional conduct in the performance of his audit of the 1998 financial statements of JWB Aggressive Growth Fund, a now defunct investment company.

McCurdy, an Ohio CPA, is the principal shareholder of McCurdy & Associates CPAs, Inc., located in Westlake, Ohio. McCurdy, as alleged in the Order Instituting Proceeding, failed to comply with professional auditing standards by failing to obtain sufficient competent evidence concerning the collectibility of a receivable from a related party that represented 25% of the Fund's assets. The Order Instituting Proceeding further alleges that McCurdy did not comply with professional audit standards in that he failed to: (1) maintain an attitude of professional skepticism; (2) render an accurate audit report; and (3) exercise due professional care.

A hearing will be held before an Administrative Law Judge to determine whether the staff's allegations in the Order Instituting Proceeding are true and, if so, what, if any, remedial action is necessary and appropriate. (Rel. 34-44425; AAE Rel. 1404; File No. 3-10509)
