ADMINISTRATIVE PROCEEDINGS

STOP ORDER ISSUED AS TO MEMORY METALS, INC. REGISTRATION STATEMENT

The Commission issued a stop order suspending a registration statement filed by Memory Metals, Inc. from becoming effective. The registration statement was filed in connection with a planned secondary shelf offering of common stock. The Commission found that the registration statement failed to disclose the interests of two individuals in the shares to be sold, their relationships with Memory Metals and their ownership before and after the planned offering. The Commission also found that the beneficial ownership of two former officers was misstated and that the registration statement omitted to disclose certain matters with respect to a contract with a customer. Memory Metals consented to the order without admitting or denying the findings. (Rel. 33-6820)

CIVIL PROCEEDINGS

ACTION FOR INJUNCTIVE, OTHER RELIEF AGAINST MEMORY METALS, INC. AND FORMER PRESIDENT

In an action filed in the U.S. District Court for the District of Connecticut, the Commission alleged that Memory Metals, Inc. and L. McDonald Schetky violated antifraud and other provisions of the securities laws in connection with the filing of two registration statements and periodic reports and the issuance of press releases and materials used in a private placement, which were alleged to be materially false and misleading. It was also alleged that Schetky sold Memory Metals securities while in possession of material non-public information. The Court permanently enjoined Memory Metals from violating antifraud and other provisions of the securities laws. The Court also ordered Memory Metals to comply with undertakings relating to advance review by an attorney of press releases, reports to shareholders and filings, the implementation of a written disclosure policy, and review of certain consulting relationships. Memory Metals consented to the Judgment without admitting or denying the allegations. (SEC v. Memory Metals, Inc. and L. McDonald Schetky, USDC DCT, Civil Action No. B-89-089, WWE). (LR-12004)

INVESTMENT COMPANY ACT RELEASES

THE ALGER AMERICAN FUND

An order has been issued exempting The Alger American Fund and certain life insurance companies and their variable life insurance separate accounts from Sections 9(a), 13(a), 15(a), and 15(b) of the Investment Company Act and Rules 6e-2(b)(15) and 6e-3 (T)(b)(15) to permit mixed and shared funding. (Rel. IC-16822 - Feb. 17)

MUTUAL SHARES CORPORATION

A notice has been issued giving interested persons until March 13 to request a hearing on an application filed by Mutual Shares Corporation for an order declaring that it has ceased to be an investment company. (Rel. IC-16823 - Feb. 17)

HOLDING COMPANY ACT RELEASES

MIDDLE SOUTH UTILITIES, INC.

An order has been issued authorizing Middle South Utilities, Inc., a registered holding company, to guarantee the performance of its subsidiary, System Energy Resources, Inc., under a nuclear fuel financing arrangement, under which such fuel may be leased in an aggregate amount of up to \$185 million. (Rel. 35-24824 - Feb. 21)

SYSTEM ENERGY RESOURCES, INC.

An order has been issued authorizing System Energy Resources, Inc., subsidiary of Middle South Utilities, Inc., to acquire its nuclear fuel by lease in the approximate amount of up to \$185 million. (Rel. 35-24825 - Feb. 21)

SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change which became effective under Section 19(b) (3)(A) of the Securities Exchange Act of 1934. The proposal (SR-NASD-89-6) delays the effectiveness of the shareholder approval requirements contained in new paragraph (i) of Part III, Section 5 of Schedule D to the NASD By-Laws. (Rel. 34-26560)
