ADMINISTRATIVE PROCEEDINGS

BONNEVILLE REGISTRAR AND TRANSFER AND MATTHEW R. WHITE SANCTIONED

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Bonneville Registrar and Transfer, a registered transfer agent, and its managing general partner, Matthew R. White, both of Salt Lake City, Utah. Bonneville and White, without admitting or denying the findings or factual allegations of the Order, consented to the Order. The Commission found that Bonneville, among other things, (1() violated the transfer agent reporting requirements by making misrepresentations and failing to disclose material information in its transfer agent registration form; (2) failed to timely file required annual reports; (3) failed to report the inability to turnaround routine items within the required time period; and (4) failed to make and maintain certain required books and records. The Commission also found that White failed to properly supervise the employees of Bonneville.

The Order censures Bonneville and directs it to, among other things, comply with its undertakings to (1) file current amendments to Forms TA-1 and TA-2; (2) have an independent accountant conduct an annual evaluation and adopt recommendations to correct deficiencies; and (3) make and maintain required books and records. The Order also censures White and directs him to comply with his undertaking to assist Bonneville in adopting formal supervisory procedures to avoid similar violations in the future. (Rel. 34-27288)

INVESTMENT COMPANY ACT RELEASES

GOVERNMENT SECURITIES ZERO COUPON TRUST; INVESTMENT GRADE BOND TRUST

A notice has been issued giving interested persons until October 19 to request a hearing on an application filed by Government Securities Zero Coupon Trust and Investment Grade Bond Trust for an order declaring that they have ceased to be investment companies. (Rel. IC-17152; IC-17153 - Sept. 25)

OCEAN STATE POWER II

An order has been issued authorizing a proposal by Ocean State Power (OSP), a general partnership and subsidiary of EUA Ocean State Corporation (EUA-OS) and Narrangasett Energy Resources Company (NERC), and its indirect parent companies, Eastern Utilities Associates (EUA) and New England Electric System (NEES); Blackstone Valley Electric Company and EUA Service Corporation, subsidiaries of EUA; New England Power Service Company (NEP Service), subsidiary of NEES; Ocean State Power II (OSP II), a general partnership and proposed direct subsidiary of EUA-OS and NERC and indirect subsidiary of EUA and NEES; and TransCanada Pipeline Limited and its indirect subsidiary, TCPL Power, Ltd., affiliates of OSP and proposed affiliates of OSP II, whereby EUA-OS, NERC, and TCPL propose to acquire a partnership interest in OSP II and EUA-OS, and NERC proposes to make capital contributions to OSP II. EUA and NEES propose further investments in and performance guarantees of certain obligations of EUA-OS and NERC, respectively; EUA Service and NEP Service propose to provide certain services to OSP II, and OSP II proposes to issue non-recourse notes in a principal amount of approximately \$225 million to a syndicate if financial institutions under a seven-year credit facility; and OSP, OSP II, and Blackstone propose to exchange certain properties.
