## NOTICE OF COMMISSION MEETINGS

Following is a schedule of Commission meetings which will be conducted pursuant to provisions of the Government in the Sunshine Act. In general, the Commission expects to follow a schedule of holding closed meetings on Tuesdays, and open meetings on Thursday morning. ## CIVIL PROCEEDINGS

---

### FINAL ORDER ENTERED AGAINST DENNIS GROTH

On June 5, the Commission announced the entry of a Final Order in the U.S. District Court for the Northern District of California against Dennis Groth. The Order ends an insider trading action instituted on September 26, 1983. Groth consented to the Final Order without admitting or denying the allegations in the complaint and the first amended complaint (both hereinafter, complaint).

The complaint alleges that Groth: sold 10,900 Warner warrants on November 17, 1982, 5,000 shares of Warner common stock on November 19, 1982, and 6,376 shares of Warner common stock on December 1, 1982, while in possession of inside information he obtained as executive vice president and chief financial officer of Atari, the principal Warner subsidiary; and knew that the growth of Atari's income had ceased, knew that Atari's income was declining, knew of other adverse events affecting Warner, and knew as well the underlying events causing these results.

The Final Order provides that Groth shall not violate the antifraud provisions of the Securities Exchange Act of 1934 through insider trading, shall place \$154,184 and 2,925 shares of Warner common stock in escrow for the benefit of private litigants, and shall surrender employee stock option rights for 13,333 shares of Warner common stock to Warner. ### CAPITAL HOUSING PARTNERS - CLII

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
