ADMINISTRATIVE PROCEEDINGS

DENNIS B. LEVINE BARRED

The Commission instituted public administrative proceedings against Dennis Levine under Section 15(b)(6) of the Securities Exchange Act of 1934. Simultaneous with the institution of these proceedings, Levine submitted an Offer of Settlement for the purpose of disposing of the issues raised by these proceedings.

In accepting Levine's Offer of Settlement, the Commission found that Levine had been permanently enjoined by the U.S. District Court for the Southern District of New York from future violations of the antifraud provisions [Sections 10(b) and 14(e)] of the Exchange Act and rules and regulations thereunder. Based upon these findings, the Commission ordered that Levine be barred from association with any broker, dealer, investment adviser, investment company or municipal securities dealer. CIVIL PROCEEDINGS

PERMANENT INJUNCTION ENTERED AGAINST DENNIS LEVINE, OTHERS

The Commission announced on June 5 the resolution of SEC v. Dennis Levine, a/k/a Mr. Diamond, Diamond Holdings, S.A., International Gold, Inc. and Bernhard Meier, 86 Civ. 3726 (SDNY) (RO) as to three defendants. Pursuant to a Final Judgment entered by U.S. District Judge Robert Owen, Southern District of New York, Dennis Levine, Diamond Holdings, S.A. and International Gold, Inc. consented to a permanent injunction against future violations of the antifraud provisions of the Securities Exchange Act of 1934 (Section 10(b) and 14(e) and the rules and regulations) without admitting or denying the allegations of the Commission's complaint. Levine is ordered to repatriate and disgorge all of the monies he has on deposit at his Bahamian bank, approximately \$10.6 million. Further, Levine will disgorge additional assets of a value of approximately \$1 million. All of the funds disgorged will be paid into a fund to be maintained by a court appointed receiver and will be distributed under a court approved plan. (SEC v. PUBLIC SERVICE COMPANY OF NEW MEXICO; JERSEY CENTRAL POWER & LIGHT COMPANY; GEORGIA POWER COMPANY

Notices have been issued giving interested persons until June 23 to request a hearing on an application filed by the following under the same release: Public Service Company of New Mexico - and its subsidiary, Sunbelt Mining Co., Inc., requesting an order exempting a new holding company from provisions of the Act applicable to it as such, and declaring that, upon the closing of the transactions described in the application, Sunbelt will not be an "electric utility company" under Section 2(a)(3) of the Act; Jersey Central Power & Light Company - subsidiary of General Public Utilities Corporation, to acquire up to \$15 million of notes issued by customers for financing certain conservation measures through December 31, 1989; and Georgia Power Company - subsidiary of The Southern Company, to use March 31, 1984, rather than the respective dates of issuance of the series of up to \$550 million of first mortgage bonds, as the starting date for accumulation of earned surplus, and to use \$302 million as the annual dividends allowance. EFFECTIVENESS OF PROPOSED RULE CHANGE

The Pacific Stock Exchange, Incorporated filed a proposed rule change which became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
