## ADMINISTRATIVE PROCEEDINGS

---

### PROCEEDINGS INSTITUTED AGAINST RONSON CORPORATION

The Commission announced today the institution of an administrative proceeding against Ronson Corporation of Bridgewater, New Jersey, pursuant to Section 15(c)(4) of the Securities Exchange Act of 1934, to determine whether certain filings by Ronson with the Commission failed to comply with the provisions of Section 13(a) of the Exchange Act, concerning accounting practices engaged in by a former plant of a wholly owned subsidiary, involving prerecognition of sales and the arbitrary adjustment, at certain interim reporting periods, of monthly ending inventory figures by amounts necessary to achieve predetermined profit margin goals. Simultaneous with the institution of the proceeding, Ronson submitted an Offer of Settlement, accepted by the Commission, whereby Ronson, without admitting or denying any of the Facts or Findings set forth in the Order, consented to issuance of the Order. Upon the entry of the Order, the proceeding was terminated. (Rel. 34-19212)

## CIVIL PROCEEDINGS

---

### FINAL JUDGMENT OF PERMANENT INJUNCTION ENTERED AGAINST STANLEY GRAZE

The Commission announced that on September 30 U.S. District Judge Charles E. Stewart, Jr., Southern District of New York, entered a Final Judgment of Permanent Injunction against Stanley Graze, a defendant in SEC v. Robert L. Vesco, et al. Graze, who served as portfolio manager for various mutual funds merged by IOS, Ltd., was permanently enjoined from violating the antifraud provisions of the Securities Act.

Judge Stewart ordered defendants Graze, Robert L. Vesco, Norman P. LeBlanc, Milton F. Meissner, Ulrich J. Strickler, Richard E. Clay and Gilbert R.J. Straub to make an accounting of all monies misappropriated from the IOS Complex of mutual funds and other related entities and to make disgorgement and restitution of \$392,570,000 plus interest. (SEC v. Robert L. Vesco, U.S.D.C. S.D.N.Y., Civil Action No. 72 Civ. 5001 [CES]). (LR-9793)

### TRUSTFUNDS TAX EXEMPT TRUST

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
