ENFORCEMENT PROCEEDINGS

FINDINGS AND SANCTIONS IMPOSED AGAINST CONTINENTAL HERITAGE INVESTMENT MANAGEMENT, INC. BY DEFAULT

The Commission has revoked the registration of Continental Heritage Investment Management, Inc. (Continental Management) as an investment adviser and made findings that it violated, inter alia, the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934. Continental Management was an investment adviser headquartered in Denver which served as the adviser to the National Municipal Asset Trust (NMAT), a Denver mutual fund, from September 1986 through August 1989. In the administrative proceeding instituted against Continental Management, the adviser was alleged to have caused NMAT to make an improper loan and to make false and misleading disclosures about the loan. Continental Management failed to file an answer in the proceeding. (Rel. IC-20246; IA-1412)

INVESTMENT COMPANY ACT RELEASES

PROVIDENTMUTUAL LIFE AND ANNUITY COMPANY OF AMERICA, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Providentmutual Life and Annuity Company of America, Providentmutual Variable Annuity Separate Account A (PLACA Account), Provident Mutual Life Insurance Company of Philadelphia, Provident Mutual Variable Annuity Separate Account A (PMLIC Account) and the PML Securities Company from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the PLACA Account and the PMLIC Account under certain variable annuity contracts. (Rel. IC-20248 - April 26)

AUSA LIFE INSURANCE COMPANY, INC., ET AL.

An order has been issued under Section 6(c) of the Investment Company Act on an application filed by AUSA Life Insurance Company, Inc., Diversified Investors Variable Funds (Separate Account) and Diversified Investors Securities Corp. granting exemptions from Sections 26(a)(2) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the assessment of a mortality and expense risk charge against the assets of the Separate Account. (Rel. IC-20249 - April 26)

THE REGIS FUND, INC., ET AL.

A conditional order has been issued on an application filed by The Regis Fund, Inc., et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 18(f), 18(g) and 18(i) of the Act. The order permits certain investment companies to issue and sell multiple classes of shares representing interests in the same investment portfolio. (Rel. IC-20250 - April 26)

HOLDING COMPANY ACT RELEASES

ENTERGY CORPORATION, ET AL.

An order has been issued denying a petition filed by Houston Industries, Inc. and Houston Lighting & Power Co. for reconsideration of a Commission memorandum opinion and order, dated December 17, 1993 (HCAR No. 25952), which authorized the acquisition by Entergy Corporation, a registered holding company, of Gulf States Utilities Company, a public-utility company and an exempt holding company, and related transactions. SELF-REGULATORY ORGANIZATIONS

UNLISTED TRADING PRIVILEGES GRANTED

Orders have been issued granting the applications of four exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. The exchanges and number of issues are: Chicago Stock Exchange - 8 issues (Rel. 34-33968); Boston Stock Exchange - 4 issues (Rel. 34-33969); Cincinnati Stock Exchange - 21 issues (Rel. 34-33970); and Philadelphia Stock Exchange - 14 issues (Rel. 34-33971).

APPROVAL OF PROPOSED RULE CHANGE AND ACCELERATED APPROVAL OF AMENDMENT TO PROPOSED RULE CHANGE

The Commission granted approval to a proposed rule change (SR-CBOE-93-57) filed by the Chicago Board Options Exchange and granted accelerated approval to Amendment No. 1 of the proposed rule change relating to the listing and trading of options and long-term options of the CBOE Global Telecommunications Index and long-term options on a reduced-value Global Telecommunications Index. Publication of the notice and order is expected in the Federal Register during the week of May 2. (Rel. 34-33962)

ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column - 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the percent owned; and Column 7 - the status of the filing, i.e., new, update or revision.
