ENFORCEMENT PROCEEDINGS

SEC SETTLES FRAUD CASE AGAINST FORMER FERROFLUIDICS' CONSULTANT

On January 13, the Commission entered a settled administrative and cease-and-desist order (Order) against David J. Chester in a pending proceeding, In the Matter of Paul Y. Okuda, Stephen A. Thorpe and David J. Chester, File No. 3-9345 (instituted July 1, 1997) for violations of the antifraud and broker-dealer registration provisions. Pursuant to the Order, Chester was suspended from association with any broker-dealer for six months and ordered to disgorge \$50,000.

The Order finds that in early 1992, Ronald Moskowitz, the former chairman and chief executive officer of Ferrofluidics Corporation, and Jan. R. Kirk, Ferrofluidics' former chief financial officer, parked a total of 620,000 Ferrofluidics shares with Chester Financial, Inc. -- a public relations firm owned by Chester -- and three other individuals (the Purchasers) until the shares could be registered and sold to bona fide investors. Moskowitz told Chester, in substance, that Ferrofluidics would lend Chester Financial, Inc. the money to purchase 200,000 Ferrofluidics shares and that Chester Financial, Inc. would receive any profits from the stock if the stock price moved higher. Chester understood that Chester Financial, Inc. would have no risk of loss if the price dropped. The Purchasers, including Chester, each signed a subscription agreement, a promissory note, and a pledge agreement. However, none of the Purchasers, including Chester, paid for the subscribed Ferrofluidics stock, nor did they have the financial ability to pay for the shares.

The Order finds that Ferrofluidics publicly announced, in a press release dated April 23, 1992, that it had "\$12,000,000 of added capital" as a result of the private placement. In fact, the transaction added only \$1.6 million in equity, from a single legitimate purchaser. The Purchasers, including Chester, never made any payments on their notes, nor did the company expect them to. Ferrofluidics nevertheless booked interest on the notes as a receivable and thereby increased Ferrofluidics' net income by approximately \$580,000, or 17%, during fiscal 1992 and \$212,000, or 22%, during the first quarter of fiscal 1993. In addition, Ferrofluidics' auditors were provided with a false confirmation during the 1992 audit, reflecting that Chester Financial, Inc. owed

Ferrofluidics the amount payable under its note.

The Order also finds that Chester should have been registered with the Commission as a broker or dealer from September to December 1992, when he assisted in selling 365,000 shares of Ferrofluidics stock for commissions of \$0.375 to \$0.75 per share. In consenting to the Order, Chester neither admitted nor denied the Commission's findings.

The Commission previously instituted three other related administrative proceedings: In the Matter of Helen Chalut and Saleem Noorani, File No. 3-9344 (July 1, 1997); In the Matter of Sheldon S. Traube and George F. Sweeney, File No. 3-9283 (March 27, 1997); In the Matter of Dickinson & Co. and T. Marshall Swartwood, File No. 3-9321 (May 28, 1997); and one related civil action, SEC v. Ferrofluidics Corp., Ronald Moskowitz, Jan R. Kirk, Stephen P. Morin, Jerome Allen, Bruce S. Moody, and the 1991 RPM Irrevocable Trust, 97 Civ. 7174, S.D.N.Y. In related criminal proceedings, Moskowitz was sentenced to eight years in prison (U.S. v. Ronald Moskowitz, 97 Cr. 1122, MBM), and Kirk was sentenced to five years in prison (U.S. v. Jan R. Kirk, 97 Cr. 1032, MBM). (Rels. 33-7792; 34-42339; File No. 3-9345)

INVESTMENT COMPANY ACT RELEASES

HARTFORD LIFE AND ANNUITY INSURANCE COMPANY, ET AL.

An order has been issued on an application filed by Hartford Life and Annuity Insurance Company, Hartford Life and Annuity Insurance Company Separate Account One (Hartford Life and Annuity Account), Hartford Life Insurance Company, Hartford Life Insurance Company Separate Account Two (Hartford Life Account), PFL Life Insurance Company and PFL Retirement Builder Variable Annuity Account (PFL Account, and together with Hartford Life and Annuity Account and Hartford Life Account, the Accounts), Mentor Variable Investment Portfolios (Mentor Trust) and Evergreen Variable Annuity Trust (Evergreen Trust). The order approves the proposed substitution of shares of the Evergreen Trust's Evergreen VA Capital Growth Fund for shares of Mentor Trust's Mentor VIP Capital Growth Portfolio, shares of Evergreen Trust's Evergreen VA Growth Fund for shares of Mentor Trust's Mentor VIP Growth Portfolio, shares of Evergreen Trust's Evergreen VA High Income Fund for shares of Mentor Trust's Mentor VIP High Income Portfolio and shares of Evergreen Trust's Evergreen VA Perpetual International Fund for shares of Mentor Trust's Mentor VIP Perpetual International Portfolio currently held by the Accounts to support certain deferred premium variable annuity contracts. The order also grants exemptions from Section 17(a) to permit certain in-kind redemption and purchase transactions in connection with the substitutions. (Rel. IC-24250 - January 12)

THIRD AVENUE VARIABLE SERIES TRUST AND ESQF ADVISERS, INC.

A notice has been issued giving interested persons until February 7, 2000, to request a hearing on an application filed by Third Avenue Variable Series Trust (Trust) and ESQF Advisers, Inc. (the Adviser) (together, Applicants). Applicants seek an order to permit shares of any current or future series of the Trust designed to fund insurance products and shares of any other investment company or series thereof now or in the future registered under the Investment Company Act that is designed to fund insurance products and for which the Adviser or any of its affiliates may serve in the future, as investment adviser, administrator, manager, principal underwriter, or sponsor to be sold to and held by: (1) variable annuity and variable life insurance separated accounts of both affiliated and unaffiliated life insurance companies; and (2) qualified pension and retirement plans outside of the separate account context.
