DECISIONS IN ADMINISTRATIVE PROCEEDINGS

SEC CITES CHRISTIAN-PAINE AND CO., INC. AND
JOSEPH J. REGA, JR.; FIRM REVOKED AND REGA BARRED

LIBRARY

The Commission instituted public administrative proceedings under the Securities Exchange and Securities Investor Protection Acts against Christian-Paine & Co., Inc., a Hasbrouck Heights, New Jersey broker-dealer, and Joseph J. Rega, Jr., its president. At the same time, on the basis of respondents' consents, the Commission revoked the firm's broker-dealer registration and barred Rega from association with any broker-dealer, investment adviser or investment company.

The sanctions were based on findings that, from about January to April 1974, the firm and Rega violated antifraud provisions by conducting business at a time when the firm was insolvent. It was also found that the firm and Rega improperly hypothecated customers' securities, made false entries in the firm's books and records, and failed to comply with net capital, credit extension, recordkeeping, reporting and confirmation requirements, as well as provisions designed to protect customers' funds and securities. In addition, it was found that the firm and Rega had been permanently enjoined from further such violations, that Rega had been permanently enjoined in another Commission action from violations of registration and antifraud provisions, and that a trustee had been appointed for the firm under the Securities Investor Protection Act.

The firm and Rega, without admitting or denying the charges against them, consented to the above findings and the indicated sanctions. (Rel. 34-11183)

TRADING SUSPENSIONS

SECURITY NATIONAL BANK TRADING SUSPENDED

Over-the-counter trading has been suspended in the securities of Security National Bank of Huntington, New York (Security National), located in Huntington, New York, for a ten-day period beginning on January 22 and terminating at midnight (EST) on January 31, 1975.

The Commission initiated the suspension on January 20 at the request of the Comptroller of the Currency and in order to allow the full public dissemination of Security National's statement prior to resumption of trading. (See Release 34-11191).

The Commission has been advised by Security National that it will mail information to Security National shareholders which will fully explain the current situation with regard to Security National being acquired by Chemical Bank of New York and with regard to liquidating dividends which may be paid to shareholders. The receipt of this information will insure that Security National shareholders are fully apprised of the situation and of their rights as Security National shareholders before making an investment decision with regard to their Security National stock. TRADING SUSPENDED IN NMC CORP.

The SEC announced the temporary suspension of trading in all securities of NMC Corp., a Delaware corporation located in New York, New York, for one ten-day period beginning on January 21 and terminating at midnight (EST) on January 30, 1975. The suspension was initiated because of the unavailability of adequate and accurate information concerning the company, its operations and financial condition. NMC is currently delinquent in its filings with the Commission required under Section 13(a) of the Exchange Act, and rules thereunder, in that the company has failed to file its annual report on Form 10-K for the year ended July 31, 1974, and its quarterly report on Form 10-Q for the quarter ended October 31, 1974. ADDITIONAL ACTION ON FOUR TRADING SUSPENSIONS

The SEC has announced the suspension of exchange and over-the-counter trading in the securities of American Agronomics Corp., and over-the-counter trading in the securities of Winner Industries, Inc., Royal Properties, Inc., and Burmah Oil Co. Ltd. for the further ten-day period January 23 - February 1, inclusive. The Commission has been informed that the securities of Burmah Oil have been suspended on the London Stock Exchange.

COURT ENFORCEMENT ACTIONS

UNIVERSAL UNDERWRITING SERVICE, INC., OTHERS, ENJOINED

The Denver Regional Office announced that on January 3 and January 9 orders of preliminary injunction were issued against Universal Underwriting Service, Inc., a broker-dealer of Salt Lake City, Utah, and its officers, Grant E. Mann, president, of Bountiful, Utah, and Gordon O. Bigler, vice-president, of Mantua, Utah. The injunctions restrain violations of the net capital rule by Universal Underwriting Service, Inc., or by other brokerage companies operated by defendants Grant E. Mann and Gordon O. Bigler. The defendants consented to the entry of the orders of preliminary injunction without admitting or denying violations as alleged by the Commission in its complaint. (SEC v. Universal Underwriting Service, Inc., et al., D. Utah, Civil Action No. C-74-368). (LR-6689)

MARTIN D. NASS PLEADS GUILTY

The Atlanta Regional Office announced that on January 14 Martin D. Nass of Daytona Beach, Florida, pleaded guilty to one count of violating the antifraud provisions of the securities laws, as well as interstate transportation of fraudulently obtained bank draft. Sentencing has been set for February 18, 1975. (U.S. v. Martin D. Nass, M.D. Fla., Crim. No. 74-218-Orl-Cr-4). (LR-6690)

HOLDING COMPANY ACT RELEASES

AMERICAN NATURAL GAS COMPANY

A notice has been issued giving interested persons until February 18 to request a hearing on a proposal of American Natural Gas Company, a registered holding company, to issue and sell between 1,700,000 and 2,000,000 shares of common stock to underwriters on a negotiated basis for public offering. (Rel. 35-18777 - Jan. 20)

ARKANSAS POWER & LIGHT COMPANY

A notice has been issued giving interested persons until February 14 to request a hearing on a proposal of Arkansas Power & Light Company, subsidiary of Middle South Utilities, Inc., (1) to amend its charter in order to permit issuances of preferred stock with sinking funds and (2) to solicit proxies of the holders of its outstanding preferred stock in connection therewith. MIDDLE SOUTH UTILITIES, INC.

An order has been issued authorizing Middle South Utilities, Inc., a registered holding company, to issue and sell 7,000,000 shares of common stock to underwriters on a negotiated basis for public offering, aggregating approximately \$93 million to the company. (Rel. 35-18779 - Jan. 21)
