### ORDER DENYING REQUEST TO EXPEDITE REVIEW OF FREEDOM OF INFORMATION APPEAL OF OAK INDUSTRIES

The General Counsel denied a request of Oak Industries to expedite review of its request for documents under the Freedom of Information Act (FOIA). The General Counsel determined that the FOIA Officer acted properly in taking additional time to process the request because (1) exceptional circumstances existed, in that the request for documents was voluminous, and (2) the Commission was exercising due diligence by processing the request through its first-in, first-out system. ## TRADING SUSPENSIONS

---

### TRADING SUSPENDED IN THE SECURITIES OF ELANA, INC.

The Commission announced the single ten-day suspension of over-the-counter trading in the securities of Elana, Inc., a Florida corporation, for the ten-day period beginning at 2:00 p.m. (EST) on March 28 and terminating at 2:00 p.m. (EST) on April 7.

The Commission suspended trading in Elana's securities in view of questions that have been raised about the adequacy and accuracy of publicly disseminated information concerning the nature of Elana's assets and business operations. (Rel. 34-25521)

## CIVIL PROCEEDINGS

---

### COMPLAINT NAMES JOHN AND MARYANN LOMBARDI

The Commission filed a Complaint on March 28 in the U.S. District Court for the Southern District of New York against John and Maryann Lombardi, alleging that they violated Sections 10(b) and 14(e) of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3 in connection with their trading in the securities of Waldbaum, Inc.

The Complaint alleges that on November 26, 1986, after the close of trading, the Great Atlantic & Pacific Tea Company (A&P) announced a tender offer for Waldbaum at \$50 per share. On November 26, 1986, M. Lombardi, in connection with her employment duties at A&P, learned that A&P was preparing to acquire Waldbaum. M. Lombardi, in breach of a duty of confidentiality that she owed to A&P, disclosed this information to her spouse, J. Lombardi. J. Lombardi, while in possession of this material non-public information, purchased 1,300 shares of Waldbaum common stock.

Simultaneously, the Lombardis, without admitting or denying the Complaint's allegations, consented to permanent injunctions against future violations, agreed to disgorge their profits of \$26,250, and to pay a \$10,000 penalty under the Insider Trading Sanctions Act of 1984. ## COMPLAINT NAMES ANDREW SOLOMON

The New York Regional Office filed a Complaint on March 28 in the U.S. District Court for the Southern District of New York for a permanent injunction against Andrew Solomon, a former research analyst with the broker-dealer firm of Marcus Schloss & Co., Inc.

The Complaint charged Solomon with insider trading violations based upon his receipt and conveyance of material, nonpublic information about proposed or considered takeover transactions from sources, including Michael N. David, a law firm associate. In each case, the Complaint alleged, Solomon provided the information to Marcus Schloss or others who then traded in the securities of the takeover receipt, or caused other persons to trade in those securities. The targets included Union Carbide Corp., Avondale Mills, American Brands, Inc., and Revco, D.S. Inc.

Simultaneously, Solomon consented to a Final Judgment of Permanent, admitting the allegations of the Complaint. (SEC v. Andrew Solomon, USDC SDNY, 88 Civ. 2125). (LR-11685)

The Commission approved a proposed rule change filed by: The Chicago Board Options Exchange (SR-CBOE-87-56) to delete the requirement that member partnerships have at least two general partners. (Rel. 34-25500); (SR-CBOE-88-1) to amend its constitution to require an affirmative membership vote for the issuance of permits or other rights granting holders access to its trading floor for the purpose of effecting securities transactions. (Rel. 34-25501); and the Philadelphia Stock Exchange (SR-Phlx-87-33) to allow the execution of certain spread, straddle, and combination ratio orders involving American-Style and European-Style Foreign Currency Options. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
