### COMMISSIONER GRUNDFEST TO SPEAK IN LONDON

On November 9, Commissioner Grundfest will give a public lecture at King's College in London, England. The title of his lecture will be "International Cooperation in Securities Enforcement: A New United States Initiative."

In addition, on November 10, he will be speaking at the International Herald Tribune and Skadden, Arps, Slate, Meagher & Flom's international conference on mergers and acquisitions in the 1990's. The title of this address will be "Foreign Mergers and Acquisitions Regulation: A View from the United States." This conference will be held at the Park Lane Hotel, Piccadilly, London.

## ADMINISTRATIVE PROCEEDINGS

---

### RULE 2(e) PROCEEDINGS INSTITUTED AND SETTLED AGAINST JOHN L. VAN HORN

The Commission issued an Order Instituting Proceedings and Opinion and Order under Rule 2(e) of its Rules of Practice against John L. Van Horn, a certified public accountant. The Order, to which Van Horn consented, denies Van Horn the privilege of practicing before the Commission provided that after five years he may apply to resume practice upon a showing that he has met certain educational and professional association requirements. The Order finds that, in connection with Van Horn's audits of CoElco, Ltd., Van Horn failed to comply with generally accepted auditing standards in several respects and engaged in improper professional conduct, and he wilfully violated Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 and wilfully aided and abetted violations of Section 12(g) of the Exchange Act and Rule 12b-20. ### NATIONWIDE LIFE INSURANCE COMPANY

An order has been issued exempting Nationwide Life Insurance Company, Nationwide Variable Account-II, and Nationwide Financial Services, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act to permit the deduction of a mortality and expense risk charge from the assets of Variable Account II. ### MASSACHUSETTS ELECTRIC COMPANY; APPALACHIAN POWER COMPANY; LOUISIANA POWER & LIGHT COMPANY; MISSISSIPPI POWER & LIGHT COMPANY

Notices have been issued giving interested persons until November 28 to request a hearing on a proposal by the following companies filed under Release 35-24740, dated November 3: MASSACHUSETTS ELECTRIC COMPANY - subsidiary of New England Electric System, to amend its indenture to adjust the dividend restriction on common stock and other distributions; APPALACHIAN POWER COMPANY - Columbus Southern Power Company, Kentucky Power Company, and Ohio Power Company, subsidiaries of American Electric Power Company, Inc., whereby they will lease to non-associated companies up to 50% of the capacity of their fiber optics communications system; LOUISIANA POWER & LIGHT COMPANY

- to issue and sell not more than \$350 million of first mortgage bonds and no more than \$100 million of preferred stock, and to acquire certain of its outstanding securities; and MISSISSIPPI POWER & LIGHT COMPANY - a registered holding company, to issue and sell one or more series of general and refunding mortgage bonds in an aggregate principal amount not to exceed \$100 million, to issue and sell no more than \$37,500,000 of one or more new series of its preferred stock, and to purchase certain of its outstanding securities.

## SELF-REGULATORY ORGANIZATIONS

### EXTENSION OF COMMENT PERIOD

The Commission extended until November 4, 1988 the comment period on a proposed rule change filed by the National Association of Securities Dealers. The proposed rule change (SR-NASD-88-19) would establish a new quotation service, the OTC Bulletin Board Display Service, for OTC securities that are not included in the NASDAQ System nor listed on a national securities exchange. ### NOTICE OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-88-18) that would add international capability to its Institutional Delivery (ID) System. The international ID System would permit more timely and efficient settlement of institutional trades executed in non-U.S. or non-Canadian securities. Publication of the proposal is expected to be made in the Federal Register during the week of November 7. (Rel. 34-26249)

### APPROVAL OF PROPOSED RULE CHANGE
