COMMISSION ANNOUNCEMENTS

COMMISSION AND NASAA ANNOUNCE 1993 CONFERENCE ON FEDERAL-STATE SECURITIES REGULATION AND REQUEST COMMENTS ON THE TENTATIVE AGENDA

The Commission and the North American Securities Administrators Association, Inc. (NASAA) announced that the annual conference on Federal-State Securities Regulation will be held on April 26, 1993. Because participation at the conference is generally limited to Commission and NASAA personnel, the release indicates that interested persons should participate by providing written comments by April 20, 1993.

ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AND SANCTIONS IMPOSED AGAINST HERMAN GARCIA, JR.

The Commission instituted administrative proceedings and imposed sanctions against Herman R. Garcia, Jr. (Garcia), a trader and compliance officer at South Richmond Securities, Inc. (SRS), a registered broker-dealer. Garcia consented to the findings and sanctions without admitting or denying the findings.

The Order alleges that Garcia charged excessive and undisclosed mark-ups on sales of two securities by SRS, and that Garcia failed to disclose SRS' domination and control of the market for these securities. The Order further alleges that Garcia was responsible for these antifraud violations.

The Order bars Garcia from association with any broker, dealer, investment company, investment advisor or municipal securities dealer; provided, that he may apply to become associated in a non-supervisory, non-proprietary capacity after four years, and orders Garcia to cease and desist from future violations of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Exchange Act and Rule 10b-5 thereunder. CIVIL PROCEEDINGS

JOSEPH ZILBER CONSENTS TO BE ENJOINED IN INSIDER TRADING CASE

The Commission filed a civil complaint on April 1 in the United States Court for the District of Columbia charging Joseph J. Zilber (Zilber) with violating Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder.

The complaint alleged that Zilber purchased 26,000 shares of Federated Bank, S.S.B. (Federated) common stock while in possession of material, nonpublic information concerning Firstar Corp.'s (Firstar's) negotiations to acquire Federated.

Without admitting or denying the allegations, Zilber consented to be enjoined from violating Section 10(b) of the Exchange Act and Rule 10b-5 thereunder, and to be ordered to disgorge \$184,500 and to pay a \$92,250 civil penalty. [SEC v. Joseph J. Zilber, 93 Civ. 668, LFO, USDC DDC] (LR-13586)

INVESTMENT COMPANY ACT RELEASES

PRIME VALUE FUNDS, INC., ET AL.

A conditional order has been issued on an application filed by Prime Value Funds, Inc., et al. under Section 6(c) of the Investment Company Act exempting applicants from Sections 2(a)(32), 2(a)(35), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to impose and, under certain circumstances, waive a contingent deferred sales load on certain redemptions of shares. (Rel. IC-19371 - March 31)

HARVEST FUNDS, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that Harvest Funds, Inc. has ceased to be an investment company. (Rel. IC-19372 - March 31)

GREAT AMERICAN RESERVE INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Sections 6(c) and 17(b) of the Investment Company Act exempting Great American Reserve Insurance Company, Great American Reserve Variable Annuity Fund (Annuity Fund), Great American Reserve Variable Annuity Account

C (Account C), Great American Reserve Variable Annuity Account D (Account D), GARCO Equity Sales, Inc. and Conseco Series Trust (Trust) from the provisions of Sections 17(a), 26(a)(2)(C) and 27(c)(2) of the Act. The order permits the combination of the assets of Annuity Fund and Account D with and into Account C (Continuing Account), and the simultaneous restructuring of the Continuing Account from a management investment company into a unit investment trust investing in shares of portfolios of the Trust. The order also permits the simultaneous issuance of shares of the portfolios of the Trust to newly created sub-accounts of the Continuing Account in exchange for all of the assets and related liabilities of Account C and the deduction of a mortality and expense risk charge from the assets of the Continuing Account. HOLDING COMPANY ACT RELEASES

PUBLIC SERVICE COMPANY OF OKLAHOMA

An order has been issued authorizing Public Service Company of Oklahoma (PSC-OK), an electric public-utility subsidiary company of Central and South West Corporation, a registered holding company, to acquire retail distribution assets located in Rogers and Nowata Counties, Oklahoma from the Chelsea Municipal Authority for \$350,000 plus an additional amount not to exceed \$200,000 based on kilowatt-hour usage during the twelve months immediately following the purchase of the utility assets. ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the New York Stock Exchange (SR-NYSE-93-16) to extend the use of the NYSE's auxiliary closing procedures to days on which settlement of Quarterly Index Expirations (QIXs) is based. (Rel. 34-32066)

PROPOSED RULE CHANGE

The <u>Philadelphia Stock Exchange</u> filed a proposed rule change (SR-Phlx-93-05) to amend Rule 1014(h) and the corollary Options Floor Procedure Advice B-7 to permit foreign currency options specialists who are on parity with other market specialists to participate in 50% of contraside contract volume during the hours of 6:00 p.m. and 3:00 a.m. EST. Publication of the proposal is expected in the <u>Federal Register</u> during the week of April 5. (Rel. 34-32069)
