ADMINISTRATIVE PROCEEDINGS

NASD'S REFUSAL TO PERMIT ASSOCIATION OF ROBERT GRAHAM, SR. AS A PRINCIPAL SET ASIDE

The Commission has divided evenly on the issues raised by the appeal from NASD action of Robert B. Graham, Sr., president and sole owner of Basil Investment Corp. of Holland, Pa., an NASD member firm. Based on Graham's conviction arising from his activities as a tax protester, the NASD denied his request to remain associated with Basil as a principal, revoked his principal registrations and ordered him to divest his ownership interest in the firm or place his stock in a voting trust with an independent trustee acceptable to the NASD.

The Commission noted that since it was evenly divided the findings required by Section 19(f) of the Securities Exchange Act for affirmance of the NASD's action could not be made. Thus, Section 19(f) required that the NASD's action be set aside and that the NASD be ordered to permit Graham's continued association with Basil as a principal and his retention of his ownership interest in that firm. CIVIL PROCEEDINGS

CIVIL ACTION AGAINST INTERLINK DATA NETWORK OF LOS ANGELES, INC., INTERLINK FIBER OPTIC PARTNERS L.P., INTERLINK VIDEO PHONE PARTNERS L.P. AND MICHAEL GARTNER

On May 27, the Commission filed a complaint in the U.S. District Court for the Central District of California against InterLink Data Network of Los Angeles, Inc., InterLink Fiber Optic Partners L.P., InterLink Video Phone Partners L.P. and Michael Gartner. The complaint seeks a temporary restraining order and an order to preliminarily and permanently enjoin the defendants from violations of the registration provisions of the Securities Act, the antifraud provisions of the Securities Act and the Exchange Act and the broker-dealer provisions of the Exchange Act. The complaint also seeks emergency relief, including an asset freeze and an accounting by the defendants.

The complaint alleges that from 1988 to the present the defendants raised approximately \$10 million through the offer and sale of common stock and limited partnership interests. The complaint further alleges that in connection with these offerings, the defendants misrepresented that they owned certain patents, that a fiber

optic cable was being built, that the defendants' stock would become publicly traded, and the security of the investment. The complaint also alleges that the defendants failed to disclose that investors' returns were paid for from funds raised from subsequent investors. [SEC v.
