COMMISSION MEETING CANCELLED

The Commission's open meeting scheduled for July 23, 1993 at 10:00 a.m. has been cancelled. The meeting will be rescheduled. (Press Rel. 93-24)

ADMINISTRATIVE PROCEEDINGS

ISSUANCE OF FINDINGS AND ORDER IMPOSING REMEDIAL SANCTIONS

The Commission announced the issuance of Findings and Order Imposing Remedial Sanctions By Default Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Order) on July 16 against Howard Neil Hochman (Hochman), a registered representative.

Hochman was enjoined, on consent, by the U.S. District Court for the Southern District of New York from further violations of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder (SEC v. Caltabiano, 92 Civ. 4906, RWS). As a result of Hochman's default, the Commission found that the allegations in the complaint in the above action were true. (Rel. 34-32648)

CIVIL PROCEEDINGS

COMPLAINT FILED AGAINST BLACK WARRIOR WIRELINE CORP.

The Commission filed a civil complaint for injunctive relief in U.S. District Court for the Southern District of New York against Black Warrior Wireline Corp. (Black Warrior), formerly known as Teletek, Ltd. (Teletek). Teletek was a "blank check/blind pool" company.

The complaint alleges that in connection with a merger between Black Warrior and Teletek, Black Warrior received Teletek IPO proceeds and used them to purchase the Teletek insiders' stock, and engaged in a scheme to conceal this use of the IPO proceeds. In furtherance of this scheme, Black Warrior violated the antifraud, the issuer books and records, and the issuer reporting provisions of the federal securities laws. [SEC v. Black Warrior Wireline Corp., Fred J. Miller, Adolph Weissman, 93 Civ. 4991, MGC, USDC, SDNY] (LR-13718)

PRELIMINARY INJUNCTION ENTERED AGAINST N. EDWARD ROSS, SOUTH BRANDON COMMUNITY CHURCH OF GOD, INC. AND NORTHDALÉ COMMUNITY CHURCH OF GOD, INC.

The Commission announced that the Honorable Anne C. Conway, U.S. District Judge for the Middle District of Florida, entered an order of Preliminary Injunction and Other Relief against defendants N. Edward Ross (Ross) of Valrico, Florida, South Brandon Community Church of God, Inc. (South Brandon) in Brandon Florida and Northdale Community Church of God, Inc. (Northdale) in Tampa, Florida in connection with the sale of allegedly fraudulent church bonds. The order was entered against Ross, South Brandon and Northdale on July 12, 1993. The defendants consented to the entry of the injunction without admitting or denying the Commission's allegations.

The Commission's complaint alleges that from at least April 1, 1991 Ross solicited and obtained in excess of \$2 million from investors for investment in church bonds. The Commission alleges that in connection with the sale of these bonds, the defendants made material misrepresentations to investors concerning, among other things, the use of the proceeds and the risks associated with the investment.

The Court's order preliminarily enjoins the defendants from further violations of the antifraud provisions of the federal securities laws and freezes specific assets of each of the defendants. [SEC v. N. Edward Ross, et al., USDC, MD FL, Civil Action No. 93-1073-CIV-T-99A] (LR-13725)

INVESTMENT COMPANY ACT RELEASES

BANDO MCGLOCKLIN CAPITAL CORPORATION ET AL.

A notice has been issued giving interested persons until August 16, 1993 to request a hearing on an application filed by Bando McGlocklin Capital Corporation (Bando McGlocklin) et al. for an amendment to an order under Sections 6(c) and 17(b) of the Investment Company Act. The amended order would permit Bando McGlocklin to issue one class of senior security which is a stock and would correct a citation in the original order. The original order granted exemptions from Sections 8(b), 12(d), 17(a), 18(a), 18(c), 30(a), 30(b), and 30(d), and Rules 8b-16, 30a-1, 30b1-1, and 30d-1 thereunder to permit Bando McGlocklin to establish and operate a wholly-owned subsidiary under the terms of a reorganization in which Bando McGlocklin transferred certain assets, including its small business investment company license, to the subsidiary in exchange for all of the common stock of the subsidiary and the assumption by the subsidiary of certain liabilities of Bando McGlocklin. THE GUARDIAN INSURANCE & ANNUITY COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting The Guardian Insurance & Annuity Company, Inc., The Guardian Separate Account J (Separate Account) and Guardian Investor Services Corporation from Sections 2(a)(35), 26(a)(2)(C) and 27(c)(2) of the Act. The exemptions apply to the extent necessary to permit the deduction of a premium-based deferred sales charge in six equal annual installments from the accumulation value of certain single premium deferred variable annuity contracts and the deduction of mortality and expense risk charges from the assets of the Separate Account. (Rel. IC-19589 - July 21)

SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the American Stock Exchange (SR-Amex-93-22) to extend until March 21, 1994 its pilot program permitting specialists to stop stock in a minimum fractional change market. (Rel. 34-32664)
