CIVIL PROCEEDINGS

COMPLAINT FILED AGAINST MERRITT BRADT AND LINDA RYAN

The Commission announced that on October 5 a complaint was filed against Merritt Bradt (Bradt) of Port St. Lucie, Florida and Linda Ryan (Ryan) of Boca Raton, Florida seeking injunctive relief, disgorgement and civil penalties. Simultaneous with the filing of the complaint, Bradt submitted a consent, without admitting or denying the allegations of the complaint, to the entry of a Final Judgment of Permanent Injunction and Other Relief against him.

The complaint seeks to enjoin Bradt and Ryan from violating the registration and antifraud provisions of the federal securities laws, and from aiding and abetting violations of the broker-dealer antifraud provisions of the federal securities laws. The complaint also seeks to enjoin Bradt from aiding and abetting violations of the broker-dealer registration provisions of the federal securities laws.

The complaint alleges that Bradt and Ryan offered and sold interests in limited partnerships through unregistered, non-exempt transactions and made misrepresentations and omissions to offerees concerning, among other things, the return on investment and the risks associated with an investment. COMPLAINT FILED AGAINST H. DAVID GRACE AND GRACE CAPITAL, INC.

The Commission announced that on October 15 it filed a complaint in the U.S. District Court for the Southern District of New York against H. David Grace (Grace) and Grace Capital, Inc. (Grace Capital).

The complaint alleges that Grace and Grace Capital, a registered investment adviser, engaged in two fraudulent schemes. First, the complaint alleges that from approximately 1984 through approximately November 1989 Grace Capital, aided and abetted by Grace, fraudulently borrowed approximately \$1.7 million from advisory clients without disclosing its insolvency or other material, adverse information. Grace Capital allegedly defaulted on most of the loans. Second, the complaint alleges that from approximately January 1991 through approximately September 1991 Grace misappropriated approximately \$600,000 from an advisory client and made material misrepresentations to that client. The complaint alleges those two fraudulent schemes

violated Section 17(a) of the Securities Act of 1933, Section 10(b) of the Securities Exchange Act of 1934, Rule 10b-5 thereunder, and Sections 206(1) and (2) of the Investment Advisers Act of 1940. The complaint also alleges that Grace and Grace Capital violated and/or aided and abetted violations of certain disclosure, custody, and books and records provisions.

The complaint seeks a permanent injunction, disgorgement, prejudgment interest, civil penalties and other equitable relief. [SEC v. H. David Grace, et al., 93 Civ. 7147, KMW, SDNY] (LR-13835)

INVESTMENT COMPANY ACT RELEASES

SECURITY FIRST LIFE INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until November 9, 1993 to request a hearing on an application filed by Security First Life Insurance Company, Security First Life Separate Account A (Account A), Fidelity Standard Life Insurance Company, and Fidelity Standard Life Separate Account (Fidelity Account, together with Account A, Accounts). The application is for an order pursuant to Section 26(b) of the Investment Company Act approving a proposed substitution of shares of the Money Market Portfolio of the Variable Insurance Products Fund for shares of the Money Market Series of Security First Trust held by the Accounts. SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the New York Stock Exchange (SR-NYSE-93-28) to amend NYSE Rules 35 and 301 to require registration applications for all employees of members and member organizations for admission to the Floor to be submitted to the Exchange on Form U-4 and to require all Floor employees of members and member organizations, members and applicants for membership to be fingerprinted. (Rel. 34-33045)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Stock Clearing Corporation of Philadelphia filed a proposed rule change (SR-SCCP-93-04) relating to reducing the maximum trade value charge. The proposed rule change became effective upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of October 18. (Rel. 34-33046)

PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-93-56) relating to codification of the basic requirements respecting access to and use of the OTC Bulletin Board service. Publication of the proposal is expected in the Federal Register during the week of October 18. (Rel. 34-33052)
